415.1 Purpose

This act is to establish a program administered by the Student Senate Pro
Tempore for students who are neither currently nor former members of the FSU
Student Senate who are interested in gaining knowledge of how the Senate
operates through first-hand experiences.

415.2 Name

The name of this program shall be "The Student Senate Certification Program"

415.2 Administration of Program

The Senate Pro Tempore shall create an application and make it available to students on the SGA website for the first two (2) weeks of each semester the program is offered. The Senate Pro Tempore shall have discretion over which applicants are to be admitted to the program. The Senate Pro Tempore shall be responsible for holding an orientation session for admitted applicants to explain the program and answer questions they may have.

Senate Amendment 3

Purpose & Description (Use extra sheet of paper if more space is needed)

The purpose of this bill is to amend the Student Body Constitution Article two (2) Section five (5), subsection A, Subsection two (2) to revise the powers of the Student Senate in disciplining its members.

Statement of Intent

The Purpose of this amendment is to strengthen the Student Senate's ability to deal with the conduct of its members, and to provide a means to discipline a Student Senator without having to necessarily resort to impeachment through Censure.

ARTICLE II THE LEGISLATURE

Section 5 POWERS AND DUTIES

History: Revised by Constitutional Amendment 8, the 56th Student Senate.

A. Senate shall:

- Enact its own Rules of Procedure, which shall require a twothirds (2/3) vote.
- 2. <u>Discipline its members for disorderly behavior through</u> Censure.
- Propose, by a two-thirds (2/3) vote, Constitutional amendments.
- 4. Provide for the compilation and publication of legislation.
- 5. Confirm appointments of the Student Body President by a two-thirds (2/3) vote for appointments to fill vacated offices, and by a majority vote for other appointments. Confirmation

WHEREAS: On January 23, 2019, there was a shooting in Sebring, Florida, in which a man

murdered five people in a bank, and

WHEREAS: On November 2, 2018, there was a shooting at a Hot Yoga studio in Tallahassee.

in which two people were killed, one of whom was a student at Florida State and

the other was a Florida State faculty member, and

WHEREAS: On February 14, 2018, there was a shooting at Marjory Stoneman Douglas High

School in Parkland, Florida, in which seventeen people were murdered, and

WHEREAS:

On November 4, 2014, three Florida State students were shot at Strozier Library,

and

WHEREAS: There has been a rise in both homicides and suicides through gun-related violence

in the United States and Florida, and

WHEREAS: Survivors of mass shootings and gun-related violence will most likely experience

medical issues, PTSD, anxiety, months of vivid nightmares, depression, and

WHEREAS: Gun-related violence is indisputably a public safety issue for the Florida State

University Student Body, and it is the responsibility of the Student Senate to

ensure a positive experience for the Student Body, therefore,

BE IT RESOLVED BY THE SEVENTY-FIRST STUDENT SENATE AT THE FLORIDA STATE UNIVERSITY THAT:

The Student Senate formally recommends that the University designate gun-related violence a top research priority to help end gun-related violence as it exists today.
