Amount requested: \$536.37, amended to \$1,800 for stoles and \$70 for COGs logo stickers Purpose of funds: To award graduating students with stoles to be worn at graduation

Details of event: BLSA will advertise the giveaway of these stoles through the student announcements to award and celebrate students successfully completing law school. The stoles are hand-woven and shipped from Ghana. They are \$18/person

#### Notes:

- Stoles are regularly \$22.95 but received a discount code from National BLSA
- 100 stoles will be purchased
- We originally approved this request on February 16<sup>th</sup> but the COGs speaker had issues with it. In order to get the rest of the requests approved from that meeting we put this request on the back burner. We are still in approval of this request and we disagree with the COGs speaker's assessment of why he denied it in the February 16<sup>th</sup> minutes.
- We are classifying these stoles as awards and more specifically as trophies.
- According to the SGA Financial Manual section 803.8:
  - The Clothing & Awards Category shall be used to pay for clothing (t-shirts and polo shirts) for the purpose of promoting an SGA-funded entity or event, and awards (trophies, plaques, and certificates) for the purpose of recognizing an individual or group.
    - (A)Clothing shall be restricted to T-shirts, tank tops and polo shirts, unless otherwise approved by a three-fourth (3/4) vote of the Senate Finance Committee.
      - 1. T-shirts and polo shirts must be made available free of charge to all FSU members of the entity purchasing them. There shall be no separate Executive Board shirts. Executive Board shirts can be waived in the form of a resolution with approval by a threefourths (3/4) vote of the Senate Finance Committee and a twothirds (2/3) vote of the Senate.
    - (B) Awards shall be restricted to trophies, plaques, and certificates.
      - 1. The manner in which the recipient of any award was (or will be) decided must be submitted to the Student Body Treasurer at the same time as the expenditure. Under no circumstances may this category be used to purchase personal gifts.
- The definition of a trophy is "a cup or other decorative object awarded as a prize for a victory or success."
  - A stole is a decorative object. These stoles are going to be awarded to graduating students who will wear them as a prize for graduating.
- There is no definition of trophy indicated in the SGA financial manual which means that these can be classified as awards being that they are decorative in nature and being

- awarded as a prize to graduating 3Ls. On the vendor website, it describes the stoles as "Native to the to the Ashanti Region in Ghana, Kente Cloth has a long tradition of be worn for the most prestigious occasions."
- The stickers will be purchased from stickermule. They are high quality logo stickers that will be added to each stole to satisfy the requirement that awards and clothing have the COGs logo on them.
