Questions:

- What are the funds for?
 - Dr. Chris Gabbard of the University of North Florida, author of A Life Beyond Reason: A Disabled Boy and His Father's Enlightenment (Beacon Press 2021), will speak about his encounters with various physicians during the short life of his son, August. Following his mother's uneventful pregnancy, August was born in 1999 with severe impairments including cortical visual impairment, profound cognitive impairment, spastic quadriplegia, and osteopenia. His most serious diagnosis was hypoxic ischemic encephalopathy (H.I.E.). Thus began a fourteen-year saga of what Michael Bérubé calls "extreme caregiving." Gabbard will describe the moments of connection and disconnection with physicians during his son's brief life.
