WHEREAS: Article II Section 1 of the Constitution of the Student Body states, "The Legislature Powers of the Student Body shall be vested in the Student Senate," and

WHEREAS: The powers of the Student Government Association are derived from the concepts of Republicanism and Democracy, and

WHEREAS: The Student Senate was formed with the intent of its structure resembling that of the Senate of the United States, and

WHEREAS: The Student Senate was formed with the intent of its structure resembling that of the Senate of the State of Florida, and

WHEREAS: The Student Senate is without an official Seal as a means of representation amongst the other bodies of the Student Government Association, therefore

BE IT RESOLVED BY THE SEVENTY-FIRST STUDENT SENATE AT THE FLORIDA STATE UNIVERSITY THAT:

The Student Senate at Florida State University design a "SEAL OF THE STUDENT SENATE" with characteristics as follows:

- 1. A Golden Ring, Emblazoned with "STUDENT GOVERNMENT ASSOCIATION" and "FLORIDA STATE UNIVERSITY"
- 2. A Garnet Field filling the said Golden Ring, depicting the space in the University the Student Senate serves
- 3. A Shield with elements from the Seal of the United States Senate, depicting the task of defending the interests of the Constituent Public
 - a. Within the top of the said shield, Twenty (20) Five (5) pointed white stars, depicting the divisions of the Student Body that the Senate duly represents
 - b. Within the bottom of the said shield, Thirteen (13) alternating garnet and white vertical stripes, depicting the history of the United States of America

- c. A Scroll overlapping the said Shield, Emblazoned with "STUDENT SENATE" as a signifier of this legislative body
- d. A Phrygian Cap sitting atop the said Shield, Emblazoned with "LIBERTY", depicting the history of Republican forms of government in opposition to monarchy and slavery
- 4. A Subsidiary Seal with elements from the Seal of the Senate of the State of Florida:
 - a. A Quill within the said Subsidiary Seal, depicting the writing of laws
 - b. A Gavel within the said Subsidiary Seal, depicting control or authority in the presiding officer
 - c. A Scroll within the said Subsidiary Seal, depicting the parchment on which laws are permanently written

BE IT FURTHER RESOLVED THAT: The Student Senate officially adopt such a Seal for its future iterations as a means of representation of the Student Senate amongst the other bodies of the Student Government Association, and

BE IT FURTHER RESOLVED THAT: The Student Senate utilizes the Seal proudly on official documents pertaining to the work of the Student Senate, and
