### 73<sup>rd</sup> STUDENT SENATE Senate Resolution

**Resolution #: 40**  
**Primary Sponsor: Myers**

**Whereas:** The Seventy-third Student Senate passed the SGA Indigenous Land Acknowledgement Act of 2020, and

**Whereas:** Rule 8.3 of the Student Senate Rules of Procedure governs what is to be put on the calendar, and

**Whereas:** The current iteration of Rule 8.3 does not reflect the current practices of the Senate Calendar, and

**Whereas:** It is the responsibility of the Student Senate to keep our documents as updated as possible, and

**Whereas:** Including the Indigenous Land Acknowledgement Act in the calendar is reflective of the Senate's promise to recognize the ongoing historical legacy of indigenous people on and beyond our campus, therefore
