73rd STUDENT SENATE Senate Resolution

Resolution #:87.

Primary Sponsor: Linsky, Tackett

Co-Sponsor(s): Wang, Nasworthy, Marcus, Little, Roy, DuChene, Edouard, Myers, Gonzalez

Whereas: Student Body Statute 413.8 states, Membership in the Senate Hall of Fame is the highest honor a student Senator can achieve. This honor shall be bestowed upon any Senator who has performed their duty as a member of the Senate with the highest standard of excellence, beyond that normally expected of a Senator at the Florida State University, and

Whereas: Per Bill 53 of the 73rd Student Senate, Student Body Statute 413.8(A)(1)(c) states, "Only senators who have served two calendar years or two full terms of office or more in the Student Senate may be considered." and Student Body Statute 413.8(A)(1)(c)(iii) states, "This stipulation may be overruled by a 2/3 vote of the senate in situations where the Senate determines a nominee's work is exceptional (emphasis added) in a shorter amount of time," and

Whereas: Senator Jason Randall has served as the Chair of the Finance Committee, Chair of the Resources & Travel Allocation Committee, member of the Rules of Procedure Ad Hoc Committee, member of the Sweepings Committee and member of the Central Reserves Committee in the 73rd Student Senate, and

Whereas: Senator Randall was the primary sponsor and creator of Senate Bill 13 that reinstated the Jewish Student Union as an Agency within the Student Government Association, and

Whereas: In his short stint during the Seventy-Second Student Senate, Senator Randall brought awareness and resources to the Victim Advocacy Program in Resolution 96 and Bill 113, respectively, and provided funds for the operation of WVFS an important part of the campus community, in Bill 111, and

Whereas: In the 73rd Student Senate, Senator Randall sponsored over 13 pieces of legislation, five resolutions, and one Constitutional Amendment that included funding for CHAW, many statute reforms, re-establishment of the War Department, A&S fee reform for the Congress of Graduate Students,

Whereas: As a member of the Rules of Procedure Ad Hoc Committee, Senator Randall served as the committee's headmaster of formatting and a essential part of the rulemaking process, without whom the committee would have been lost, and

Whereas: Senator Tackett testifies that "While Senator Randall is an outstanding Senator, he is an even better man. We initially bonded over our shared advocacy for the food pantry and CHAW. From there, we had many heated debates in and outside the senate chambers. No matter how passionate the argument or how stubbornly wrong Jason was, we were always able to come to some sort of compromise. Senator Randall voted among no political line, but rather with a strong code of ethics. I am honored to call him a friend", and

Whereas: Senator Linsky testifies that "Senator Randall has made outstanding contributions to every facet of the Seventy-Third Session. He is second to none when it

comes to thoroughly reading, writing, and formatting legislation. I have seen his contributions first-hand in ROPAH - of which Senator Randall was a member - as well as every other committee I have served on where Senator Randall was not a member. Senator Randall's expertise on matters pertaining to our Finance Code have helped every member of the Senate better understand how to do our most important job: allocating and expending the A&S Fee Fund on behalf of our student body."

Whereas: Parliamentarian Rowan testifies that "Jason Randall is a pain in the neck. That being said, he's a pain in the neck I will miss dearly. Over the course of the Seventy-Third Senate, from fights in the Zoom halls of ROPAH to late night phone calls that leave both of us busily flipping through Robert's Rules, I have been grateful to get to know Senator Randall, not just because he is a great senator, but because he is an amazing person. The Senate will not be the same without this amazing Senator and friend. Good luck in the real world, Randall!", and

Whereas: Pro-Tempore Wang testifies that "Senator Randall has been an invaluable addition to the Senate since he was confirmed and especially to my Rules Committee. I cannot imagine a single Senate or committee meeting without his unrelenting questions, and I am sad to see him leave this organization. Besides his contributions to Senate and the student body, Jason is one of the most amazing humans who will always stop to ask me how I am with genuine care," therefore,
