A revision to the Student Body Statutes

BE IT ENACTED BY THE SEVENTY FOURTH STUDENT SENATE THAT:

A revision is made to the Student Body Statutes SBS § 413.3 (See attached).

To amend the statute Mandating that nominations for the FSU Student Senate Award for Excellence be proposed in the form of a resolution and clarifying that they be referred to the Student Life committee by the Senate President. This bill also outlines procedural guidelines for the nominating resolution that mirrors those of Student Senate Hall of Fame Award procedures.

413.3 The FSU Student Senate Award for Excellence

- A. Each Senator may nominate one FSU student, faculty/staff member, or campus entity for an FSU Student Senate Award for Excellence per year though a maximum of five (5) such awards shall be given each year. The FSU Student Senate Award for Excellence is to be granted for distinguished service to the Florida State University or to the community, or for outstanding performance in representing this university.
- B. A Senator wishing to nominate an individual or entity for the Student Senate Award for Excellence must do so by submitting a resolution for referral to the Student Life Committee containing the nominee's name and a description of why they are deserving of the award. Upon approval by the Student Senate, the award shall be presented to the recipient in any fashion deemed fit. The FSU Student Senate Award for Excellence shall be a certificate or other memento designed and provided by the Student Senate President.
1. When nominating resolutions are debated on the Senate Floor, two rounds of pro may be given, but no rounds of con will be permitted. If the resolution is approved by the Senate by two-thirds (2/3) vote, the nominated individual or entity will be considered a recipient of the Student Senate Award for Excellence.
 2. The provisions in 413.3 (b) shall not preclude the Student Senate President from immediately placing a nominating resolution on the calendar for second reading if that right is granted to them by the Senate Rules of Procedure.
