Statute/Amendment Text:

400.3 Calling of Senate Meetings

~~The President of the Senate Student Senate President shall be empowered to call Senate meetings, and shall call a meeting special sessions of the Senate with a twenty-four (24) hour notice at their discretion or if requested by a majority of the Senate in the form of a motion or petition signed by a majority of the members of Senate holding office at the time the petition is presented, petitioned by a majority of the members of Senate holding office at the time the petition is presented, or if requested by a majority vote of the Senate.~~

~~A. If a special session is called by the Student Senate President, an absence shall not negatively affect a Senator's attendance record.~~

A. The President of the Senate Student Senate President shall be empowered to call Senate meetings and shall call a meeting if petitioned by a majority of the members of Senate holding office at the time the petition is presented, or if requested by a majority vote of the Senate.

~~B. The Student Senate President may call a special session of the Senate at their discretion.~~

a. If a special session is called by the Student Senate President, an excused absence shall not negatively affect a Senator's attendance record.
