Whereas: According to the student body statute 622.3 , "The CLC funding committee shall allocate funds to CLCs from a block amount decided by the Budget Committee allocation for the next fiscal year", and

Whereas: The College Leadership Council funding Committee met on Wednesday, October 12th, 2022, to deliberate and allocate \$15,000.00 from the block amount decided by the Budget Committee for the 2022-2023 fiscal year, and

Whereas: The College Leadership Council funding Committee heard from the College of Arts and Sciences, the College of Business, the College of Criminology and Criminal Justice, the College of Fine Arts, on their plans for the upcoming year, and

Whereas: The College Leadership Council funding committee heard from the College of Arts and Sciences their request for \$1,000.00 to put on events like a mental health awareness 5k, professional development events with other RSOs, mental health therapy dog events with the Mental Health Council, and research panels, and allocated them \$2,500, and

Whereas: The College Leadership Council funding committee heard from the College of Business their request for \$18,000.00 to put on and pay for Deans & Donuts, Student/Faculty Mixer, FSU Day at the Capitol, Conference Attendance All University SLC's Mixer, President's Council End of Year Reception, Corporate Tour, Back to Business (College-wide Welcome Event), Family Weekend Events, Homecoming, Peer Connect, Community Service Events, Promotional Materials, Uniforms, Name Badges, Printing & Marketing Items, Social & Team Building Activities, Orientations & Tours, Leadership Development, Tabling & Recruitment, and the Untapped Potential Project, and allocated them \$4,000.00, and

Whereas: The College Leadership Council funding Committee heard the College of Criminology and Criminal Justice's request for \$1,500.00 for Food for various events and Expenses and allocated them \$2,000.00, and

Whereas: The College Leadership Council funding Committee heard the College of Communication and Information's request for \$3,700.00 for their BBQ and Spring Social Event and allocated them \$2,500.00, and

Whereas: The College Leadership Council funding Committee heard the College of Fine Arts request for \$1,900.00 to put on their Six publication party, fall food drive, The Arts Work event, Pizza with the Professors, and Career Development Opportunities, and allocated them \$2,000.00, and

Whereas: The College Leadership Council funding Committee heard the College of Entrepreneurship's request for \$2,650.00 to put on their JMC alumni round table, 3 entrepreneurship Shaw coffee hours, JMC Challenge, and Speaker events and allocated them \$2,000.00, and

Be it resolved by the Seventy-fourth Student Senate at Florida State University that: The College Leadership Funding Council recommends to fund these College leadership Councils the above amounts for the 2022-23 school year from the 2022-23 budget line for College Leadership Councils, and
