Whereas: The Russian government has consistently violated the sovereignty of Ukraine since its founding in 1991 by meddling in Ukrainian political affairs and supporting Russian separatists in the Donbas region,

Whereas: On Thursday, February 24 th, the Russian Government broke international law by waging a territorial conquest on the sovereign nation of Ukraine

Whereas: The Russian Military has committed multiple war crimes during its invasion of Ukraine, including attacking civilian apartments, children’s shelters, schools, and vital Ukrainian infrastructure,

Whereas: Vladimir Putin has destroyed the peace in Europe and has put the Ukrainian and Russian people in jeopardy in an attempt to exert force over a sovereign nation,

Whereas: The Ukrainian people have fought bravely against overwhelming odds, and have defended their country valiantly against blatant aggression,

Be it resolved by the Seventy-fourth Student Senate at Florida State University that: The Florida State University Student Senate does not condone the actions of Vladimir Putin and the Russian Government in its Invasion of Ukraine,

Be it further resolved that: The Florida State University Student Senate applauds the bravery of the Ukrainian people against the war crimes and aggression of the Russian State, and supports the Ukrainian people in their fight for freedom,

Be it further resolved that: The Florida State University Student Senate strongly urges Florida State University and the Florida government to divest in Russian companies and assets when applicable.
