Whereas: According to Student Body Statute 900.5, "Bureaus shall be annually reviewed by the Internal Affairs Committee, which shall recommend to Student Senate if a Bureau shall continue to exist", and

Whereas: The Student Council for Undergraduate Research and Creativity was heard by the Internal Affairs Committee of the 74th Student Senate on March 7, 2022, and

Whereas: The Internal Affairs Committee highly recommends that the Student Council for Undergraduate Research and Creativity prioritize communication with their Student Senate liaison, and

Whereas: The Internal Affairs Committee recommends the Student Council for Undergraduate Research Council work with the Student Senate and its liaison to work towards updating its governing statutes to streamline efficiency and executive board transition procedures as detailed by the bureau director, and

Whereas: The Internal Affairs Committee highly recommends the Student Council for Undergraduate Research Council updates their executive board leadership and contact information on the Student Governance and Advocacy website, and

Whereas: The Internal Affairs Committee highly recommends that the Student Council for Undergraduate Research Council establish transition documents to aid in transitioning in new executive board members, therefore

Be it resolved by the Seventy-fourth Student Senate at Florida State University that: Upon completion of Bureau Review, the Internal Affairs Committee of the 74th Student Senate recommends the Student Council for Undergraduate Research and Creativity should continue operating and continue their work on Florida State University's campus after proper review of the aforementioned recommendations,
