## 2023 SWEEPINGS PROVISO

## I. GENERAL

A. No account funded by A\&S fees may pay any stipend, wage, or salary increase to any positions not funded in Sweepings 2023 without the express consent of the Student Senate in the form of a resolution separate to that of the Sweepings Allocation.
B. In the event of shortfalls or excesses, the Vice President of Student Affairs, the SGA Advisor, the Student Senate President, and the Student Body President shall meet to review options.
C. All purchase requests shall be received prior to May 31, 2024.
D. Any unspent funds shall be returned to the Sweepings account.

## II. OPS WAGES

A. Monies allocated to the Union in the OPS Wages Category shall be used to pay wages for student workers for the 2023-2024 fiscal year.
B. OPS Wages allocated to the Student Government Executive Branch shall be used to make the Chief of Staff an OPS paid position in accordance with $\S 803.5$.
C. OPS Wages allocated to the Black Student Union shall be used to create an OPS paid front desk receptionist position to be funded at a rate of $\$ 12 /$ hour at 20 hours/week for 16 weeks in the Spring 2024 semester in accordance with §803.5.
D. OPS Wages allocated to the Center for Leadership and Service shall be used to create an OPS paid TedXFSU Intern position, and an OPS paid ServeScript Intern Position.

## III. SGA OFFICES

A. Part of the monies allocated to the Student Governance and Advocacy office in the expense category shall be used to purchase two (2) SGA Seals, three (3) flagpole kits and flags, one (1) conference table, one (1) TV, one (1) PC, and one (1) conference room webcam.
B. None of the monies allocated to the Student Governance and Advocacy office shall be used to develop the "Let's Budget" Simulation Game.
C. Of the funds allocated in the category of expense to The Office of Student Agencies and Institutes, $\$ 3,000$ shall be used for Lavender Celebration Stoles, $\$ 3,000$ shall be used for V-rak-ke-ce-tv Cultural Celebration stoles, and $\$ 1,000$ shall be used to purchase merchandise for Graduate Student Kickback.

## IV. SGA BUDGETED ORGANIZATIONS AND DEPARTMENTS

A. Monies allocated to Campus Recreation in the expense category shall be allocated to Leach Center Fitness Flooring Replacement, Outdoor Pursuits equipment, the Lakefront

Shuttle Program, and climbing wall upgrades. Any remaining funds may be used at the discretion of the department.

1. Monies allocated to The Sports Clubs Council should first be used to purchase scuba equipment and water polo goals. Remaining funds shall be used at the department's discretion.
B. All monies allocated in the expense category to the Student Union shall be controlled by the sole discretion of the student-elected Union Board members.
C. All monies allocated to the Student Union shall not be transferred to the Replacement and Renovation Account.
D. Monies allocated to FSU Class Councils shall be used to fund the Senior toast, the movie screening in partnership with the Askew Student Life Cinema, and the Spring Fair.
E. Funds allocated to FSU Class Councils shall not be used to purchase merchandise.

## V. AGENCIES

A. The Hispanic Latinx Student Union is encouraged to request the Senate to consider a transfer bill to effectuate the purchase of $t$-shirts under the Expense category.
B. The Jewish Student Union is encouraged to request the Senate to consider a transfer bill to effectuate the purchase of t -shirts under the Expense category.

## VI. AFFILIATED PROJECTS

A. No more than $\$ 2,000$ in the Expense category of WVFS Tallahassee 89.7 FM shall be used to purchase Chairs for the facility.

## VII. OUTSIDE DEPARTMENTS

A. Monies allocated to FSU Libraries shall only be used for the purchase of physical books for the Pop-Lit Section.
B. Monies allocated in the O.C.O category to the Academic Center for Excellence Learning Studio shall be used to purchase upgrades to furniture.
C. Monies allocated to the University Health Services department shall not be used for the purchase of a spinning wheel.
D. Monies allocated to the FABLAB-Innovation Hub shall be used to fund two (2) Large XL3 Printers, and two (2) Medium MK4 Printers.

## VIII. RECOGNIZED STUDENT ORGANIZATIONS

A. Monies allocated to the Business Case Club must be used for travel to conferences.
B. Monies allocated to FSU Hillel shall be used to fund one (1) giant menorah and the Hanukkah Party.
C. Monies allocated to the African Student Association in the category of Clothing and Awards shall be used to purchase t-shirts.
D. Monies allocated to the Caribbean Students' Association shall be used for Pageant Catering and T-Shirts.
E. Monies allocated to Every Nation Campus Tallahassee shall be distributed evenly amongst all FSU student travelers for registration fees.

## IX. SEVERABILITY CLAUSE

A. Any part, provision, or representation of this Bill, which is prohibited, or which is held to be void or unenforceable shall be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof.
