Whereas: In recent weeks the University has failed to address concerns from the Black community over an undeniable absence and lack of representation for black males on FSU's Homecoming court, on inadequately addressing the hanging of a KKK poster which emboldened racial hate on September 28th, and the racial discrimination present at football games as displayed prominently by the block seating incidences that happened at the beginning of this Fall, and

Whereas: Last Saturday, October 2nd, 2021, the Black Student Union here at Florida State University hosted a Blackout event encouraging the student body to wear black in a show of solidarity at the October 5th football game, and

Whereas: The Black Student Union hosted an organized march from Wescott Fountain to Doak Campbell Stadium before the game demanding more protections for the Black community here on our campus and abroad, and

Whereas: The Black Student Union demands that a diversity and inclusion curriculum included in FSU co-curricular activities be created with the consultation of FSU's identity based agencies, that funding urgently goes towards comprehensive camera placements, that a specialized resource is created that specifically handles when marginalized communities are attacked on campus, that the university set expectations and guidelines about hate speech and visibility of that message, and the BSU demands more transparency of the processes of our local and school police departments and report systems, and

Whereas: It is the duty of our SGA Student Senate to advocate for every community here on our campus in order to uplift their voices and messages for Florida State University's administration to hear, and

Be it resolved by the Seventy-third Student Senate at Florida State University that: The Seventy-third Student Senate stands behind and advocates for the demands of the Black Student Union that a diversity and inclusion curriculum included in FSU co-curricular activities be created with the consultation of FSU's identity based agencies, that funding urgently goes towards comprehensive camera placements, that a specialized resource is created that specifically handles when marginalized communities are attacked on campus, that the university set expectations and guidelines about hate speech and visibility of that message, and that there be more transparency of the processes of our local and school police departments and report systems, and

Be it further resolved that: The Seventy-third Student Senate acclaims the Black Student Union's activism and work in planning and hosting the Blackout Event and March to show unity and solidarity for the Black community on campus and behind the BSU's goals to make FSU a safer campus for all marginalized communities.

Whereas: Florida State University students pay tuition and fees, which include access to parking in commuter and overnight lots and garages, and

Whereas: The FSU Parking and Transportation Services website states that "Permits are valid August 15 of the first year through August 15 of the following year for currently enrolled students, faculty, and staff (except Payroll Deduction and Visitor Permits)," and

Whereas: Over the course of the past year, parking spaces in multiple ground lots and garages around campus have been converted to ParkMobile "Pay to Park" spaces, and

Whereas: The now paid parking spaces were formerly parking spaces in which anyone with a valid and corresponding FSU permit could park, and

Whereas: FSU students regularly express frustration about parking and ask what their SGA representatives can do to alleviate these parking issues, and

Whereas: Multiple constituents have reported that these Pay to Park spaces are frequently left unused in commuter lots such as the student surface lot adjacent to the Stadium and in garages such as Spirit Way, and

Whereas: If FSU wanted to convert some of the parking spaces on campus to a special permit, they could have enhanced campus sustainability initiatives and added charging stations to more garages.

Be it resolved by the Seventy-third Student Senate at Florida State University that: we recognize that many of our constituents are frustrated with the Pay to Park system used in our parking lots and garages.

Be it further resolved that: the Seventy-third Student Senate at Florida State University recognizes that access to parking has long been an issue on our campus that has been further exacerbated by the volume of Pay to Park spaces.

Be it further resolved that: the Seventy-third Student Senate recognizes that there are certain instances when Pay to Park can increase community accessibility and visitor interaction through permitless parking.

Be it further resolved that: we, the Seventy-Third Student Senate at Florida State University implore the university to use all funds generated from the Pay to Park system towards additional free student parking spaces, especially in the form of new, expansive, and sustainable garages on current Florida State University property.

Be it further resolved that: the Seventy-third Student Senate at Florida State University implores the university to explore the possibility of adding electric car charging spaces to campus garages.

Be it further resolved that: the Seventy-third Student Senate at Florida State University thus condemns the conversion of previously free and accessible student parking spaces in commuter lots and garages to a now paid luxury.
