SECTION 1: Student Body Statutes §100.5 shall be amended to read:

100.5 Within the Student Body the following elected or appointed offices shall be considered major offices:

Student Body President

Student Body Vice President

Student Body Treasurer

Student Body Attorney General

Executive Chief of Staff

Cabinet Officers

Directors, and Assistant Directors, Secretaries, Treasurers of

Agencies, Bureaus, and Affiliated Projects

Senators

Members of the Office of Governmental Affairs Board of Directors

Justices of the Student Supreme Court

Clerk of the Court

SECTION 2: That a new statute be inserted at the end of Chapter 100 of Student Body Statutes which reads:

100.11 In cases that an Agency, Bureau, or Affiliated Project does not use the nomenclature included in this chapter for their major offices, the first four student offices listed in each body chapter shall be considered as major offices and shall be bound by all regulations on those holding major office.

Whereas: Further detail is needed to determine how to handle legislation whose primary sponsor or sponsors are consistently absent from presenting their legislation to a committee.

Be it resolved by the Seventy-Third Student Senate at Florida State University that: the following changes be made to the 73rd Student Senate Rules of Procedure and shall take effect five minutes before the end of the last meeting of the 73rd Student Senate:

- 10.11. The primary sponsor of any bill, constitutional amendment or resolution may withdraw consideration of the document from the Calendar of the Senate at any time.
 - a. If no primary sponsors of a measure are present for three (3) committee meetings during which their measure is to be considered, the sponsor(s) shall meet with the Chair of the committee to determine whether or not they should withdraw the measure from consideration.
 - 1. If a decision is not reached during that meeting, the committee may withdraw the measure from the committee's agenda by a two-thirds (2/3) vote.
 - a. Following the passage of a vote to withdraw the measure from the committee's agenda, the measure shall be removed from that committee's agenda and referred to the Rules Committee for withdrawal from the Calendar of the Senate.
 - If the Chair of the committee and the primary sponsor decide to keep the
 measure in the committee, the sponsor shall have three (3) committee
 meetings following the date of the meeting with the Chair to present the
 measure. Failure to present the measure within that time frame shall
 result in the measure being automatically referred to the Rules Committee
 for withdrawal.
 - 3. Any legislation that is referred to the Rules Committee for withdrawal, shall be considered based on whether the primary sponsor or sponsors are capable of continuing to present this measure. The Rules Committee shall take one of the following actions by a majority vote:
 - a. Withdraw the measure from the Calendar of the Senate;

- b. Recommend to the Student Senate President that the measure's committee referral be reconsidered as stipulated in Rule 5;
- c. <u>Assign a new primary sponsor or co-primary sponsor to the measure.</u>
