Resolution 82

WHEREAS: On June 6, 2013 a republican led initiative introduced to the United States House of Representatives; Immigration enforcement Bill H.R. 2278, the Strength And Fortify Enforcement Act (SAFE Act), and

WHEREAS: This Bill was referred to House Subcommittee on June 25, 2013, remaining under current revision by subcommittee on Conservation, Energy and Forestry, and

WHEREAS: This Bill would allow States to enact, implement and enforce criminal penalties that penalize the same conduct that is prohibited in the criminal provisions of immigration laws, and

WHEREAS: The law enforcement personnel of States, may investigate, identify, apprehend, arrest, and detain undocumented persons to the same extent as Federal law enforcement personnel, and

WHEREAS: Implementation of this Bill would lead to rampant profiling and racial discrimination towards all the ethnic groups that fall under immigrant background, and

WHEREAS: This Bill eliminates the administration's ability to implement its Deferred Action for Childhood Arrivals (DACA) policy and other policies related to reviewing otherwise deportable people's immigration cases to determine if they should be allowed to remain in the U.S., and

WHEREAS: This Bill would have a largely negative economic impact on the country. After enacting an immigration enforcement policy similar to those described in the SAFE Act, Arizona's economy lost \$141 million, including \$45 million in hotel and lodging cancellations and \$96 million in lost commercial revenue, therefore

BE IT RESSOLVED BY THE SIXTY-FIFTH STUDENT SENATE AT THE FLORIDA STATE UNIVERSITY THAT:

The Florida State University will stand in strong opposition to Bill H.R. 2278, and will work to bring attention to this issue at the local, State and Federal level of the United States Government.
