The Sixty Fourth Student, Senate Resolution 43
Sponsored by: Senator Wilson and Senator Scott

WHEREAS: Voting is a fundamental right of every citizen in this nation,

The State of Florida, claiming that they wish to cut down on WHEREAS election fraud, has been deploying tactics to disenfranchise voters of particular populations, specifically students, the elderly, minorities, and people of low income,

The kinds of election fraud that the State is claiming to remedy is, in fact, vanishingly uncommon, and simply a poor excuse to remove voters from registries, and keep them from being able to vote,

WHEREAS: The U.S. Department of Justice, along with other groups, are challenging the legality of voter purges, as the National Voter Registration Act bars states from engaging in certain types of voter purges 90 days before a federal election,

WHEREAS: Letters being sent to thousands of "potentially ineligible" voters are tactics of intimidation, as they suggest that until they produce costly proof of their eligibility, they may not be eligible, and that casting a vote when ineligible is a felony,

WHEREAS: These kinds of policies are undemocratic and are simply used for political gain,

BE IT RESOLVED AT THE SIXTY-FOURTH STUDENT SENATE THAT:

We the students of the Florida State University, in conjunction with the students of Florida Agricultural and Mechanical University, find the voter suppression tactics employed by the State of Florida are completely unacceptable, and demand that the State halt any further efforts to purge the voter registry

The Sixty Fourth Student Senate Resolution

WHEREAS: The 2011 Florida law HB 1355 has reduced the required number of hours that early voting can take place before an election,

WHEREAS Prior to this law, supervisors of elections were required to provide AT LEAST 96 hours of early voting access,

WHEREAS Under the new law, early voting must be available six hours a day for eight days (a total of 48 hours), and can be available for up to 12 hours a day for eight days (a total 96 hours),

WHEREAS It is now at the discretion of the local authorities to provide the maximum amount of access to early voting, or cut that access in half,

WHEREAS It has been shown that early voting is disproportionately used by Florida's minority populations, and that restrictions on early voting would threaten to further disenfranchise a very particular population of voters,

BE IT RESOLVED AT THE SIXTY-FOURTH STUDENT SENATE THAT:
We the students of the Florida State University, in conjunction with
the students of Florida Agricultural and Mechanical University,
strongly encourage ALL counties of Florida to extend access to early
voting to the maximum allowed 96 hours
