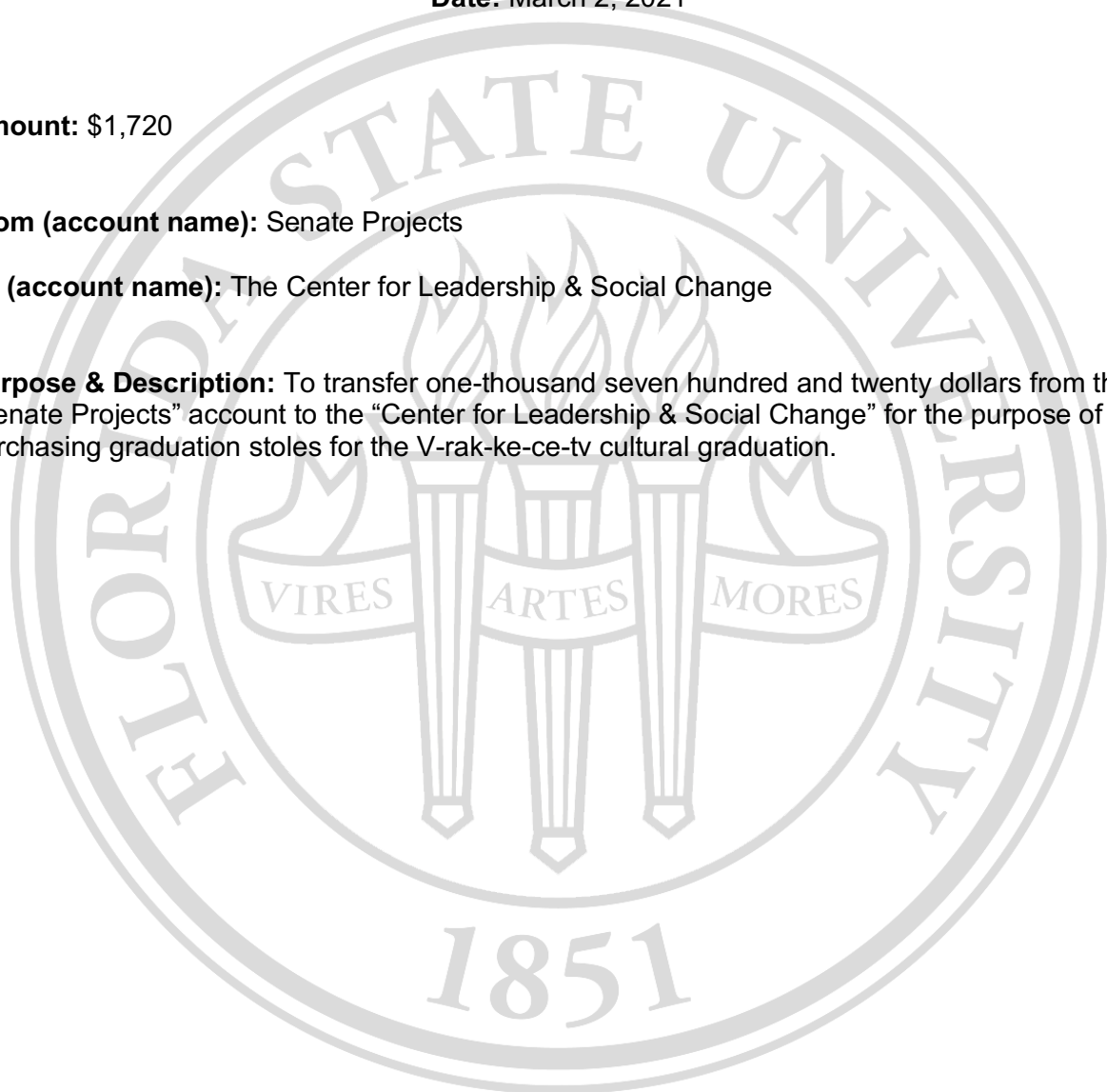

Purpose & Description: To further promote gender identity inclusion and preferred names in SGA elections

Statute Number(s): 712.1 C

Statute/Amendment Text: Candidates shall be listed by seat in alphabetical order of their last names and the name shall be printed in the same form as requested at the time of filing. Each candidate's last name shall appear on the ballot, and the name must be the same as it appears on the candidate's FSU identification card myFSU account. No affiliation other than those specified in 712.1 C F shall be printed with any candidate's name.



73rd STUDENT SENATE Senate Resolution

Resolution #: 26

Whereas: Local Fees are defined as the Activity & Service (A&S) fee, the Athletic Fee, and the Health Fee, and

Whereas: Florida Statue 1009.24 states the total Local Fee may not exceed 40% of tuition, which is \$215.55, and

Whereas: Local Fees per credit hour are currently \$34.73, representing 16% of the cost of tuition, and

Whereas: the Local Fees total is the sum of an A&S Fee of \$12.86, an Athletic Fee of \$7.90, and a Health Fee of \$13.97, and

Whereas: the Student Local Fee Committee for FSU, established with Florida Statue 1009.24, reviews and recommends Local Fee increases annually for the betterment of Florida State University, and

Whereas: Florida Statue 1009.24 gives Florida State University the authority to increase the aggregate sum of the fees by no more than 5% annually, which represents an increase of \$1.73, and

Whereas: the Student Local Fee Committee heard requests from representatives of departments who receive funding from the A&S and Health Fees, in which each group requested their respective fee be increased by the maximum amount, and

Whereas: there was no increase requested for the Athletics Fee, and

Whereas: the proposed fee increases would increase the Local Fees to the following amounts: an A&S Fee of \$13.69 and a Health Fee of \$14.87, while the Athletic Fee would remain at \$7.90, and

Whereas: the proposed total Local Fees would be \$36.46, representing 17% of the current tuition cost of \$215.55, and

Whereas: the Student Local Fee Committee makes the recommendation to increase the Local Fees to this new total of \$36.46, with an A&S Fee of \$13.69, an Athletic Fee of \$14.87, and a Health Fee of \$7.90.

Be it resolved by the Seventy-third Student Senate at Florida State University that:

This Senate supports the increase in the Local Fees as it will allow the university to better serve its student population and meet their needs.
