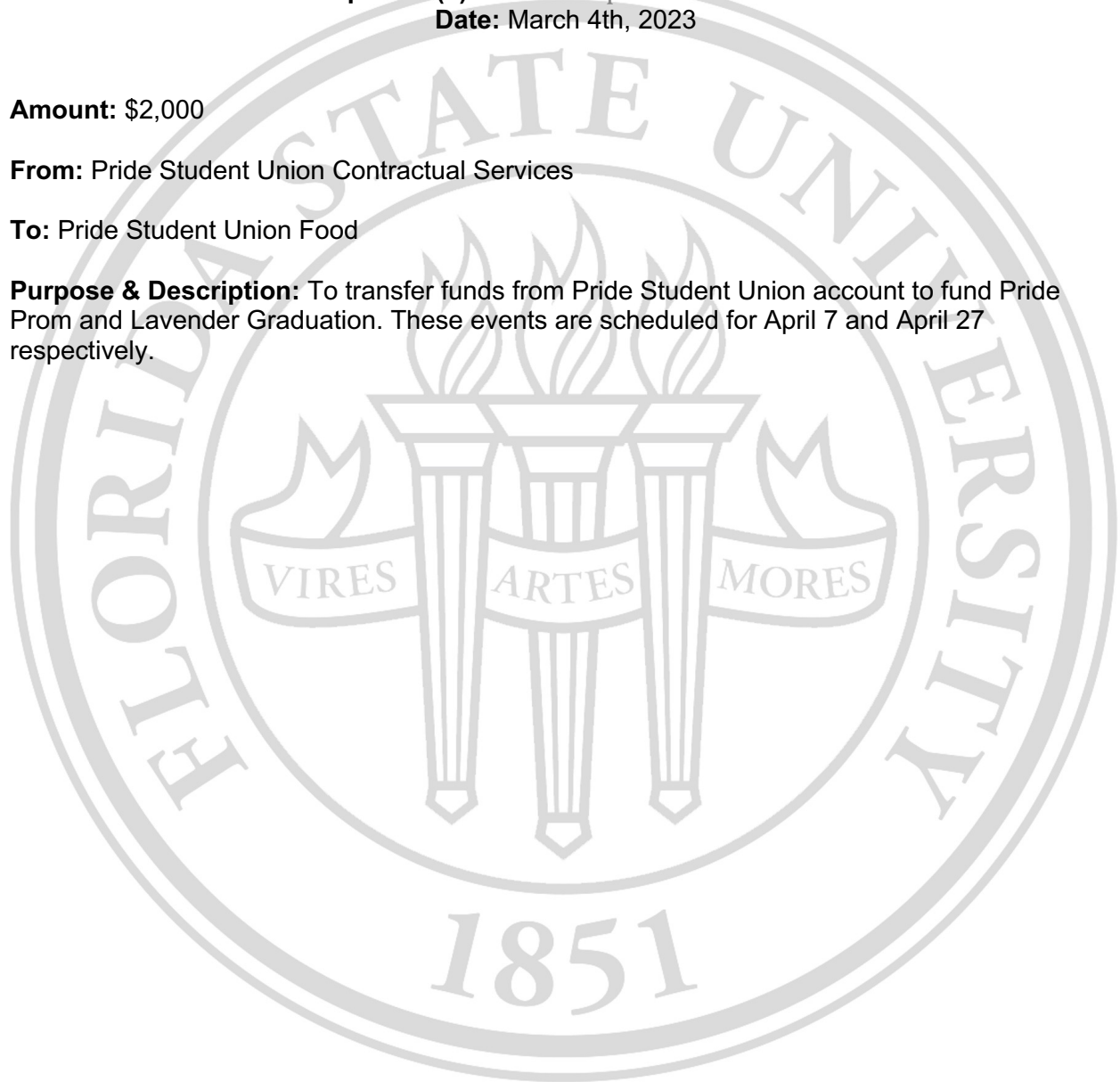

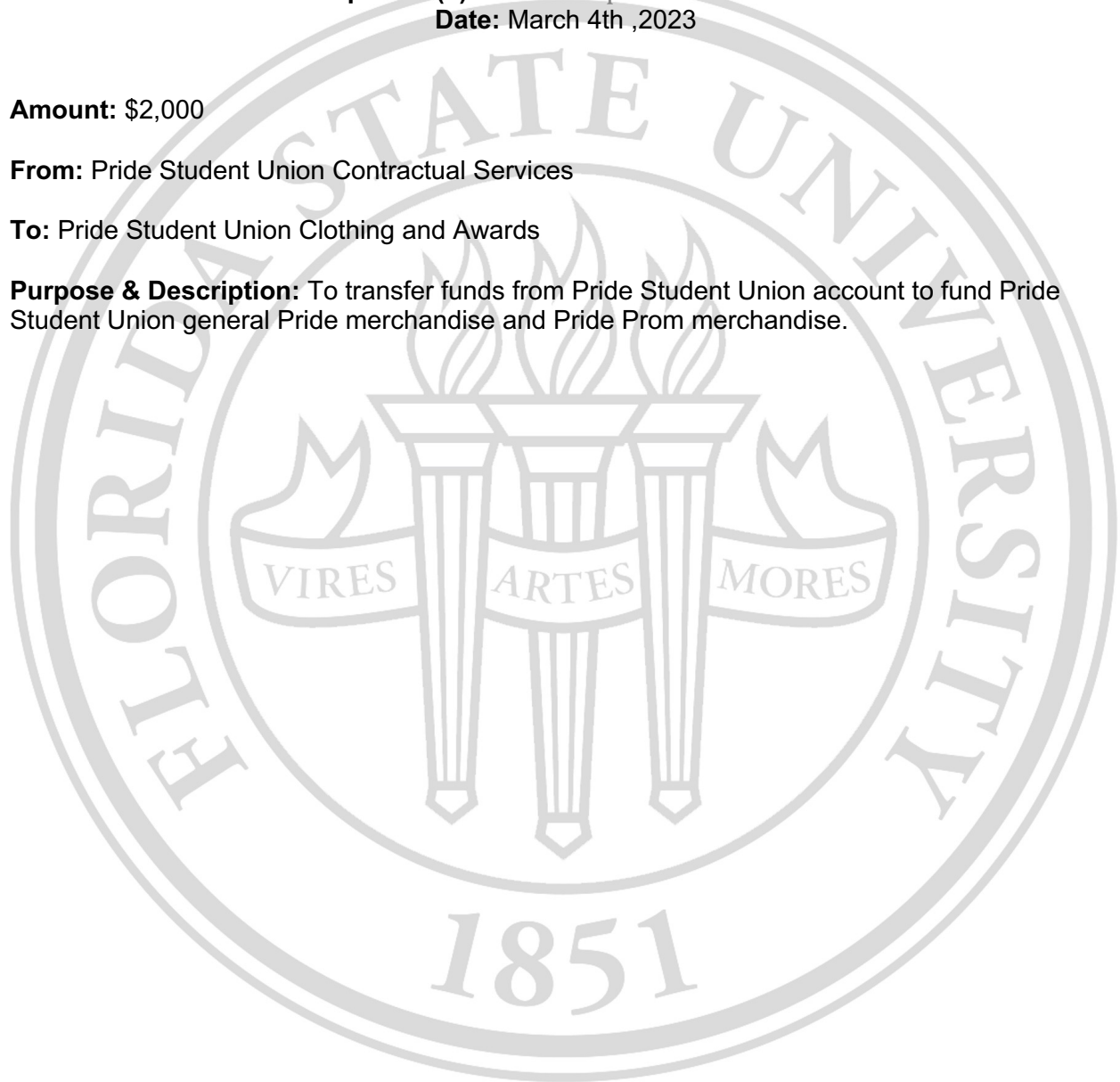

**Statute Number(s):** 302.8

**Statute/Amendment Text**

8. Vacancies and Leaves of Absence

A. Junior and Sophomore Class Vacancies

In the event a seat on the JCC or SoCC, becomes vacant the replacement procedure will be done as follows:

1. President and Vice President

a. Applications must open within five (5) school days of an officer renouncing the position.

b. The application must be advertised for a minimum of ten (10) school days.

c. Upon the receipt of applications for a vacant position in the JCC, the interviews will be conducted by the Senior Class Council President, and the remaining members of the JCC respective Class Council, before being forwarded to the Chief of Staff.

d. After being forwarded by the Chief of Staff, the applicant will be confirmed through Internal Affairs Committee of the Student Senate, with final confirmation on the Senate floor.

2. Treasurer and Secretary

a. Applications must open within five (5) school days of an officer renouncing a position.

b. The application must be advertised for a minimum of ten (10) school days.

After the interviews for said positions have been concluded and a candidate has been chosen by the JCC respective Class Council that person will be appointed by the President of that Class Council ~~the JCC~~ at their earliest convenience.

**Purpose & Description:** Revising language pertaining to the approval and veto process of bills passed by the Student Senate, and providing more time for the Vice President for Student Affairs to sign the annual budget bill to conform to Florida Statute 1009.24(10)(b).

**Statute Number(s):** SBS § 402.2, 416.3

**Statute/Amendment Text:** See attached



## 402.2 Veto and Veto Amendment Process

- A. Upon presentation of a bill, the Student Body President shall have five (5) school days to approve or veto the legislation. If no action is taken within the five (5) day limit, then the bill shall be treated as approved by the Student Body President. This five (5) day limit shall begin on the first school day after the Bill is ~~passed by the Student Senate~~ received by the Student Body President via email. ~~If approved, the~~ The Student Body President shall then submit the bill to the Vice President for Student Affairs for consideration. ~~Attorney General. The Attorney General shall refer approved bills to the Vice President for Student Affairs within three (3) school days of receipt. In the absence of an Attorney General, the Student Body President shall be responsible for referring approved bills to the Vice President for Student Affairs.~~
- B. The Student Body President must submit written justification/reasoning to the Student Senate, within the five (5) day limit, of receipt to sustain any veto of legislation. The Student Body President or a designee must also deliver an oral justification to the Student Senate for the reason for the veto(es) within two (2) Senate meetings. The copy of the President's justification/reasoning for the veto(es) must be e-mailed from the Student Body President to the Senate President so that the Senate President may e-mail distribute it to all Senators at least 48 hours prior to the President's oral justification to the Senate. The Senate President must send the originally vetoed bill to all Senators. If the Vice President for Student Affairs vetoes a bill, it is suggested that they send a request be submitted to submit that individual requesting an email notification/reasoning of the veto to the Senate President. If this occurs, a copy of the emailed justification/reasoning must be emailed distributed to all Senators.
- C. Bills not acted upon within ten (10) school days after being received by the Vice President for Student Affairs shall be treated as approved unless the Student Body President, Senate President and Student Body Attorney General are notified why the Bills not the Student Subsection 402.2 (C) shall governed by Chapter by the Vice President for Student Affairs within the ten (10) day limit as to bill will not be acted upon within that limit and when action will be taken. acted upon within eighteen (18) school days after being passed by Senate shall be treated as approved. The provisions of not apply to the annual A&S budget bill, which shall be 416.3.
- D. If a vetoed bill from either the Student Body President or Vice President for Student Affairs is amended on the floor of the Senate during the reconsideration of the bill, that bill will be considered new legislation and be resubmitted to the Student Body President and Vice President for Student Affairs for approval or veto, all preceding statutes on time constraints to bill consideration applying.
- E. If a presidential veto is overridden, that bill shall then go directly to the desk of the Vice President for Student Affairs for consideration as soon as possible; the preceding statutes on time constraints to the bill consideration applying again upon presentation the following school day.
- F. ~~Chapter 402.2 shall nullify and supersede any conflicting statute or rule.~~



## Chapter 416 Annual Budget Procedures Act of 2016 (updated)

### 416.1 Purpose

This act is to establish a procedure by which the annual Activity and Service Fee (A&S) Budget of the Student Senate is produced and passed.

### 416.2 Scope

The Annual A&S Fee Budget hereby referred to as the Budget shall be passed in compliance with the provisions of this act and all applicable provisions within the State of Florida Administrative Code. No exceptions are authorized other than those specified within.

### 416.3 Procedures for Passage of the Budget

- A. The Budget shall not be approved by the Student Senate in a Summer Session.
- B. An estimated amount of the Budget shall be used to submit to the Senate President for First Reading by the Chair of the Budget Committee. After which, hearings shall be held and operated at the discretion of the Chair the Budget Committee.
1. Each prospective recipient of monies from the Budget shall make budget request. The Budget Committee shall hold hearings during which budget requests are defended. Each prospective recipient the Budget shall have a separate hearing.
  2. The hearings shall be administered by the Chair of the Budget Committee and shall require a minimum of three (3) Senators. The Budget Committee will in good faith obtain quorum.
  3. The Budget Committee shall have the authority to deliberate monies to requesting and non-requesting prospective recipients. The Budget Committee shall also be authorized to deliberate more or less than the amount requested.
- C. When the Budget has been deliberated and approved in whole by the Budget Committee it will be heard on Second Reading. All Senators shall be presented copies of the proposed allocations. The Budget shall be on the calendar for second reading for a minimum of five (5) business days with proposed allocations before passage. The budget and proviso must properly be advertised on the Student Government website while on Second Reading.
- D. The Budget shall be approved by the Senate before the beginning of the fiscal year of which it affects. The Chair of the Budget Committee shall make a good faith effort to complete the Budget no later than October 31 of each year.

- E. The Budget and Proviso language cannot be approved separately. Changes to the Proviso language may be made via resolution at any time before the Budget is approved by the Board of Trustees. This resolution shall be passed with a two-thirds (2/3) vote of the Senate.
- F. Amendments to the Budget, on the Senate floor, must follow a majority vote to unlock a specific line item and category of the Budget or a line of the Proviso language. Any amendment that affects the allocation amount in any line of any recipient shall require a three-fourth (3/4) vote of the Senate.

1. Amendments may only be made to a specific category of one recipient.

- G. Hearings, deliberations, and meetings of the Budget Committee are and shall be advertised in the Senate. The Chair of the Budget Committee shall not exclude any student from witnessing the hearings or in accordance with Chapter 409 of the Student Body Statutes.

- H. The Budget shall be passed by a roll-call vote. A simple majority is required for passage.

- I. If the Budget is failed in Senate or vetoed by the Student Body President within five (5) school days of receipt, the Budget Committee shall create a new budget in due time, following the guidelines in these statutes.

- J. The Vice President for Student Affairs shall retain line-item veto power over the budget bill and have fifteen (15) school days from the date of presentation of the budget to act on the allocation and expenditure recommendations, which shall be deemed approved if no action is taken within the 15 school day limit.

1. If any line item or portion within the budget is vetoed by the Vice President for Student Affairs, the Student Senate shall, within fifteen (15) school days, make new budget recommendations for expenditure of the vetoed portion of the bill. These new recommendations shall be made in the form of a new bill, which shall be deliberated by the Budget committee without the need for new budget request hearings.

2. If the Vice President for Student Affairs vetoes any line item or portion thereof within the new budget revisions, the Vice President for Student Affairs may reallocate by line item that vetoed portion to bond obligations guaranteed by Activity and Service fees.

3. The Vice President for Student Affairs may also veto the budget bill in its entirety, in which case the Budget Committee shall create a new budget in due time, following the guidelines in these statutes.

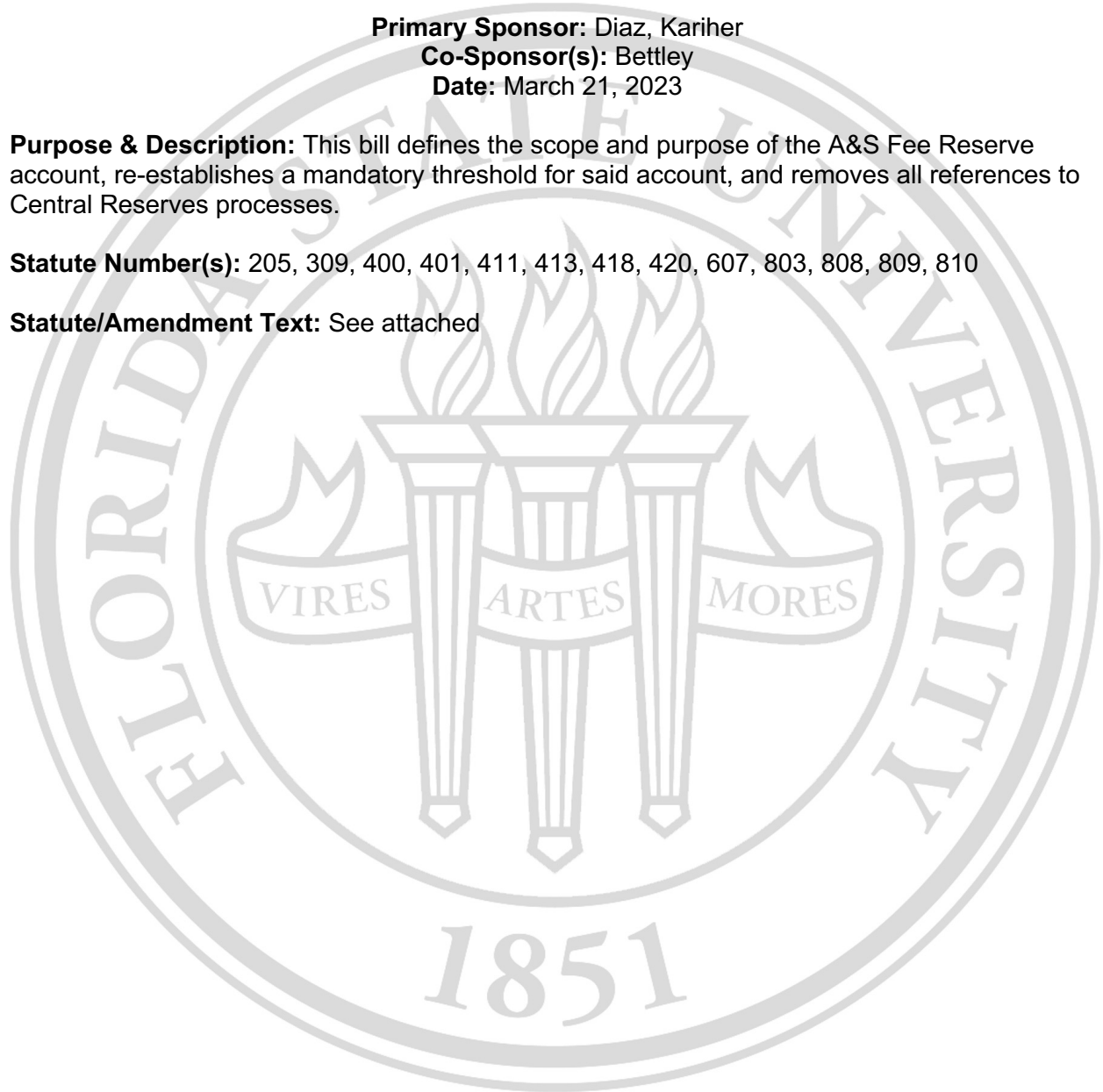

## Chapter 205 Code of Ethics

### 205.3 Standards of Conduct

2. No officer or employee will judge or vote on any matter that would affect private gain. No Executive Board member of an SGA funded organization may vote within a funding committee of Senate on an allocation to the organization in which that member serves as an Executive Board member which requires Student Senate confirmation. This restriction will not apply to that members' vote on the final annual budget, or sweepings, or central reserves.

## Chapter 309 The Executive Projects Account

### C. Funding

The account may be replenished by the annual budget, ~~central reserves, sweepings, or by transfer from any other account.~~

## Chapter 400 Organization of the Senate

### 400.7 Senate Committee

- D. Senators may also serve on Sweepings and Central Reserves Committees in addition to membership on other committees.

## Chapter 401 Forms of Legislation

### 401.3 Omnibus Bills

- B. If a bill covers three or more statutory titles, as defined in Title I, or provides funding for multiple organizations, it shall be defined as an Omnibus Bill. A two thirds (2/3) vote is required for final passage of an Omnibus Bill. The annual budget, and sweepings, and central reserves bills shall not be considered to be Omnibus bills.

## Chapter 411 Senator's Committee Rights

- C. Neither Section 411 A nor B applies to the Rules and Calendar, Sweepings, or Supplemental Funding, or Central Reserves Committee.

411.2 The ~~Central Reserves and Sweepings Committees are~~ is a special standing committees that shall exist for a particular session until ~~their~~ its respective duties have been completed.

## Chapter 412 Sweepings Regulations Act of 1995

~~412.2~~ In all cases where monies in the excess of five thousand dollars are released from the Central Reserves to Senate, ~~excluding Sweepings, the~~

~~same procedures described in 412.1, shall be used to determine how this money will be allocated, with the following exceptions.~~

- ~~A. The Student Body President shall not have a line item veto on such allocation. However, the Student Body President and Student Body Vice President shall be members on this committee.~~
- ~~B. The committee shall be permitted to meet as long as needed and may be called into existence at any time by the Student Senate President, or majority vote of the Student Senate.~~

#### 413.7 Spring Awards

- ~~D. The Artes Award (Chair of the Year) - The best Chair of the Resource for Travel Allocation Committee (RTAC) Programming Allocation Committee (PAC) and Standing Committee Chairs (other than Rules and Calendar, Central Reserves and Sweepings). The Senator awarded the Artes Award demonstrates exception working their communities and has excelled in skill while chairing the committee.~~

### **Chapter 418 The Senate Projects Account**

#### 418.4 Funding

- ~~A. The account may be replenished by the annual budget, central reserves, sweepings, or by transfer from any other account.~~

### **Chapter 420 Major Legislation**

#### 420.1 Definition major Legislation

~~Major legislation shall include the Budget Bill, the Sweepings Bill, the Central Reserves Bill, and the Legislative Agenda Resolution. The Senate President has the authority to determine if any other bill, resolution, or allocation shall be deemed major legislation.~~

### **Chapter 607 Congress of Graduate Students**

#### 607.1

##### G. Duties and Responsibilities of COGS

- 8. COGS will be offered a non-voting ex-officio seat on all Student Senate Budget Committees, budget sub committees, ~~Central Reserves Committee~~, and Sweepings Committee.

### **Chapter 803 SGA Budgetary Categories & Categorical Restrictions**

### 803.5 The OPS Wages Category

- A. Wages may only be drawn from this account in the manner explicitly stated by the Student Senate in the proviso language of the annual budget (or the Sweepings ~~or Central Reserves~~ proviso). Money may not be redistributed within the category except as stipulated in 803.5 B.

### 803.9 The Other Capital Outlay (OCO) Category

- A. All money budgeted to the OCO category in the annual Budget, ~~and Sweepings, and Central Reserves~~ bills must have attached proviso language explicitly stating the purpose of the funds. All appropriations from Senate Projects into this category must be preceded by a resolution explicitly stating the purpose of the funds.

## Chapter 808 Operation Procedures

### 808.9 Sports Club Distribution Council

#### D. Specific Guidelines

1. No allocations shall transpire without the approval of the specific allocations via resolution of the Student Senate. ~~This shall exclude allocations from Central Reserves.~~

## Chapter 809 ~~Policy on Reserve Accounts~~ Replacement & Renovation Accounts

~~809.7 The A&S Reserve will be utilized for cash flow needs, enrollment shortfalls, and budgetary emergencies. A Senate bill will be required to release funds from this account.~~

~~809.8 The A&S Reserve shall be maintained at a level of five hundred thousand (\$500,000).~~

~~809.9 The required contribution into this account will be the first priority on A&S dollars.~~

## Chapter 810 ~~Forms pertaining to Funding Boards shall be jointly determined by the Senate President and SGA Director of Student Affairs.~~ Activity & Service (A&S) Fee Management and Reserve Account

810.1 The Office of the Vice President for Student Affairs (OVPSA), shall maintain an A&S Reserve account that shall be maintained at fifteen (15) percent of the annual A&S budget passed by Student Senate.

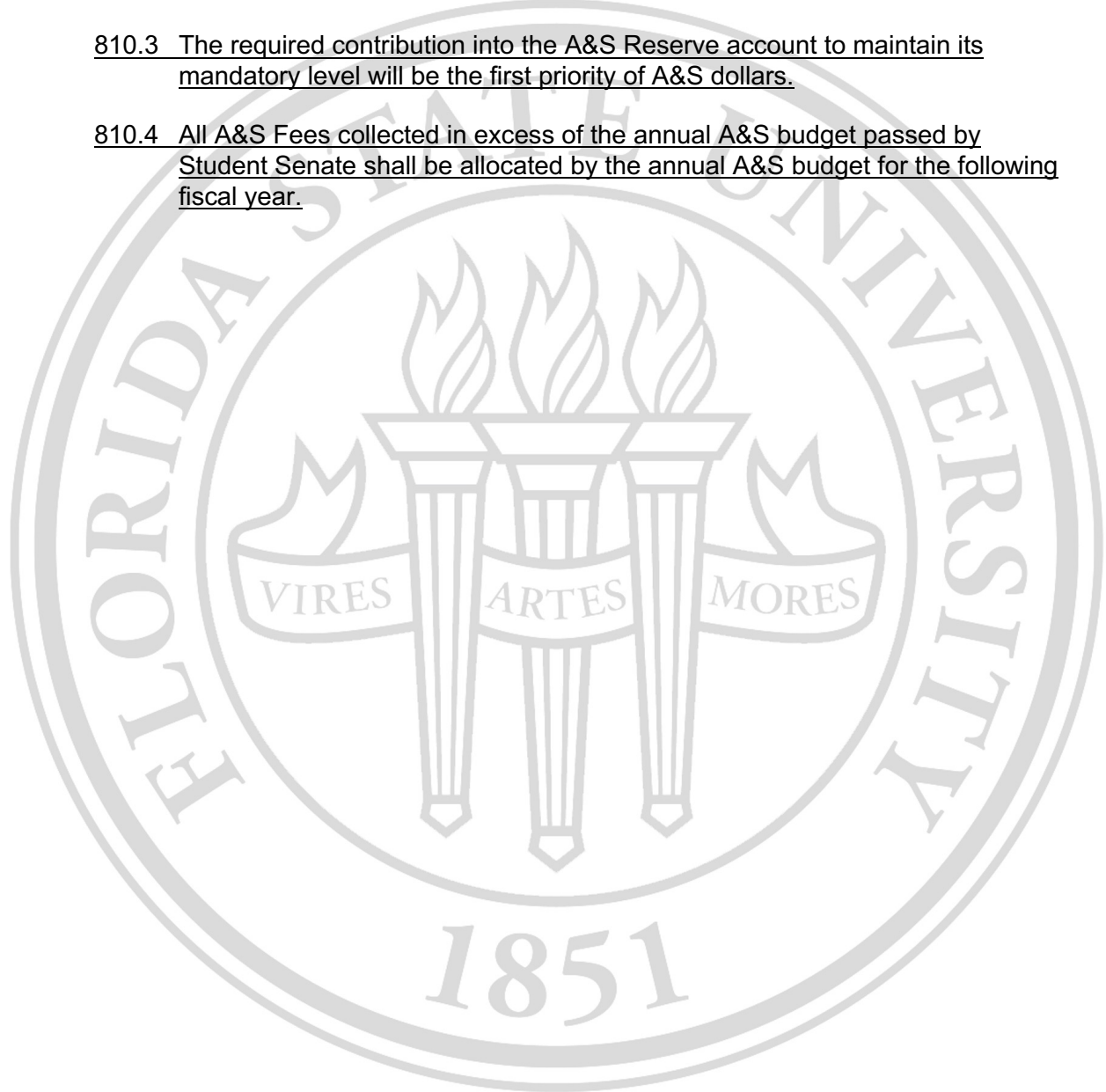
- A. All A&S Fees held in excess of the mandatory level at the end of each fiscal year, shall be allocated in the annual A&S budget for the following fiscal year pursuant to Chapter 416.
- B. The OVPSA must receive Senate approval to hold more than more than mandatory level.

1. The Chair of the Budget committee shall present the request in the form of a resolution and shall require a two-thirds (2/3) vote of the Senate.

810.2 The A&S Reserve account will be utilized for cash flow needs, enrollment shortfalls, and budgetary emergencies. Funds released for these purposes shall require authorization via a Senate bill.

810.3 The required contribution into the A&S Reserve account to maintain its mandatory level will be the first priority of A&S dollars.

810.4 All A&S Fees collected in excess of the annual A&S budget passed by Student Senate shall be allocated by the annual A&S budget for the following fiscal year.

**Whereas:** This body values the dignity of all persons, and

**Whereas:** Florida House Bill 1421 states that public postsecondary institutions may not provide funding or reimbursement for gender affirming care, and

**Whereas:** Florida House Bill 1421 prohibits anyone in the State of Florida from changing their sex assigned at birth, and

**Whereas:** Florida House Bill 1421 prohibits health insurance policies from providing coverage for gender affirming care, and

**Whereas:** Florida House Bill 1421 prohibits health maintenance contracts from providing coverage for gender affirming care, and

**Whereas:** The public state universities are leading the nation in gender affirming care and provide an affordable way for patients to access physicians specialized in transgender primary care, hormone therapy, hair removal, mental health services, OBGYN services, surgical care, urology, and voice therapy, and

**Whereas:** According the American Medical Society, youth who receive gender affirming care had a 60% lower odds of moderate or severe depression and 73% lower odds of suicidality, and

**Whereas:** The American Medical Society states that interfering in the medical care of transgender youth would be detrimental to their health, and these measures insert the government into clinical decision-making and force physicians to disregard clinical guidelines, therefore

**Be it resolved by the Seventy-fifth Student Senate at Florida State University that:** The passage of Florida House Bill 1421, or any bill that aims at limiting or banning gender affirming care is antithetical to the values of our institution and is condemned in the strongest possible terms, and

**Be it further resolved that:** The 75th Student Senate amends the Legislative Agenda by strongly opposing House Bill 1421, and

Resolution #: 29

**Date:** March 7th, 2023

**Whereas:** On March 7, 2023, Florida State Senator Erin Grall proposed Senate Bill 300, “Pregnancy and Parenting Support”; and

**Whereas:** This bill outlines a near-complete ban on abortions that occur after six weeks of gestation in the state of Florida, with exceptions for survivors of incest and rape, whose abortion access is limited to occur before fifteen weeks of gestation; and

**Whereas:** This transgression of reproductive rights is just the latest in a long series of attacks from a local, state, and national level, which started with the decision of the U.S. Supreme Court case *Dobbs v. Jackson Women’s Health Organization*, which overturned the historical precedent set in *Roe v. Wade* that legalized abortion nationwide, and the Florida passage of the “Reducing Fetal and Infant Mortality Act”, which banned abortions after fifteen weeks of gestation; and

**Whereas:** Though the overturning of *Roe v. Wade* did not itself ban abortion, it did open the door for malicious legislators to attempt to institute such bans, as can be seen through the archaic Senate Bill 300; and

**Whereas:** Florida’s Constitution guarantees the right to privacy in Article I, Section 23, which would seem to prohibit any bans such as the ones already passed and proposed; and

**Whereas:** The most effective way to reduce abortions does not come through the restriction of reproductive freedoms, but rather through the expansion of access to contraceptives, which sees far higher rates of success, according to the Guttmacher Institute; and

**Whereas:** Abortion bans disproportionately affect college students, as 42% of all abortions are obtained by individuals aged 18-24, according to the Guttmacher Institute; and

**Whereas:** Abortion bans have been proven to decrease college enrollment, specifically for Black women, reduce out-of-state enrollment in anti-abortion states, disrupt medical school training, encourage qualified faculty to discontinue their employment in anti-abortion states, and enable innumerable troubling effects on institutions of higher education, according to the Brookings Institute; and

**Whereas:** It is the duty of the Student Senate to defend the rights and wellbeing of students with or without uteruses at Florida State University; and

**Whereas:** Although the Student Senate cannot directly introduce legislation on a state or national level to alleviate the concerns that have resulted from recently proposed legislation and

court decisions, it can address the issues and urge lawmakers to consider the implications of their actions, in order to best represent the Florida State University Student Body; therefore

**Be it resolved by the Seventy-fifth Student Senate at Florida State University that:** The Florida State University Student Senate condemns Senate Bill 300, "Pregnancy and Parenting Support", in the highest possible terms; and

**Be it further resolved that:** The Student Senate stands with all students affected by this legislation and will continue to provide support to best ensure that the wellness of the Student Body remains in tact; and

**Be it further resolved that:** The Student Senate encourages Florida legislators and courts to review the Florida Constitution, which makes Senate Bill 300 illegal and an inherent violation of the privacy of Florida citizens and residents; and

**Be it further resolved that:** The Student Senate, as the elected representatives of the Student Body, reminds the Florida legislature that they represent and serve their constituents, and that the 30,000 voters who are students at Florida State University stand against Senate Bill 300, and to consider the alarming ramifications of this legislation during voting; and
