Statute/Amendment Text

- G. All events must be publicly advertised via either a flyer, social media, chalking campus, etc. RSOs must submit an estimate of the number of FSU students who may are likely to attend the event.
 - 1. The Committee shall not fund for events which are likely to only have group members attend and have no general benefit to the student body.
 - 2. The Committee shall not fund for events which are exclusive to a club or organization's executive board. This rule may be waived by a threefourth (3/4) vote of the committee.
 - 3. <u>Organizations shall not be funded more than \$500.00 per person per trip.</u>

Whereas: The Naming Ad-Hoc Committee is the only ad hoc committee specifically outlined in the Rules of Procedure, and

Whereas: Senators, Agency leaders, and other RSO leaders are required to go through extensive and complex procedures for any renaming under the current Rules of Procedure, and

Whereas: The Naming Ad-Hoc Committee primarily focuses on detailing the procedure for community outreach, which is already implicit in the role of Student Senators, and

Whereas: The current procedure of the naming ad hoc requires at least two pieces of legislation to be submitted as part of any relevant decision,

Be it resolved by the Seventy-second Student Senate at Florida State University that: The following rules be amended as follows:

10.17 Senate Naming Procedure: Any Senator may, at any time during New Business, make a motion to create a Naming ad hoc committee <u>for</u> the name for any Senate title, award, or recognition, any title of an SGA Office, Agency, Bureau, or Affiliated project, and any other entity outlined in Student Body Statutes. For the motion to be accepted, <u>ten senators</u> <u>ten percent of senators</u> must stand in support of the formation of a naming committee. A committee will be formed, on which, at least, one representative from each of the standing committees must be part of the ad hoc committee.

The committee must:

- a. The Senate President will appoint a chair who must notify invite all relevant parties to each meeting and communicate any significant decisions made by the committee to those parties. The relevant parties will be determined by the committee. agency and bureau directors of an ongoing naming process. The chair must encourage them to invite their members and affiliates to offer input to the committee. The chair will also share the naming meeting time, location, and minutes with all agency and bureau directors.
- b. Gather student feedback. Student feedback can come from the agencies, bureaus, and/or campus wide surveys, social media posts, or other outlets of expression. A real and concerted effort to collect student feedback must be proven and provided as part of any name change related legislation. Any legislation should be sponsored by members of the committee. and retained as part of the documents submitted with the final legislation.
- c. Present a resolution for the proposed name change to Rules and Calendar, where the committee must include student input, student survey feedback, articles, interviews, awards 29 and accolades, (if applicable) regarding the subject that is in question.
- d. Pending approval in Rules and Calendar, the resolution of the proposed award name change will be forwarded to senate as a whole for a vote.

Whereas: Power Based Personal Violence (PBPV) is defined as "a form of violence that has a primary motivator: assertion of power, control and/or intimidation in order to harm another", and

Whereas: PBPV includes relationship/partner violence, rape/sexual assault, stalking, and other uses of force, threat, intimidation, or harassment of an individual, and

Whereas: According to GreenDot, 6.8% of FSU students reported experiencing sexual violence. While 20% of FSU students experience dating violence and 11.5% of students report experience stalking since Fall 2016, and

Whereas: Statistics and data revolving PBPV will never be 100% accurate given that survivors of PBPV do not always report, and

Whereas: PBPV effects FSU students every day and these survivors of PBPV deal with the repercussions of this violence indefinitely, and

Whereas: Such effects of PBPV that survivors face includes depression, flashbacks, PTSD, a sense of hopelessness and isolation, and

Be it resolved by the Seventy-second Student Senate at Florida State University that: commends the strength and character of the 135 survivors of sexual battery, the 89 survivors of relationship violence, the 36 survivors of stalking, 108 survivors of other sexual misconduct and PBPV since May 2019. As well as commend the strength and character of the countless others who did not report.
