

- Bill 39, Sponsored by Senators Diaz and Kariher (P): Defines the scope and purpose of the A&S Fee Reserve account, re-establishes a mandatory threshold for said account, and removes all references to Central Reserves processes.
- **Bill 40, Sponsored by Senator White (P):** To update statues pertaining to amendments for the Finance Committee meetings.
- **Bill 42, Sponsored by Senator Bettley (P):** To remove the Advisory Cabinet from Student Body Statutes.
- Bill 43, Sponsored by Senator Dale (P): Wording change to clarify the role of the
 executive branch. The previous wording was unclear and not reflective of the actual
 structure of the Executive Branch.

Statute/Amendment Text: See attached



Chapter 205 Code of Ethics

205.3 Standards of Conduct

2. No officer or employee will judge or vote on any matter that would affect private gain. No Executive Board member of an SGA funded organization may vote within a funding committee of Senate on an allocation to the organization in which that member serves as an Executive Board member which requires Student Senate confirmation. This restriction will not apply to that members' vote on the final annual budget, or sweepings, or central reserves.

Chapter 309 The Executive Projects Account

C. Funding

The account may be replenished by the annual budget, central reserves, sweepings, or by transfer from any other account.

Chapter 400 Organization of the Senate

400.7 Senate Committee

D. Senators may also serve on Sweepings and Central Reserves

Committees in addition to membership on other committees.

Chapter 401 Forms of Legislation

401.3 Omnibus Bills

B. If a bill covers three or more statutory titles, as defined in Title I, or provides funding for multiple organizations, it shall be defined as an Omnibus Bill. A two thirds (2/3) vote is required for final passage of an Omnibus Bill. The annual budget, and sweepings, and central reserves bills shall not be considered to be Omnibus bills.

Chapter 411 Senator's Committee Rights

- C. Neither Section 411 A nor B applies to the Rules and Calendar, Sweepings, or Supplemental Funding, or Central Reserves Committee.
- 411.2 The Central Reserves and Sweepings Committees are is a special standing committees that shall exist for a particular session until their its respective duties have been completed.

Chapter 412 Sweepings Regulations Act of 1995

412.2 In all cases where monies in the excess of five thousand dollars are released from the Central Reserves to Senate, excluding Sweepings, the

same procedures described in 412.1, shall be used to determine how this money will be allocated, with the following exceptions.

- A. The Student Body President shall not have a line-item veto on such allocation. However, the Student Body President and Student Body Vice President shall be members on this committee.
- B. The committee shall be permitted to meet as long as needed and may be called into existence at any time by the Student Senate President, or majority vote of the Student Senate.

Chapter 413 Senate Awards

413.7 Spring Awards

D. The Artes Award (Chair of the Year) - The best Chair of the Resource for Travel Allocation Committee (RTAC) Programming Allocation Committee (PAC) and Standing Committee Chairs (other than Rules and Calendar, Central Reserves and Sweepings). The Senator awarded the Artes Award demonstrates exception working their communities and has excelled in skill while chairing the committee.

Chapter 418 The Senate Projects Account

418.4 Funding

A. The account may be replenished by the annual budget, central reserves, sweepings, or by transfer from any other account.

Chapter 420 Major Legislation

420.1 Definition major Legislation

Major legislation shall include the Budget Bill, the Sweepings Bill, the Central Reserves Bill, and the Legislative Agenda Resolution. The Senate President has the authority to determine if any other bill, resolution, or allocation shall be deemed major legislation.

Chapter 607 Congress of Graduate Students

607.1

- G. Duties and Responsibilities of COGS
 - 8. COGS will be offered a non-voting ex-officio seat on all Student Senate Budget Committees, budget sub committees, Central Reserves Committee, and Sweepings Committee.

Chapter 803 SGA Budgetary Categories & Categorical Restrictions

803.5 The OPS Wages Category

A. Wages may only be drawn from this account in the manner explicitly stated by the Student Senate in the proviso language of the annual budget (or the Sweepings or Central Reserves proviso). Money may not be redistributed within the category except as stipulated in 803.5 B.

803.9 The Other Capital Outlay (OCO) Category

A. All money budgeted to the OCO category in the annual Budget, and Sweepings, and Central Reserves bills must have attached proviso language explicitly stating the purpose of the funds. All appropriations from Senate Projects into this category must be preceded by a resolution explicitly stating the purpose of the funds.

Chapter 808 Operation Procedures

808.9 Sports Club Distribution Council

D. Specific Guidelines

 No allocations shall transpire without the approval of the specific allocations via resolution of the Student Senate. This shall exclude allocations from Central Reserves.

Chapter 809 Policy on Reserve Accounts Replacement & Renovation Accounts

- 809 .7 The A&S Reserve will be utilized for cash flow needs, enrollment shortfalls, and budgetary emergencies. A Senate bill will be required to release funds from this account.
- 809.8 The A&S Reserve shall be maintained at a level of five-hundred thousand (\$500.000).
- 809.9 The required contribution into this account will be the first priority on A&S dollars.

Chapter 810 Forms pertaining to Funding Boards shall be jointly determined by the Senate President and SGA Director of Student Affairs. Activity & Service (A&S) Fee Management and Reserve Account

- 810 .1 The Office of the Vice President for Student Affairs (OVPSA), shall maintain an A&S Reserve account that shall be maintained at fifteen (15) percent of the annual A&S budget passed by Student Senate.
 - A. All A&S Fees held in excess of the mandatory level at the end of each fiscal year, shall be allocated in the annual A&S budget for the following fiscal year pursuant to Chapter 416.
 - B. The OVPSA must receive Senate approval to hold more than more than mandatory level.

- 1. The Chair of the Budget committee shall present the request in the form of a resolution and shall require a two-thirds (2/3) vote of the Senate.
- 810.2 The A&S Reserve account will be utilized for cash flow needs, enrollment shortfalls, and budgetary emergencies. Funds released for these purposes shall require authorization via a Senate bill.
- 810.3 The required contribution into the A&S Reserve account to maintain its mandatory level will be the first priority of A&S dollars.
- 810.4 All A&S Fees collected in excess of the annual A&S budget passed by

 Student Senate shall be allocated by the annual A&S budget for the following
 fiscal year.

Statute/Amendment Text The information obtained at the committee meeting will be complied into a resolution by the committee Chair. This resolution will be presented at the next possible Senate Finance Committee meeting, and shall be discussed, debated, and voted on in compliance with the committee's rules of procedure. In order for an amendment to pass there must be a two-thirds (2/3) vote of the Senate Finance Committee. An amendment to the resolution **may** not **be found friendly or unfriendly and** must be debated <u>if objected too or found unfriendly</u> with a period of questions and pro/con debate subject to the committee's rule of procedures. <u>If found unfriendly an amendment would require a two thirds (2/3) vote of the Senate Finance Committee to pass. Thereafter, the resolution shall be forwarded to the Student Senate, and placed on the Consent Calendar.</u>

Statute Number(s): 301

Statute/Amendment Text (please copy below from Word version on Statutes)

301.1

A. Authority

In accordance with the Student Body Constitution, there shall be a cabinet in the Executive Branch to assist the constitutional officers in the execution of their duties. The Constitution delegates the authority to define the positions and their duties to Statutes.

B. Purpose

The purpose of this chapter is to define and outline the structure of the Executive Cabinet.

C. Composition

The Executive Cabinet shall be composed of the Executive Office of the President, and the Advisory Cabinet. Only members of the Executive Office of the President shall be considered under the "cabinet officers" mantle of major offices.

301.2 Definition

A. The Executive Office of the President: the vehicle through which the Student Body President and Vice President execute their constitutional powers and carry out their

administration's programs, projects, and agenda.

B. The Advisory Cabinet: the group that shall exist for the purposes of coordination among executive branch groups, projects, and offices, and to provide information and assistance to the Student Body President and Vice President.

301.3 Authority and duties of the Executive Office of the President

The Executive Office derives its authority from the Student Body President and has no authorization, power, or authority to act unless specifically granted by the Student Body President or Vice President. It shall not have the authority to pass resolutions or acts.

The Executive Office of the President shall have the following duties:

- A. Assist the Student Body President and Vice President in the execution of the plan for the Executive Branch.
- B. Represent segments of student body quality of life in accordance with the structure issued by the Student Body President.
- C. Fulfill the obligations of the job descriptions for each office.
- D. Work for the improved quality of life of the student body.
- E. The Executive Office of the President shall meet on a regular basis no less than once every two weeks during the fall, spring, and summer semesters. Minutes of these meetings will be recorded and kept on record.

301.4 Membership

The Chief of Staff who is appointed by the Student Body President and is subject to Student Senate confirmation, directs the activities of the Executive Office, and is subject to the will of the Student Body President.

The Student Body President has sole power of appointment within the Executive Office and may dismiss any individual serving under them at their discretion.

- 301.5 Organization and appointments of the Executive Office of the President
 - A. The Student Body President may organize the Executive Office as deemed necessary and proper within the limits imposed by the Student Body Statutes.

- B. If a new Executive Office of the President position is created, the Student Body President must notify, in writing, the Student Senate of its creation.
- C. Within two (2) weeks of inauguration, the Student Body President, in consultation with the Student Body Vice President, shall address the Student Senate and present the plan for the organization of the Executive Office of the President. Each position, whether created near the inauguration or later in the term, must have a title and a description not totaling fewer than fifty (50) words detailing the responsibilities and privileges of the position. Such a plan must be published on the Student Government Association Website.
- D. All members of the Executive Office of the President must be confirmed by the Student Senate as "Cabinet Offices" and major level positions within the Executive Branch.
- 301.6 Composition of the Advisory Cabinet

The Advisory Cabinet shall be composed of ex-officio members including:

- A. Agency, Bureau, and Affiliated Project Directors or Assistant Directors to serve in the absence of the Directors.
- B. The Senior Class Council
- C. Any student organization by the Student Body President, provided written notice is given to the Student Senate President.
- 301.7 Advisory Cabinet duties and restrictions
 - A. The Advisory Cabinet shall not be permitted to pass binding resolutions or legislation.
 - B. The Advisory Cabinet shall advise the Student Body President and Vice President on general matters and assist in the coordination of the Executive Branch.
 - C. The Advisory Cabinet shall meet as deemed necessary by the Student Body President to discuss activities and events of the Executive Branch for the purpose of increasing the amount and level of cooperation and interdependency and reducing duplication and wasted effort.

- D. The Advisory Cabinet shall pool wisdom and experience of its members to suggest to the Student Body President and Vice President methods to reduce waste in material and time as well as to ensure the greatest impact for Executive Branch projects.
- E. When directed, the Advisory Council may assist the Executive Office of the President.
- F. When necessary, the Student Body President may hold a meeting of just agency directors or bureau directors or affiliated projects. However, meetings of the entire Advisory Cabinet are preferable to individual meetings and must occur as necessary.

Statute/Amendment Text

706.10 Black Student Union

A. Elections shall be carried out subject to the provision of Chapter 1003.3.

1003.3 Board of Directors

A. Membership

The Board of Directors, hereinafter collectively referred to as "Board", shall consist of chairs and co-chairs of respective BSU committees, of which four (4) shall be elected officers of the BSU, hereinafter referred to as "officers", and shall consist of staff which includes the house manager, or any other positions created by the elected BSU officials.

- **B.** Term of Office and Elections
- 1. BSU elections shall be run in accordance with Title VII of the SGA Student Body Statutes with the exception of the rules of procedure outlined in 1003.3 B (3) and 1003.3 B (6).
 - a. For the purpose of BSU elections, an academic week shall be defined as a calendar week during a semester in which classes are in session.
 - 2. The BSU shall have four (4) elected officers. The elections shall take place

the first Wednesday in April each year. Following the election, elected officers shall officially take office the first week of the summer A semester. The elected members of BSU (whose roles are defined in this chapter) are the Director (President), Vice President, Secretary, and Treasurer.

- a. If the date of elections is a religious holiday, it shall be moved one (1) week by the Supervisor of Elections. This must be done prior to the filing deadline. i. If the Elections are moved, the Supervisor of Elections shallinform the President of the Black Student Union, the Student Body President, the Senate President, and the Speaker of the Congress of Graduate Students no less than two weeks prior to the new date of the elections or the original date of elections, whichever is earliest. REVISED/UPDATED — January 2022193
 - b. The date of the election shall not be set in any manner other than described in this chapter. This election shall be advertised as described in Chapter 702.
- 3. The Black Student Union election shall follow the rules and procedure as outlined in Title VII, with the exception of the declaration of candidacy and party registration, which are outlined in 1003.3 B (5).
- 4. Campaigning is prohibited before 12:00 a.m. on the Wednesday that is one week prior to the date of the elections.
- 5. BSU political parties must register with the Office of Elections as an SGA political party per Chapter 704. All candidates for office shall submit their declaration of candidacy with the Supervisor of Elections no later than 4:00 p.m. on Wednesday, two weeks before the election.
- No Recognized Student Organization receiving A&S Fees shall supportor endorse an independent candidate or political party.
- 7. The Supervisor of Elections shall organize a debate pursuant to Chapter 702 during the academic week of campaigning, where all candidates seeking office shall be given fair and equal time to debate and answer questions from the electorate. The Supervisor of Elections shall have the sole discretion to determine which questions will be asked.
- 8. The following shall constitute a Schedule 2 Violation, as outlined in Chapter 715.7, with penalties, as outlined in Chapter 716.3:
 - a. Campaigning prior to the academic week of campaigning.
- 9. The BSU officers shall select the committee chairs and co-chairs of the Board by three-fourths (3/4) majority vote. The committee chairs and cochairs shall take office the first week of the summer session and shall serve a one (1) year term.

A. Term of Office

 The Black Student Union President, Vice-President, Secretary, and Treasurer shall each serve a one-year term. The President, Vice-President, Secretary, and Treasurer's term of office shall take effect one week after appointment, and end one week after confirmation of the new President, Vice-President, Secretary, and

- Treasurer the following year, notwithstanding extensions as may be required by the Student Body Constitution.
- 2. The term of office for the Board members shall be one year. President, Vice-President, Secretary, and Treasurer shall not be limited to the number of terms they may serve. After their year term, to be reappointed, they must go through the initial procedures.

- 15. SGA General Counsels
- 16. Clerk of the Court
- 17. Supervisor of Elections
- 18. Deputy Supervisors of Elections
- 19. President, Vice President, Treasurer, and Secretary of the Senior Class Council
- 20. Homecoming Director, Assistant Director, and Homecoming Live Director
- 21. Any elected or appointed office which receives OPS Wages from Student Government.

Whereas: In October of 2022, the City of Tallahassee Commission proposed an ordinance change for the City of Tallahassee that would amend sections 12-93, 12-94, and 12-96 of the Code of General Ordinances; and

Whereas: The proposed changes to the City Ordinances would allow Tallahassee Police personnel to take necessary precautions to restrict audible noise from select establishments after the hour of 11:00PM on Sunday through Thursday, and 12:00AM on Friday through Saturday, regardless of circumstance; and

Whereas: The language of the amendment reads: "to restrict outdoor amplified sound which is plainly audible 200 feet from the establishment"; and,

Whereas: The city of Tallahassee is home to three educational institutions, making the city the home of over 54,000 college and university students; and

Whereas: The proposed amendments to the City of Tallahassee Code of General Ordinances would heavily limit and restrict the operations of several bars, clubs, and restaurants ("nightlife") in the City of Tallahassee, as confirmed by the personal accounts of several employees and managers of these establishments; and

Whereas: Tallahassee nightlife establishments employ almost exclusively FSU students, helping many students pay for tuition, and other necessary personal expenses; and

Whereas: Florida State University is home to 54 total fraternities and sororities, whose operations would also be limited and restricted by the proposed amendments to the City of Tallahassee General Ordinances, as confirmed by the personal accounts of several members of these esteemed organizations; and

Whereas: These Greek organizations regularly contribute to the betterment of the City of Tallahassee through support of both local and national philanthropic efforts, city cleanups, community engagement, social advocacy, and much more; and

Whereas: The area designated by the city code as the "Urban Core" is an area that a significant portion of FSU students live, as well as an area with many Greek houses and nightlife establishments; and

Whereas: The City of Tallahassee and Florida State University reap large economic benefits from their reputations of being home to some of the largest and most prominent Greek organizations and nightlife establishments in the nation, contributing to both tourism and a large student population; therefore

Be it resolved by the Seventy-fifth Student Senate at Florida State University that: The FSU Student Senate is sympathetic to the negative aspects that the proposed changes to the Tallahassee City Ordinances for noise would have on FSU's Greek organizations, Tallahassee's nightlife, and the FSU student body as a whole; and

Whereas: There are several amendments that could be made to the Senate Rules of Procedure to update the document with current practice and procedures that are more efficient, and

Whereas: Student Body Statute §401.1 states, "Changes to the Rules of Procedure must be done through resolution and adopted by a two-thirds (2/3) vote of the Senate," therefore

Be it resolved by the Seventy-fifth Student Senate at Florida State University that: As a result of Bill 10 passed by the 75th Student Senate, which replaces the role of PAC and RTAC liaisons with newly created elected PAC and RTAC vice chair positions, and being that there is no procedure for when the Senate President Pro Tempore has to relinquish the chair, the Student Senate Rules of Procedure be amended as follows:

- 7.1 Composition: The Student Senate President, Student Senate Pro Tempore, the Chairs of each of the standing committees outlined in Rules Six, and the chairs of the Senate Funds Distribution Committees outlined in Rule 5. The Student Senate President Pro Tempore shall serve as the Chair of this committee. The chairs of PAC and RTAC shall only appoint their liaisons in their absence.
 - a. In the event a Chair of the standing a committee is unable to attend a Rules committee meeting due to an excused reason, they may designate their vice chair to serve in their place for that meeting upon submitting a written declaration to the Student Senate President Pro Tempore.
 - b. In the event a Chair and vice chair of a <u>standing</u> committee <u>is</u> are unable to attend a Rules meeting due to excused reasons, the Chair may designate another member of that committee to serve in their place for that meeting upon submitting a written declaration to the Student Senate President Pro Tempore.
 - c. The Student Senate President may temporarily preside over the Rules committee in the absence or request of the Student Senate President Pro Tempore.

Be it further resolved that: As a result of Bill 39 passed by the 75th Student Senate, which removes the Central Reserves committee from Student Body Statutes, the Student Senate Rules of Procedure be amended as follows:

The Sweepings and Central Reserves Committees shall be <u>a</u> special standing committees and defined in, and subject to, the limitations of Chapters 411 and 412 of the Student Body Statutes. These <u>This</u> committees shall not be considered <u>a</u> standing committees for the purpose of comprising the Rules Committee.

Be it further resolved that: Because it has not been recent precedent that students wishing to provide public comment must fill out "request to address" cards, and being that there is currently not a Senate emailing list, the Student Senate Rules of Procedure be amended as follows:

- 8.11 <u>At their discretion, the Student Senate President may request that Any</u> students wishing to speak during the Student and RSO Comments section of the agenda must fill out a "Request to Address" card.
- 8.12 Any senator wishing to announce upcoming Agency, Bureau, and RSO events during the Closing Announcement section of the agenda may fill out an "upcoming events" card to be put on the Senate emailing list.
- **8.13 8.12** The Special Introductions portion of Senate meetings shall be reserved time where guests invited at the discretion of the Student Senate President may address the Senate. Any Senator may move for other speakers to be permitted, subject to a majority vote. This motion shall be debatable.

Be it further resolved that: The Student Senate Rules of Procedure be amended as follows to update the "committee reports" language to say "committee minutes":

- **Committee** Minutes Reports: Each committee shall compile and publish Committee minutes following each meeting. file written reports. Committee reports minutes must be filed with the Senate Advisor and Webmaster no later than noon of the day of the next Senate meeting. Reports of a committee meeting/activity Such minutes shall include:
 - a. Member attendance list
 - **b.** Amendments to measures before the committee and votes on those amendments including voting position by member.
 - **c.** Final votes on measures.
 - **d.** Pertinent discussion the committee feels should be brought to the attention of the Senate.
 - **e.** The date and time of the meeting and the date and time of the next meeting.

Be it further resolved that: To reduce redundancy surrounding the powers of the Senate President to appoint a temporary presiding officer to chair Senate meetings, the Student Senate Rules of Procedure is amended as follows:

- 2.2 The President shall be the presiding officer of the Student Senate, except when they choose to temporarily relinquish the chair. In such cases, the <u>Student Senate President Pro Tempore shall assume the chair, unless the President president shall have the authority to appoints another any senator to assume the chair temporarily, and preside over the Senate.</u>
 - a. The President shall not designate a senator as temporary chair if said senator has participated in the debate of a question or measure still before the body. The President, once they have relinquished the chair to debate, shall not resume the chair until the question before the body has been resolved.
 - b. When not holding the chair or presiding over the Senate, the President shall retain all the rights, privileges, and responsibilities of any other Senator.
 - Other than the Student Senate Pro Tempore and cases arising out of Rule 1.7, any Senator who temporarily assumes the chair shall only have the authority to preside over meetings.
- 2.10 The Student Senate President shall be the presiding officer of the Student Senate except when they choose to temporarily relinquish the chair. In such cases the Student Senate President Pro Tempore shall assume the chair, or appoint another senator, the Student Senate President shall have the authority to appoint any senator to temporarily assume the chair, and preside over the Senate.
 - a. When not holding the chair or presiding over the Senate, the Student Senate President shall retain all the rights, privileges and responsibilities of any other Senator.
 - b. Other than the Student Senate Pro Tempore and cases arising out of Rule 1.7, any Senator who temporarily assumes the chair shall only have the authority to preside over meetings.
 - c. The Student Senate President shall not designate a senator as temporary chair if said senator has participated in the debate of a question or measure still before the body. The Student Senate President, if they have relinquished the chair to debate, shall not resume the chair until the question before the body has been resolved. The Student Senate President shall retain the authority to reassume the chair at any other time.
- 2.11 2.10 The Student Senate President and Press Secretary shall be the administrators of any official social media account(s) of the Legislative Branch and can appoint this power to any designee. All social media pages must be kept on the lowest privacy levels and must be open for all to view read. The Senate President or designee shall be responsible for creating a Monthly Newsletter including events funded by Student Senate.

Be it further resolved that: To clarify procedures surrounding the Senate President's power to recess Senate meetings, the Student Senate Rules of Procedure be amended as follows:

8.14 The presiding officer may call for the Senate to recess for a specified amount of time. This action shall require a majority vote if objected to by any senator. Any Senator may also make a non-debatable motion to recess, which shall require a second, and a majority vote for passage if objected to. The presiding officer shall call the meeting to order at the expiration of the time specified in such a motion.

Be it further resolved that: To clarify procedures surrounding how Senate meetings are adjourned, the Student Senate Rules of Procedure be amended as follows:

8.15 Upon the completion of all items on the Senate's Calendar, the presiding officer shall entertain a motion to adjourn the meeting, which shall require a second and a majority vote for passage if objected to.

Whereas: The Student Senate acknowledges that each victim of gun violence is a human being, a functioning member of society, and a loved family member, and the impact they left on this world will not be forgotten nor will their death be in vain, and

Whereas: The Seventy Fifth Student Senate at the Florida State University recognizes the lives lost in this horrific tragedy: Evelyn Dieckhaus, 9; Hallie Scruggs, 9; William Kinney, 9; Katherine Koonce, 60; Mike Hill, 61; and Cindy "CiCi" Peak, 61, and

Whereas: The Student Senate recognizes that the mental health of many students at Florida State University and across the nation may be severely impacted by this senseless tragedy, therefore

Whereas: Since 1965, global production of sugar cane has quadrupled in scale, with two billion metric tons of the crop being produced in recent years; and

Whereas: Harvesting sugar cane can be difficult due to the buildup of dried leaves at the base of the sugar cane crop, which accumulates over the course of the season; and

Whereas: Sugar cane producers across the state of Florida resort to the burning of this leafy material to simplify the farming process, leading to several issues in Floridian communities; and

Whereas: This "sugar cane burning" releases harmful particulate matter into the air, which pollutes the Florida environment, rivalling even the amount of pollution created by automobiles, with research done by Florida State University finding that sugarcane fires resulted in 5,100 metric tons of this particulate matter every year, whereas on-road motor vehicles in Florida emitted about 6,100 metric tons every year; and

Whereas: Sugar cane burning has also been linked to environmental racism, with marginalized communities being disproportionately affected by the burns, due to the proximity of many of these communities to the burn sites and there being many more active burn permits in these historically marginalized communities than in other parts of the state and area; and

Whereas: The particles produced by sugar cane burning negatively affects the life of all residents in Florida, with the matter being linked to respiratory issues and exacerbating conditions such as asthma and bronchitis, and directly leading to an estimated three deaths per year; and

Whereas: There are many tried and tested alternatives to sugar cane burning, such as "green harvesting", which involves cutting sugar cane while it is still green for immediate processing, in order to preserve the soil and air quality of our great state, among other methods; and

Whereas: Even though Florida's cane sugar industry is the largest in the nation, producing a two billion dollar economic impact to the state, the burning process leading to pollution and long-term environmental damage, and disadvantaging already-marginalized communities, despite there being safer and more environmentally-friendly alternatives, is a willful neglect of the corporate responsibility to public wellbeing; therefore

Be it resolved by the Seventy-fifth Student Senate at Florida State University that: The Seventy-fifth Student Senate opposes the practice of sugar cane burning, and urges sugar cane producers in Florida and the Florida government to explore other options to replace this outdated practice.
