100.1 Major Offices

A. Definitions

- 1. Director The chief executive of an entity.
- Assistant Director The individual who would assume the role of the chief executive of an entity in the absence of the chief executive.
- 3. Treasurer The individual in charge of monitoring the finances of an entity.
- 4. Secretary The individual in charge of taking minutes at board meetings of an entity.
- B. The definitions listed in this statute shall include any positions which fit the criteria of the definition.

603.2 PCC Student Elections

A. Franchise

- 1. All students enrolled at PCC are eligible to vote in the semi-annual PCCSGC elections. Students enrolled at the main campus are ineligible vote in the semi-annual PCC-SGC elections.
- 2. All students enrolled at PCC are eligible to vote in FSU-SGA Presidential, and Vice Presidential, and Treasurer elections and/or on Amendments to the Student Body Constitution, in the manner outlined by the FSU-SGA Supervisor of Elections in accordance with Chapter 700 of Student Body Statutes. either by absentee ballot or by vote at a poll established at PCC by FSU-SGA. All sealed absentee ballots are to be delivered to the Commissioner of Elections by the day of voting at the Tallahassee campus.

803 Transfer Requirements

A. SGA branches, offices, agencies, bureaus, and affiliated projects, and recognized student organizations which are allocated A&S monies may only transfer A&S money between budgetary categories through the passage of a legislative bill. Such transfers shall also require the consent of the Director or chief executive of the entity within which the funds are being transferred.

The Treasurer shall:

- A. Provide information and support to any organization, executive agency, bureau and funding board.
- B. Meet monthly with the director or financial officer of executive agencies, affiliated projects, bureaus, and funding boards individually to turn in monthly expenditure statements for review, address questions and/or concerns, and discuss upcoming funding opportunities.
- C. Review all A&S expenditures made by executive agencies, bureaus, student organizations (with the exception of COGS) and funding boards before the expenditures are submitted to the SGA Business Manager of SGA Accounting.
- D. Have forty-eight (48) hours to approve or reject any expenditure. After forty-eight (48) hours, the expenditure may be considered without approval of the Student Body Treasurer.
- E. Reject any expenditure; must have the approval and signature of the Student Body President.
- F. Assist all entities within the Executive Branch in the development of effective resource management techniques.
- G. Assist all entities within the Executive Branch with the correction of financial problems and developing techniques to avoid further financial problems.
- H. Assist the President in preparing the budget of the Executive Branch ensuring accuracy, transparency, and alignment with the goals and priorities of the student body.
- I. Defend the Executive Branch budget in meetings or discussions with relevant stakeholders, including university administration, funding boards, and external entities.
- H. Review the financial manual periodically and provide official recommendations for any necessary reforms or updates to ensure compliance with applicable regulations, enhance financial management practices, and promote transparency and accountability within the Executive Branch.
- K. Review the finance code in student body statutes and provide official recommendations to the student body Senate for any necessary reforms
- L. Represent the Executive Branch in financial discussions, meetings, or negotiations with external entities, such as RSOs. This includes advocating for the financial interests and needs of the student body, seeking additional funding opportunities, and collaborating with external organizations or institutions on matters related to the financial well-being of the Executive Branch.

- d. Review Senate Funds Distribution Committee consent resolutions, approve or disapprove nominations to the Funds Distribution Committees, and inform the Senate of any relevant actions.
- e. Forward or deny all **nominations for** agency, bureau, and affiliated project nominees for financial officers, **excluding Executive Cabinet officers**.

Whereas: Florida State University is respected nationwide for being a leading research university. Florida State University offers students the chance to participate in research with the Center for Research and Engagement, and offers underclassmen the ability to be a part of the Undergraduate Research Opportunities Program, and,

Whereas: Florida State University's National High Magnetic Field Laboratory, the Los Alamos National Laboratory, and University of Florida are home to the strongest magnet in the world, is the only one of its kind in the Western Hemisphere and one of only a dozen such facilities in the world, and consistently provides unmatched research opportunities for students in condensed matter physics, geochemistry, and cryogenic physics, and,

Whereas: Florida State University has over 750 Recognized Student Organizations, over 40 Fraternity and Sorority chapters, 7 identity-based agencies, a thriving Student Government Association, and a consistently ranked top 20 best athletics program, on campus for students to explore, participate in and find a community in, and,

Whereas: Florida State University's football program has won three national championships, eighteen conference titles and six division titles, has sent 293 players to the NFL, including 46 first-round picks, has had three Heisman trophy winning players, and,

Whereas: On June 6th, 2023, the Human Rights Campaign officially declared a state of emergency for LGBTQ+ individuals in the United States following what it deems an unprecedented and dangerous spike in anti-LGBTQIA+ legislation, and

Whereas: The Human Rights Campaign notes that 2023 has been a record-breaking year for anti-LGBTQIA+ legislation, as over 525 anti-LGBTQIA+ bills were introduced in 41 states, with 76 of those being signed into law as of June 5th, 2023, and

Whereas: The organization furthers that as of May 2023, the Florida legislature has passed six laws deemed anti-LGBTQIA+, more than the last seven years combined, and

Whereas: With the growing number of anti-LGBTQIA+ laws, students across the country have expressed that they feel unsafe and unrepresented in schools through petition, protest, and other avenues, and

Whereas: The Pride Student Union, located on the third floor of the FSU Student Union, stands to advocate for LGBTQIA+ rights on campus, and has expressed the worry of LGBTQIA+ people at FSU and their ability to stay safe on campus, therefore

Be it resolved by the Seventy-fifth Student Senate at Florida State University that: The Student Senate condemns these legislative attacks against LGBTQIA+ individuals across the United States, acknowledging their impact on members of our own University's student body, and
