**WHEREAS:** Goal of IV of the Florida State University Strategic plan states that the Florida State University Will strive to ensure student success in Tallahassee and beyond, and

**WHEREAS:** The Florida State University provided funding for the Appleton Museum of Art from 1990 – 2004, and

**WHEREAS:** The Appleton Museum of Art provides fine art and culture to the city of Ocala, as well as to the students of the College of Central Florida, and

**WHEREAS:** Florida governor Rick Scott vetoed a \$1.5 million budget line item adversely affecting the museum's ability to remain a going concern, therefore

**BE IT RESOLVED BY THE SIXTY NINTH STUDENT SENATE AT THE FORIDA STATE UNIVERITY THAT:**

We recommend that Governor Rick Scott reconsider the \$1.5 million budget veto to the Appleton Museum of Art.
