**Purpose & Description:** To remove the rule that requires a student Senator to have served two years or more in the Senate as a criterion upon which a student Senator may be awarded membership in the Senate Hall of Fame. And, to fix typos.

Statute Number(s): 423.8

#### Statute/Amendment Text:

413.8 The Senate Hall of Fame

History: Added by the 54<sup>th</sup> Senate Bill 64. Revised by the 56<sup>th</sup> Senate Bill 78. Revised by the 60<sup>th</sup> Senate Bill 69. Revised by the 62<sup>nd</sup> Senate Bill 91. Revised by the 72<sup>nd</sup> Student Senate Bill 6A.

Membership in the Senate Hall of Fame is the highest honor a student Senator can achieve. This honor shall be bestowed upon any Senator who has performed their duty as a member of the Senate with the highest standard of excellence, beyond that normally expected of a Senator at the Florida State University.

A. Prospective candidates for this award shall be nominated by the Student Senate in Resolution format. Included in the Resolution should be the name of the Senator to be nominated, the Senate(s) in which the individual served and reasons why the Senator is deserving of this honor. When this resolution is debated on the Senate

Floor, two rounds of pro may be given, but no rounds of con will be permitted. If the Resolution is approved by the Senate, by two-

thirds (2/3) vote, the Senator will be automatically considered a member of the Senate Hall of Fame.

- 1. The Senate shall determine the criterion for selecting the recipients of the award. The following exceptions to this apply:
  - a. Only the Senator's accomplishemnts accomplishments in the Student Senate shall apply.
  - b. Holding a position of Senate leadership shall not be the sole basis for determining if a nominee is qualified.
  - c. Only Senators who have served two years or more in the Senate may be considered, but the length of the Seantor's term, beyond two years, shall not count for or against the nominee.
  - d. <u>except Except</u> for the original members of the Senate Hall of Fame, no person shall be considered for membership following their graduation from Florida State University.
  - e. No more than four (4) Senators shall be inducted in the Hall of Fame per year.
- C. Once a nominee has been selected to be a member of the Senate Hall of Fame, they will be notified in a timely manner as to the award. The Senators placed in the Senate Hall of Fame shall have their names placed on a plaque that will be permanently displayed in the hall outside of the Senate Chamber.

**Be it resolved by the Seventy-Third Student Senate at Florida State University that:** This waiver shall be granted and funds shall be disbursed to use the Executive Projects account to pay for OPS Wages.

**Whereas:** Florida State University students and faculty do not pay additional fees for parking spots in their respective designated lots on campus, and

**Whereas:** The FSU Parking and Transportation Services Website states that "Permits are valid August 15 of the first year through August 15 of the following year for currently enrolled students, faculty, and staff (except Payroll Deduction and Visitor Permits)," and

**Whereas:** Over the course of the past year, parking spots in multiple ground lots and garages around campus have been converted to "Pay to Park" spots, and

**Whereas:** These paid parking spots only benefit those who have the privilege and financial means to pay for "luxury" parking spots rather than the entire student body, and

**Whereas:** The paid parking spots were formerly parking spots in which anyone with a valid corresponding FSU permit could park in, and

**Whereas:** FSU students regularly complain about parking and ask what their SGA representatives can do to fix it, and

Whereas: Multiple constituents have reported that these Pay to Park spots are frequently left unused, and

**Whereas:** If FSU wanted to convert some of the parking spots on campus to a special permit, they could have enhanced campus sustainability initiatives and added charging stations to more garages.

**Be it resolved by the Seventy-third Student Senate at Florida State University that:** we recognize that Pay to Park does absolutely nothing to benefit our constituents.

**Be it further resolved that:** the Seventy-third Student Senate at Florida State University recognizes that this new parking system only adds to systemic issues regarding elitism facing various communities around our campus.

**Be it further resolved that:** the Seventy-third Student Senate at Florida State University thus condemns the conversion of previously free and accessible parking spots to a paid luxury.

**Whereas:** Florida State University has a pre-existing FSU Alert System on multiple platforms including the social media application Twitter, email, mobile SMS, and

Whereas: FSU Alert has historically been used to let students know about incidents on campus such as armed robberies and physical assaults, and

**Whereas:** Our peer universities, namely Auburn University, utilize their "Campus Safety" accounts on widely-used platforms such as Instagram to let students know about reported sexual assaults in on-campus buildings and locations affiliated with campus organizations such as surrounding streets, campus recreation facilities, and fraternity and sorority houses, and

Whereas: Such incidents are reported in a way that protects the identity of the victim and accused perpetrator as legally required, and

Whereas: Students across the country at various institutions are organizing against the systemic nature of hiding sexual assaults on campus and in campus-affiliated locations, and

**Whereas:** In compliance with the Clery Act, all colleges and universities that receive federal funding are required to disclose information regarding crime on OR NEAR and the university's campus, even if the incident is disclosed by a third party, and

Whereas: Florida State University currently interprets this to only include on-campus reports, and

**Whereas:** Peer universities interpret this to include incidents in areas near campus that are explicitly or implicitly affiliated with the university, and

**Whereas:** The Student Senate has installed a Sexual Assault Survivor's Advocacy Ad Hoc Committee in multiple senate sessions, and

**Whereas:** The Torchlight Campus Policy Center published a report about sexual crimes on campus that includes the fact that less than 0.1% percent of students (38 reports) had their reports included in the 2016 Annual Security and Fire Report, and

**Whereas:** The ACHA-NCHA II survey that same year recorded over 10% of participants on college campuses that has experienced non-consensual sexual experiences, and

**Whereas:** It is possible that Florida State University is under-reporting the amount of sexual crimes on campus as a result of not including areas that are off campus but implicitly affiliated with the university due to the nature of the people that visit those areas, and

**Whereas:** Victims can call (850) 644-7161, text (850) 756-4320, email Victims-Advocate@fsu.edu, or call FSUPD at (850) 644-1234 if they are in need of any assistance.

**Be it resolved by the Seventy-third Student Senate at Florida State University that:** FSU Alert should expand its content to alert students about crimes, including sexual assaults, that occur around campus, in addition to those on campus that are currently pushed out.

**Be it further resolved that:** the Student Senate encourages FSU Alert to expand to platforms more regularly used by our students such as Instagram.

**Be it further resolved that:** the Student Senate encourages Florida State University to adopt an interpretation of the Clery Act that includes incidents near campus in areas that FSU students frequently traffic.

**Be it further resolved that:** the Student Senate stands with survivors of power based personal violence on our campus, including those whose stories have gone untold and underreported.

**Be it further resolved that:** the Student Senate encourages students to pressure the university into being transparent with this information such that students are aware of places to avoid.
