BE IT RESOLVED BY THE 69TH STUDENT SENATE AT THE FLORIDA STATE UNIVERSITY THAT:

Rule 7.1 of Senate Rules and Procedures be stricken and replaced with the following:

7.1

Composition: The President Pro Tempore, the Chairs of each of the standing committees outlined in Rule Six, and the Chairs of the Senate Funds Distribution Committees outlined in Rule 5.15. The President Pro Tempore shall serve as Chairperson of the committee.

- a. In the event a Chairperson of a Standing Committee is unable to attend a rules and calendar committee meeting due to an excused reason they may designate their Vice Chair to serve in their place for that meeting upon submitting a written declaration to the Senate President Pro-Tempore.
- b. In the event a Chairperson and Vice-Chair of a Standing Committee is unable to attend a rules and calendar committee meeting due to excused reasons the Chairperson may designate another member of that committee to serve in their place for that meeting upon submitting a written declaration to the Senate President Pro-Tempore.
- c. In the event a Chairperson of a Funds Distribution Committee is unable to attend a rules and calendar committee meeting due to an excused reason they may designate a member of the Senate Finance Committee, excluding the Chair and Vice-Chair, to serve in their place for that meeting upon submitting a written declaration to the Senate President Pro-Tempore.
