## **Committee Business:**

- McCraney likes the information on the housing Excel spreadsheet.
  - Maybe we should consider generating and sharing a survey with grad students, asking them where they live
  - Solmaz-Ratzlaff supports the idea
    - Hussain: We can populate that list and give incoming graduate students more options. For future the list can be shared on the Office of Provost, Graduate Student Resource Center website
- Nord: there is no new information on the transportation. The past chair informed Transportation that Nord/COGS should be CC'd moving forward.
- Ebuara: the plan to consider reviewing data for the potential increase in conference grants may no longer be necessary because Josh (COGS Deputy Speaker of Finance) has proposed an increase in the new budget plan
  - Depending on how the congress votes, we should have a plan on how we want to move forward
  - Ebuara: Since we plan for 1000 applications to benefit from grants, but the most grant applications we have seen are 700, applicants are receiving more money to benefit them more
  - Galeano Cabral: In conversations with the new director of the resource center, they mentioned having 1000\$ for every doctoral student. To receive that money, they must first apply for the COGS conference grant.
    - Applicants can receive grants from both COGS and the Resource Center.
