 - Opening Statement:
 - Hello and thank you to the internal affairs committee for the time in deciding my feasibility to the board of the Office of Governmental Affairs. I want to start at the beginning as my love for politics has been a long standing one. Being raised in the United Kingdom for 14 years I have fond memories of looking at my parent's ballot back when they were the United States when I was a freshman in high school, I found these systems to be wildly different, I really am learning new things about the American governmental process every day. However, this fuels my desire to get involved. Ultimately, I would say I am a strong candidate for the board. Firstly, I have ample experience in the realm of government and politics. This past summer I spent two months in Washington DC on Capitol Hill with the committee on small business. I think this undoubtedly fueled my knowledge for the American political process. This semester I aided my knowledge in Florida politics working with representative Al Lawson and his Tallahassee office. Through that I do case work, talk with constituents and it's really been a fantastic experience. I am also really lucky to be an intern during the midterms which really gives me an inside look into the world of campaign politics as I aid him in the campaign trail. Within FSU specifically, I am a fellow with the institute of politics. In a bipartisan collaboration with other fellows, we created and executed the why we serve initiative where we interviewed representatives and why they got into politics. With OGA, I personally believe it is one of the most important agencies within FSU student government. Much of the project initiatives coined by the senate are really as effective as the capitol support behind them. With that being said I am really looking forward to working in a bipartisan fashion with other board members to craft next year's legislation agenda. - **Candidate for Confirmation:** Brayden Harrell - OGA, Board of Directors
 - Opening Statement:
 - Good evening IA, it is great to be back. For those of you that don't know me my name is Brayden Harrell I served back in summer senate and as Vice Chair of the IA committee. A little bit about me as a rising senior in the college of social science majoring in political science and a minor in economics. I am pursuing a board seat withing the office of governmental affairs. When it comes to my career experience, I have served as a regional representative for a US Senator in four rural counties in which I had to work with constituents, political parties, and other voters to make sure of our messaging and campaign tactics. I also became very knowledgeable about Senator Marco Rubio's policies including his protection plan which was implemented during the Covid-19 crisis. Why is this important in campaigns? Whenever you're pitching something to a voter, you always need to know about the policies that you're representing. The same thing can be said when we are working with constituents here at the student body. So, I intend to use my knowledge on policy to be able to reflect that of the student body here at Florida State. I also ran my own campaign as a campaign manager for a state house race, which was a non-partisan race. That brings an interesting mindset to the table. I have worked with my fellow people in order to get things done. I have worked with different agencies and lobbyist groups to make sure we were getting across the policies we wanted to with my candidate. I have worked with notable black lobbyists here in Tallahassee who is very active within that community, I have also worked with the NRA and organizations such as Young Americans for Liberty. Polar opposite places but we were able to come together and find compromise and that is important when on a campus like Florida State. I want to ensure that everyone has an equitable share in the conversation when we talk about what the office of governmental affairs will do for the student body. As a campaign manager, I became very fluent with Instagram, Facebook, etc. and being able to monitor and manage social media is not an easy task. I also served as the president of my fraternity so I am very familiar with going out into the community and greeting people and having those real conversations. I want to thank Jason, Emma, and Omer and their faith in me.
 - Round of Questioning:
 - **Vice Chair McMahon:** In your application, you talked about examining policies on ANS fees and DEI institutes, can you expand on this?
 - **Candidate Harrell:** So a long standing thing in senate is we want to see ANS fees be reestablished, it has been I think five years since we've seen the state establish new ANS fees. So I want to work with the student body to see what they want and what their needs are. A lot of students don't take advantage of things we

have on campus such as the mental health council, counseling in psychology and services, athletics program. We need to reevaluate not only how students are taking advantage of these things but all these organizations that are receiving money and things like that. So, I want to ensure we are doing all of that. When it comes to DEI, I want to see DEI expanded to a little more into the lives of students. I just attended the Fraternity and Sorority Life converge, where we learned a little bit more about Dei in the Greek community and I want to see students get involved in that. So, we are going to ensure that these things are talked about and this isn't just a sole decision on my part, but a global conversation between senate, the executive branch, and all the people involved.

- **Senator Crocker:** How exactly do you plan to jumpstart those conversations?

- **Candidate Harrell:** As a summer senator, I have a lot of connections in senate. I am going to be very proactive when it comes to serving OGA, not only in an official capacity but as a representative of that. So coordinating with those senators and asking "what do you need to see?" and asking them what their constituents want and need. The role is to being representative of students at all levels of government and I believe even here at the Florida State level. I think working with you guys to make sure things get done in the most fair, equitable way is the best. Starting those conversations is number one. As I stated, I have experience with social media so we can start those conversations there so we can make good, equitable decisions.

I think doing events with organizations that aren't our direct target audience is something I would love to do and I think it would get a lot of great exposure.
- **Senator Anand:** Why OGA? What made you want to apply?
 - **Candidate Hansel:** As I said, I am an advertising major in the College of Communication, so it is very different. I have always loved and had a passion for politics. I love understanding the mindset of everyone when it comes to politics. Being a voice for the students is something I would love to do and having a nonpartisan opinion is important and it is something that interests me much more. Having a non-biased opinion but getting exposure from the student body is something that is super exciting and I can't wait to do it, if confirmed.
- **Senator Schindler:** Reading over your application, I see you want to advocate for the real project, how do you plan to do that in your role?
 - **Candidate Hansel:** For those that don't know what it is, the real project is a project here on campus that gives the student body exposure on not abusing alcohol, which is a problem here on campus. We see it in all aspects of campus, I think it is something super important. I would love to be able to partner with them and having events is important. So gaining exposure and creating opportunity on campus that doesn't have to do with alcohol. This is something I have worked on in my advertising strategy class, working closer with the real project and a middle school in a different county. It has been really rewarding and I would love to bring in and make it bigger on FSU's campus.
