• Consent Resolution #30 Sponsored by Chair Seager

 Opening Statement: Yes, I'm ready. So today you will be hearing me present because that resolution 30 And it is about the American Hellenic educational progressive Association and the real estate society at FSU. So for the American Hellenic education pressive association is here today for \$1,800 in the funding from our tech. Their travel is from November 10 to the 12th and they will be traveling to traveling to Chicago, Illinois. To take part in an event called mainstage. Chicago is our CIO attending this event will allow them to offer will allow them the opportunity to network and meet other individuals from all over the United States, Canada and Greece with similar roots of theirs. This is a great opportunity for this RSO to network and raise money towards their national project this year, which is the Boys and Girls Club for America. They're asking for \$916 in travel expenses for flights \$584 In lodging which is \$292 per night for one room for five students because this hotel allows five students for this hotel room and \$3 for registration fees which is \$30 which is \$60 per person. And then for the real estate society at FSU is asking for \$1,501.72 in the category of lodging. They'll be traveling to Atlanta, Georgia for a corporate tour where they can network with other individuals with careers in real estate and learn about possible job opportunities. For those graduating in the near future. There'll be traveling from November 15 to the 17th. Their original request was \$1,635.56. But with our tax willing budget and SGA statutes limiting our committee to keeping \$40,000 in the budget for next spring. Our tag found it fiscally responsible to allocate the remaining \$1,501.73 to this organization. This comes out to about 170 or \$187.72 per night for four rooms two nights and 16 students I yield the rest of my closing

Senator Hellman- Why is it three like \$360 per student when there's only like the first one only has five travelers but we're funding significantly less for 16 travelers? Yeah, I was doing the math earlier today and they actually came to us.

Chair Seegar- They actually told us that they did drop in students because students backed out the last minute so it was eight people now it's five people, and their original quote was 2006 \$2,600. And just our tacked on is responsible that we had to cut a travel expense because flights are very expensive for these five individuals, that just giving them \$916 for flights was just fair. Again, my case with the only two organizations this week, and we only do have \$3,301.72 left in the account. So we would love to fund this organization as best as possible with as little budget as we have because at the end of the day, if we give organizations you know, 100 bucks here, 100 bucks there, that's not going to help and this would really help this organization out.I would also like preface to that they have I believe it's \$300 in their account. So a lot of this expense will have to come out of their pockets. So I think the best opportunity for us funding them would keep their money in their own pockets. Since we are a committee that gives money for travel expenses.

Senator Gorelick- the lodging request the 584 Is that based off of the cheapest option or do you know like where they're staying?

Chair Seegar- Yes, I actually have their PowerPoint as well. They are staying in the Residence Inn, which is downtown Chicago, which I believe if I look back at my notes, it's one room but it's \$292 per night, based on SGA statutes which we found out I think two weeks ago. We can allocate them at most \$300 per night per room
