- Opening Statement:
- Hi everybody. So as Laney said my name is Alexis Dubinsky and I'll be coming to finance every week. So I'm super excited to work with you all. This is my first content resolution. So I'm really excited but it's not too long, so it shouldn't take me too long. So first of all, our list is a Venezuelan Student Association. They came to PAC requesting money for I believe it was 260 T shirts and then we went we went through some questioning, we talked to them and they told us that their club has 120 active members but they usually only have around 15 to 30 people coming to their VMs so we decided that it'd be best to cut them to around 125 T shirts. That way they can still use the shirts for outreach and given to all our members as they do have a higher they do have a pretty high member count. But I know that there's a representative of the organization here today to advocate for a higher number of T shirts. So if you guys have any questions about that you can direct those questions to either myself or the organization if I can't answer those questions

- Chair Lento - Can you see tell me what constitutes an active member in your organization?
- Pedro Zuloaga (VenSa) - I first want to say thank you to all of you. And to answer your question an active member. For us specifically means we program 17 events this semester, and we considered an active member to show up to at least like three, four or five of those events, since we have those. Our group chats at a size of like about 250 people. We don't have 250 members, but the people that we consistently see at our events and have other friends are what we consider constitute for an active member.
- Chair Lento - How many are how many would how many people would you consider there to be active members currently in your organization?
- Pedro Zuloaga (VenSa) - Specifically said to like as van says active members, um, it's just kind of like I feel like it's like a hard way to answer this question because we have active members that are for events or like kind of like people that are very connected with events. And then a lot of our attendees tend to be from other affiliates and Hulu and Hulu, and we have more outreach towards that but I don't want to answer the question where you don't want me to like answer essentially.
- Chair Lento - So with what you are funded right now with the $\$ 945$. That is for 120 shirts. Correct?
- Chair Staveski - That is 125 T shirts looking at like the last quote on their Qualtrics if you I don't know if you guys have it up. I know it's in the minutes. But if you look at the very last quote on the Qualtrics application, that will be 425 shirts at that price. But I know Sam or former president Diaz sent a new quote in the chat. So I think at that price, I can do the math really quick. It would be less T shirts, clothing, the new quote is 820 for the unit price, so the 945 would get them 115 shirts at that price.
- Vice Chair Navarro -What kind of events they do instead of just GBM if you guys could also explain on what other kinds of events you have throughout the school year.
- Pedro Zuloaga - Thank you, Vice Chair. I'm happy to answer that question. So one of the things that is big advances that our biggest attendance has never really had our GBMs like GBMs are very cultural, very like they're very educational. But at times, like investment culture,
we're very like party culture. We're very like excitable culture. So we like social events a lot of the time. And one of our biggest events that was during our week of events was our our Thanksgiving, which was our Thanksgiving which was affiliated like a potluck with a bunch of other affiliates. We also at almost every semester, throw like a bonfire. And that gets a lot of our attendance and our we also throw busyness, which are like pool days, and that's where our largest attendance event we've ever had, which was over like 100 people, and our outreach extended past just the Josue bubble. We had a lot of IFC brothers at our events. We had a lot of people that weren't even Venezuelan or Hispanic at our event. It was just at the end of the day, we were playing music and we had that we had that pool of people that wanted to be involved. And from that event, we got a lot more active members. Essentially, the whole part is of what we're trying to say here is that Ben says not only like shown it's, it's wouldn't be correct to say how the amount of members of ventajas do their job GBMs the majority of our events are social. And the way we really do it is through our busyness or our potlucks and our different events that we have and that's the reason that we came to this meeting to expand on that

- All-Night Yahtzee I forgot to answer the one question about where the event is located is in Memphis, Tennessee. So we would as an organization be covering the lodging costs. So that's something that we are taking out of our Yeah, we've taken care of the lodging but it is in Memphis, but it is open to the public. Yes, we have an audition process, but it's just a musical groups. So we just got to make sure that we're getting the members that you know, the group needs.

- All-Night Yahtzee - So we are. FSU is oldest acapella group. We've been around for 25 years. We were founded in 1998. So it is actually our 25th anniversary. So it's a big deal for us.
