  - Senator Widmann: The only changes are in 908.7 A. It is changing it to be read "the office of OGA shall have the authority to create a legislative agenda for any session of a Local, State, or Federal legislative bodies. This agenda shall include policy proposals intended for submission in their respective branches of government and any other necessary efforts to accomplish the purpose of OGA." This is just changing the wording that would only allow OGA to work in the Florida Legislature, where now we can work in the local, state, and federal legislature as well. If there is a board that may not be as successful as one, more funding less funding etc., they don't have to work at the federal level they just can. As Director

of Operations, it is my goal to expand to the federal level. There is one more change, it was a typo, "to be properly investigated."
