- Opening Statement:
 - Senator Hellman and White (P):
 - Senator Hellman (P): This idea has been in the works for several semesters, and now we are receiving an overwhelming amount of interest from the freshman class. Having a dedicated council for freshmen can lead to a more organized and efficient allocation of resources for their specific needs, ensuring that their concerns are addressed promptly and effectively. This, in turn, can contribute to a more positive campus experience and a stronger sense of community among all students 17,066. That is how many students were accepted into the Class of 2027. That is how many students the Freshman Leadership Institute accepts every year. The reason we can call ourselves leaders is because our student body elected us, on the basis that we will always do right by them. We cannot tell 98.8% of our new peers, our new Seminole family, that we will not work to create a place that new freshman can start their journey in student government. The Freshman Class Council will play a pivotal role in organizing and promoting events specifically tailored to the needs and interests of incoming students. These events can range from orientation activities and academic workshops to social gatherings and community service initiatives. These events not only help freshmen adjust to their new environment but also foster a sense of belonging

and inclusivity, which are essential components of a thriving campus community. As Deputy Treasurer of the Senior Class, I have met with the Senior Class Council President and Treasurer to work out logistics when it comes to exact positions and finances. The Freshman Class Council would not be able to make event or purchase requests without the approval of the Senior Class Council, which are the same rules that apply for the sophomore and junior class. The Freshman Class Council has been worked into the budget as a whole and we are well prepared to be the support that these freshmen, or anyone, will need during this transition. This is not a controversial idea. We were selected as leaders to make real change. With the creation of the Freshman Class Council, we will get to see real results on this campus. We will make history by witnessing the ever-growing freshmen class expand the reach of student government. The entirety of the class councils board is pushing for this addition, and I would appreciate the support.

 - Senator Waldie: Just one questions for clarification, I know somewhere in here it says that the SCC not have discretionary spending of A&S monies so, how would that work on a day-to-day basis, if there is supposed to be planning, what are the procedures built in for that within the legislation?
 - Senator Hellman: Follow the same as the sophomore and junior class councils, the senior class treasure will put purchase requests for events, and what's great about the class councils is that they treat it like their family and a lot of our events unless it's just the senior class during graduation, a lot of our events are joint, so it's a lot of collaboration and no way that anything can get passed through that doesn't go under the senior class, and that falls for every class too.
 - Senator Waldie: Okay, thank you so much.
 - $\circ~$ Whitman motions to enter round table, Pro-Tempore Cofer seconded.
- <u>Round-Table Discussion</u>:
 - **Chair Velazquez**: We are now in round table, does anyone have anything to say?
 - Senator Widmann: Yes, I am also a member of the senior class council, and I love the work that the class councils do. My reason for joining class council was to get students more involved and as I am terming out of senate soon, I wanted to stay involved with my class and student body as a whole. We heard in both our speeches for pro temp and senate president on ways to get more students involved in student government. This entity here is the perfect way to do that as we heard from the deputy treasurer of the senior class, the finances of this have already been worked out and seems like a cost-effective way that we can get more students involved. You have my support.
 - **Pro-Tempore Cofer:** I approached this, looking subjectively from the fact of what exactly what Senator Widmann said. I came into this space wanting to create exposure, more areas to be involved, in student government. More subjectively

that the class councils are something they want, worked hard for, and have already implemented a strategy to make sure they can be funded. When I first say the legislation, I was skeptical but that fact that they want to do it, willing to do and that this is a community and freshman are being put in blindly, is what really put me in favor of this bill. Freshman have been really vocal for their want and desire for this, so I think it's something we shouldn't be in the way of.

- Senator Chinn: It seems that instead of creating an entire freshman class council it might be better to just expand or built upon the Freshman Leadership Institute. If they are going to be working under the senior class council then speaking to them anyway, it seems counter intuitive to what the freshman leadership institute is. The bill has failed twice already, and I am not seeing any significant changes, so I don't see a change to make this bill come up again.
- Senator Widmann: I just wanted to add on to that. With the bill failing, one of the reasons was that we were in the middle of a hiring process for our current advisor so that was something we couldn't keep on the books. Having the freshman class council work with the senior class council, every other class council works with the senior class council, they can't put in purchase requests without going through the senior class council. If I'm not mistaken the freshman leadership institute is pretty selective and it has a GPA requirement, which goes against what student government is to engage all students, so that's my opinion.
- Pro-Tempore Cofer: I think the problem with this and why it failed in the past, I wasn't there for it so I can't be completely honest but there wasn't really an outlines process for how this was going to work, you know implementing the fact that there is now a budget process for how it's going to play out. The difference between the FLI and this is that the class councils have a broad ability for students in that class to be more involved in campus generally, and FLI is more exclusive, with mentorship and being more personalized. Especially when you consider the fact that FSU is admitting more freshman each year. So, I think it is important to provide resources that support the egregious amounts of new students that are coming to our campus.

- <u>Closing Statement:</u>
 - Senator Hellman: Due to the huge increase in acceptances, we have to accommodate for the growing campus and like Senator Cofer said we are so lucky to have leaders like the ones we have in class council that are carrying about these incoming freshmen especially coming from seniors that are going to be gone next year. The way the class council is pushing so hard for these students to have a say and answering these students, and their dms. It would not be fair on our part to just read them and swipe out. These students are begging for it, and I believe it is extremely admirable of the class councils to be pushing for this so hard and I do appreciate everyone hearing me tonight.
