So, the senate president may create an ad hoc election oversight committee to compose a written or multiple-choice certification exam. To assess appointments to elections commission. The test was fairly encompassing the election code, judiciary committee must approve that test prior to the start of the campaign week, every fall and spring semester, a previously used test may be reapproved, all voting members a elections commission shall take the election code test every fall semester. So essentially if somebody wants to serve on the elections commission, they must take the election oversight exam, which was written by a judiciary committee before us. So, I'm going to entertain a motion a little bit to approve the previous test that was written by a previous judiciary committee. And then I know we have some pretty big legislation coming down the pipeline right now, in terms of the election code being changed. So, when that happens, I'm going to go and talk to Spencer Greenwood and talk to the sponsor of the bill as well, to make sure that we can make changes to that quiz as needed. And then we can just re approve at a future meeting if we need to.
