Bill #100 Sponsored by Senator Windlan (P) Barresi, Burton, Garcia, Gorelick,

This bill modifies the election code to establish an opportunity for every candidate running for an SGA office to have a 100-word statement about their qualifications and/or reasons for running published on the SGA website and made accessible to the student body at least 48 hours prior to Student Government Association election day.

• Opening Statement (5 mins):

Thanks for having me today. The most common complaint I have gotten is that people don't know anything about SGA while they are voting is that they do not know anythign about indivual candiates, and then they vote for people they know, or select at random, or don't even vote for some. It is a hurdle for voters in general because there is no way for voters to see information about the different candidates that are running, and what their reasons and qualifications are. So I drafted this bill it basically adds a section into the duties of the supervior of elections to publish up to 100 words for each candidate that chooses to submit a statement onto the candidate declaration form. This will ensure that anyone who submits will be published on the SGA website 48 hours before election day.

## Larancuent moves to amend, Sponsor finds it friendly

**Amendment:** To create a subsection under 702.2 under the jobs of the supervisor of elections to "The supervisor of elections must approve candidate responses within 2 days of submission and if the response is not approved, the candidate will have 24 hours to make edits and resubmit to the supervisor of elections.

Khosh: How do you think we can avoid party politics issues with this?

**Windlan:** I think this helps to further SGA from party politics because it helps people see things about indivual candidates outside of party politics. I think this offers another way to move away from party politics.
