3.1. Bill 25

4.2. Bill 32

Amends Chapter 612 (which deals with the Student Government Golden Tribe Lecture Series) to eliminate the several specific allocations of membership in the committee, and instead place appointment power in the hands of the Student Body President. Also, it revises the statute to require all candidates chosen by the Golden Tribe Lecture Series Committee be approved by the SGA Senate via consent resolution after coming out of Student Affairs. Amends 802.10 eliminating the ability of Golden Tribe funds to be spent for any purpose.

Wants to connect The Golden Tribe Lecture series to the student body; want students and the senate to be more actively involved.

Updated the list of committee members for GTL.

But this might be giving too much power to the senate

Why not do this the way we do bureaus and agencies ... why dont we do a re composition of who will decide what will be coming to the GTL Series... should not be all academic.

If we want to make it student run student led then we cannot make it a strictly "academic" series.

The list of past speakers has been very inconsistent with what the GTL Series is intended to be.

We give bureaus and agencies the authority to operate within the budget that they are given; maybe we should make GTL Series a little more like this?
