- **Bill 38** Sponsored by President Diaz Revising language pertaining to the approval and veto process of bills passed by the Student Senate.
  - Opening: Overall, this bill does changes to the veto and bill approval process, i realized Dr. Hect needs at least 15 days to approval or veto the budget bill. So, I asked this bill to also be sent to Budget. Some of it is copied straight from state law, which I can cite for you. Specifically J, subsection two, is taken from state law.

- General Questioning:
  - Senator Dale: Does the student body president already have the ability to veto the budget bill?
  - President Diaz: The student body president can veto any bill. 402.2(A) and 402.2(B) talk about the student body presidents veto and approval powers.
  - Vice-Chair Burton: For clarification, this bill is adding verbiage of state law?
  - President Diaz: In any general bill, Dr. Hecht has 10 school days, however state law mandates 15. I'm not creating a new policing, this was already in state law.
  - Senator Dale: How long has this been state law that we haven't been giving them 15 days to veto?
  - President Diaz: I'm not sure when that specific part of state law was written.
