 - Response: SAP funds student Academic programs and they can not request funds from anywhere else besides because they are not an RSO.
 - Sen Dale- Statue The dean must express support for this?
 - Response:Widmann- all applications were submitted to student body treasurer and they have submitted previous SAP request for the past few years
 - Sen. Cofer Is this the only request that has come to SAP and do you anticipate any other organizations needing these funds?
 - Response: Widman all statues were met, the SAP application was posted on the sga INSTAGRAM and website and we only meet once to allocate of these funds to those organization who need them.
 - Sen. Dale- what is this expense for?
 - Widman: This is them to attend a conference, but is only available for student academic programs
 - Widman screen shares the request from WORLD AFFAIRS
 PROGRAM
 - Point Chair Burton: is this to see if the bill aligns with statues
 - Dale: No, its to see if we are blindly giving away 22, 000 dollars, do they normally request this much money? Are they funded by other organization?
 - Response: Widman: "Reads request. States that the amount funded is an estimation of what conferences they will be able to attend each year they make sure that no conference exceeds \$200 per student"
