- Resolution #32 Sponsored by Senator Diaz (P), Senator Pedraja (Co) Proposing comprehensive amendments to the Senate's Rules of Procedure to improve the efficiency of the Senate's operations. (AMENDED and PASSED in Judiciary 4<sup>th</sup> April)
  - Opening Statement (5 minutes):
    - President Diaz (P) Hi, yes, I don't want to take up too much time and an opening statement. I know that the pro tempore told everybody to read the resolution prior to being here. So, I highly suggest looking at it. If you have any issues with anything in it, ask questions, but I'll yield my time with that.
  - <u>Question Period:</u> None.
  - Chair Kariher moves to enter deliberations, Chair Widmann seconds, no objections.
  - o Round-Table Deliberation (30 minutes):

- Chair Kariher I've looked over this bill. With my committee. It's really just fine. It's just like clerical things.
- Chair Bettley Yeah, I was going to say basically the same things as the previous senator. It's just really kind of making things more succinct in our rules of procedure.

- Opening Statement (3 minutes)
  - Senator Garrison Hi, everyone. So, I just wanted to thank you all for being here to hear me out today. And I also wanted to say that I take Senate very seriously, and these absences weren't just me not wanting to come. And I'll gladly answer any question of any detail of all of these absences. And the majority of them, I did just get unlucky because within my sorority I'm a recruitment board leader. And of course, of all the days where nothing's going on Wednesdays all of our meetings are on Wednesdays. And then the beginning of the semester, like we had some on Tuesdays, which is where my judiciary committee meetings are. So, I did try sometimes to go to my RBL meeting and then like come to Senate,

but then Senate would end early, and I wouldn't have time. And the RBL meeting started at 7:30 and so does Senate. So, most of my absences did come from that some of them were sicknesses. And I honestly did not know that my judiciary committee absences were combined with my regular Senate absences. And if I did know that I probably would have like, used a mental health day absence, and tried to not rack up these many absences. And it really was unintentional and completely, all on my part, and I have no more meetings for my sorority RBL for the rest of the semester. And I'm completely committed for the rest of the semester. And I just want to say thank you guys again for hearing me out and I would gladly answer any questions about my absences.

- Question Period (15 minutes)
  - Chair Kariher Are you planning on being here over the summer?
    - Senator Garrison Yes, I'll be here all summer. I have an internship. So I'll be here all summer.
  - Pro-Tempore DuChêne Clarification, are you taking any classes with FSU over the summer?
    - Senator Garrison Yes. The second session of summer.
  - Chair Widmann So I know that you did explain your time constraints for missing the Wednesday Senate meetings. But if I recall correctly from the pro tempore explaining the absences, your most recent absence that put you over the five absent absence limit was for judiciary? Do you still have any time constraints with that committee?
    - Senator Garrison Right. So that was completely my fault. I will be honest about that last absence; I knew that I was at 4.5 because I was emailing with the pro tempore. I knew that I did have a lot of absences. And it was just a lot going on in my life, but I know everyone has that. And for that judiciary meeting, I was at the library, and I knew that I had a meeting and then I honestly just forgot, and that's completely on me. And I have a responsibility that I did not own up to and that was just honestly a mistake. So, yeah, that was the most recent one. So that's what put me over and if I wouldn't have done that, I probably wouldn't have exceeded five.

- Pro Tempore DuChêne Thank you. And to be clear, we'll have new committee assignment. I mean, if you want to stay on judiciary, I there's a good chance we'll stay on judiciary. However, there'll be new committee assignments next week. Anyway, so that'll mean new committee times, etc. And then of course the summer is its own separate thing. We're still in question period.
- Chair Kariher moves to enter deliberations, Chair Widmann seconds, no objections.
- Closing Statement (Remainder of Opening Time)
  - Senator Garrison So thank you guys. Again, I just want to say that I plan on now that I know that my committee absences and regular Senate absences are in one, I would definitely not exceed five again, and I'm capable of putting all my time into this committee, or whatever the next one is. And I'm going to try and figure out my new time constraints and make sure that I can kind of get everything together in order to not get these many absences ever again. So, thank you for hearing me out.
- Deliberations (15 minutes)
  - Chair Bettley Yes, I'm in favor of unsuspending the Senator. I actually really appreciate the honesty that this Senator gave us. Things come up people forget, I'm the Chair of a Committee and I literally forgot about my own committee recently. So, I completely understand that stuff comes up and people have stuff going on. And I think it's really respectable and commendable that she's owning up to it and telling us flat out what happened. So, I will be voting to unsuspend her.
  - Chair Kariher As the Chair of Judiciary, I can just say that Senator Garrison had shown up to pretty much every single meeting, I guess, except for that one. So, you know, I definitely think on suspending is the best option. Just showing up and participating all that stuff. I think that Senator Garrison will be a great addition to keep in Senate. So, I'm in full support of unsuspending.
- Pedraja moves to call the question, Widmann seconds, no objections.

- New Absence Deliberations (5 minutes)
- Chair Pedraja moves to grant the Senator two (2) additional absences, Chair Bettley seconds, Chair Kariher objects – Chair Pedraja withdraws motion.
  - Chair Bettley POI How many absences would be comfortable for you?
    - Pro-Tempore DuChêne To clarify this they will adhere to the same policy of excused absences being half.
    - I think two would be plenty. I still have mental health days of if I don't see myself needing to even use an absence for the remainder of the semester. So, I think two would be fine.
  - Chair Kariher The reason why I object to is because the Senator is going to be here over the summer. So, for everyone else that we've been giving two for isn't going to be here over the summer. So, I think you know, people go on vacation. People do stuff over the summer. So, there's a chance that the Senator might not be able to come to every senate meeting in the summer, so I'm in favor of maybe giving three or four. But I would like to know y'all's thoughts as well.
  - Chair Bettley Yeah, I think three is like a good compromise. Correct me
    if I'm wrong, but she still has two mental health days as well. So that
    would give her three absences and two mental health days, which almost
    puts her right back at the same amount that a regular Senator would
    have. So, I'm good with three.
- Chair Pedraja moves to grant the Senator three (3) additional absences, Chair Bettley seconds, no objections.
- Senator Garrison is granted three (3) additional absences.
