**BILL #14 - Sponsored by Senators Bettley and Chehaitli (P)

**This legislation serves to remove the Office of the Center for Participant Education as a budgeted bureau.**

- Opening Statement (5 mins):
- **Chehaitli:** The Center for Participant Education has done some amazing things as they have been very effective in the past. This hasn't been active as a structured Bureau since 2020 and has been budgeted \$0 for the past two years. Taking out the

CPE Bureau from statutes would streamline the Budgeting process, and we hope to pass the resolution to commemorate the work that they did.


