Consent Resolution 3 - Sponsored by Chair Staveski Line Item \$1,984 and \$1,700

- o Opening Statement:
 - Chair Staveski: So guys, this is a pretty short consent resolution compared to some past ones that I've presented to finance. But I want to start off by saying I think there are some representatives of the American Marketing Association here. We did have a slight issue with the American Marketing Association in pack today, their event is a little bit unique. It is um, food for a 75 person marketing event, but only 15 of those are confirmed FSU students. So statutorily I wasn't sure if we were allowed to fund it. But I talked to our accounting office and Andy and in accordance with statute eight oh 3.7 F we are allowed to fund it. So I can give you guys some more clarification on that. But I think they're here just in case there was an issue. So I wanted to let them know that we are allowed to fund it statutorily. They're asking for food for their conference. It's \$1.700 for two meals for 75 people, which we thought was very reasonable. And then who bought us here to request for their event. That's this Friday. All the food is from Publix, which is an approved vendor, it actually comes out to somewhere between like five to \$7 a person because they have an expected attendance of 350 people so that is a very low number. We found it very reasonable. And even though that events on Friday. I've coordinated with our accounting office and since it is a vendor we use often they'll be able to get the PIO in time for this Friday. So yeah, I welcome any and all questions. I can drop the Qualtrics links in the chat but yeah, let me know if you have any questions.

o Technical Non-Debatable Questions:

- Senator Raiford: I was just wondering what is the appropriate or like an average amount of a price per meal for an event like this? Because I know you said five to seven for the first event, but if the 1700 divided by two because it's a two meals that's 850 divided by seven my people is a little over \$11 and one is like five to \$7. So I'm just wondering what's like the average amount that we typically find?
- Chair Staveski: Oh, yeah, absolutely. When I the question I've seen honestly vary depending on the type of event that it is. It seems like from my interpretation, it seemed that the American Marketing Association's event was more like a meal. When I'm actually I'm going to I'm going to change what I'm saying. Sorry, I'm remembering what's happening now. So American Marketing Association, they, they're getting their food from Chick fil A or mo so it's like prepared food but nobody's getting all of their stuff from Publix. So it's kind of more groceries, which is why we thought it would be much less expensive, and also they're making it in a much larger quantity. So I think that's kind of where that discrepancy and price comes from. But we funded meals that are like way more than \$11 before like if somebody caterers and events like Sunday's I think once we spent like \$16 a meal so we didn't think that these were unreasonable or unusual at all.
