 - Opening Statement:
 - <u>Candidate Kessler</u>: Good Evening my name is August Kessler and I use he/him pronouns. Im a sophomore at Florida State pursuing a major in English, history, and sociology. I am here today seeking to be confirmed

as the Pride Student Union Assistant director for the 2024 Spring Semester. Since arriving at Florida State I have been able to pursue passions in tangible ways that have allowed me t grow and strengthen my abilities. My experiences with the Pride student union have encouraged the growth and within my position I hope to encourage growth in others across campus. Although I have not been previously on board for Pride I have worked with the organization in the past and have gained new ways on campus that have prepared me to take onn this role. Since arriving at Florida State, I have involved myself with the Askew Student Cinema. As both a student and employee. My position at the ASLC gives me the opportunity to lead others respectfully, problem solve effectively and communicate with my coworkers of ensure theres a safe and productive work environment. - Bill #8: Sponsored by Senator Garcia
 - Opening Statement:
 - Senator Garcia: Hey everyone, so one of the biggest questions I get from people is what I do in SGA. I think that a big issue is that people don't know what we're going to do before we do it. Like they don't know what bills were going to discuss unless you have a friend or a close connection you may not be aware of the legislation we are debating on that day. If that is something important to you, you don't have the advance notice to be able to schedule yourself accordingly so you can show out of these meetings. So, what this bill does is that it basically publishes the legislative agenda. Which is the agenda us senators receive in advance and my thinking is that if we receive it in advance the public should as

well. I work within the capitol and one of the biggest things with committees is that they publish that agenda in advance so that people can prepare to go to these meetings. Hopefully to increase transparency and have people show up.

- Senator Gomez: I just have a question on when in advance this would be posted like is ita week ahead before
 - Senator Garcia: Yeah, so I put 24 hours in advance but I put "or in accordance with when it is received by Student senate. I know we don't always receive our agendas in advance so I would be open to a different interpretation. I feel as if 24 hours is a good amount of time so that the senate clerk is still able to fulfill their responsibilities and it doesn't put too much strain on them. It gives people enough time for people to plan around that
