- Candidate for Confirmation: Jalisa McEntyre: D&I Institute, Director
  - Opening Statement:
    - <u>Candidate</u>: Hi everyone my name is Jalisa McEntyre I am currently a Senator, if hopefully everything goes well I will resign tomorrow. I was selected to be directeor of Diversity, Equity and Inclusion Institute. I am a

previous exec board member and have also had previous experience with it in the past, so I feel best fit for the position. In addition to teh fact that I kind of already knnow how the institute is ran and given taht it is behind I am capable of getting it up and running. I already have powerpoints made, in the process of getting started, I am in communication with assistant director who was confirmed last week. I already have good relationships with agency leaders and I am ready to get it up and running. ## o Round of Questioning:

- Senator Gomez: What do you think is the biggest obstacle at FSU when it comes to prevennting bigotry while promoting diversity and inclusion?
  - Candidate McEntyre: When it comes to preventing discrimination while also trying to promote diversity, teh biggest thing si people not knnowing how to respect each others difference. Especially, if the situation is either left or right and people dont understand that you can agree to disagree at certain times. SOmetimes there is a right side and there is a wrong side but because theres a level of respect that needs to be mainntained and people dont know how to maintain that or establish a level of respect. That is probably the biggest problem that comes for it because when the line of respect is crossed thats when i believe violence starts to happen. That is something I know how to take measures against because I was previously in the institute. You kinf of know how to set the standard and tone of the room before the discussion occurs.
- Senator Pu: What are some of the hurdles that you wish to tackle on your new positions that hinder on your principles of diversity and equality here at FSU.
  - Candidate McEntyre: Some hurdles that I am wishing to tackle
    would definitely be the stigma that DEI is bad. I know it si being
    brought down in legislation and that theyre saying how they wont
    be using public funding at school. DEI is not affected because
    thats nnot the fundnig source. It is not just the liberal thing that
    theyre pushing around it gives everyone a safe space to their
    environments. Allows people to see other cultures and learn
    respectful ways to communicate.
- Senator Gomez: So I see in your forwarding letter taht you were an intern at teh capitol, so if you could explain some of your takeaways from that and how you could use that experience to help your potential new position?
  - Candidate McEntyre: So I actually apllied for this last year and was offered it not too long ago. So Im not really sure whats in my forwarding letter but I do know whats in my resume. Yes, I was an intern at the capitol and at the capitol I definitely saw the red andthe blue and it was such a drastic difference. The same way people have petty differences in real life they have it there as adults and they carry on and you see it in legislationa nd everywhere. To really get things done is that politics are a game. If you want to get things done you have to rally people behind the scenes, talk to them and get them on your side.       - Senator Meier: Did you mean, why isnt budget approved by summer Sentae? That was already in Statutes that teh budge isnt appproved by summer senate because most budgeted entitites arent really active in the summer or dont have as many active members during the summer, so it wouldnt be appropriate to have them request or approve during the summer.
