  - Opening Statement:

## • Candidate for Confirmation: Jose Collantes: Legislative Branch, RTAC Member

- o Opening Statement:

As for qualifications go for RTAC there are none as of this moment. But the thing is I am very eager to be involved in SGA. I have made previous attempts to get involved in SGA.
