- Bill #64 Sponsored by Chair White
  - o Opening Statement:
    - Chair White: So this bill is pretty simple. It just adds onto sweepings, adds onto the statutes relating to sweepings, during sweepings we give out

money to agencies, student leadership councils, campus rec, and other entities that request additional funding. But specifically we can give money to ourselves through sweepings. However, that was not included in the statutes because when we give out funds, you'll see if we have Senate project bills come through here that the funds have to be allocated to a specific thing. And that's where the money has to be spent. Because we have categories that can tell you if I pull book consent resolution, but with that, the money would have to be spent on that category by the RSO. So if you budget the RSO \$100 for a contract, contractual services, but then they end up being able to put that \$100 for food they would need to go through Senate to change that amount, have to change where the funding is coming from and where they can spend the money on. So this bill just puts it into statutes the procedure that would have to be followed. We did this on our last Senate meeting. We had the African American Student Association come and then they presented a bill to get and then a Senator presented a bill on their behalf to get the money to switch categories, and that's what this bill would do. I yield the remainder of my time to my closing.

# Technical Non-Debatable Questions:

- Senator Fredock: so you mentioned that this is for RSOs, those that are allocated money through sweepings. But I'm not seeing that because chapter 803 of statutes seems to be just about budgetary categories in general. So from kind of my perspective reading this, this looks like this will apply to any RSO that's given money through PAC or RTAC. If they need to change categories, they'd have to go through this?
- Chair White: I believe it would. It would also probably apply to that but when they go through RTAC and PAC by that time they know what they want to spend money on. This mainly would affect the entities at the beginning of the year that get money through sweepings. Sweepings is like budgeted funds. So it would be affecting them that like requests in the beginning of the year. And then as they see how the money gets used when that ends up changing categories while they're in PAC or RTAC, you can make amendments while it's being decided on to fix the categories during the meetings before they pass the consent resolution.

# Senator Fredock moves to enter round-table discussion; Chair White seconds

#### Round-Table Discussion:

- Senator Fredock: So one smaller concern I have with this, the language is mentioning like a chief executive of like, you know for the SGA entities is not a big deal. But for RSO those typically have a board and I don't think giving the this power to just like an RSO's president is the best.
- Chair White: so I can respond to that. That's because most of the time you have to have your RSO, you have to have your financial, your ones that have financial certification and a majority of the time that's usually the president or the director of finance. So that's what it means by director or chief executive, the people that are financially certified, which is why that

language is included. And usually the President will need to sign up anyways for most organizations for the financials. Which is why that's already part of the bill previously.

- Chair White moves to call the question; Senator Jones seconds; Senator Fredock objects, motion fails
- Round-Table Discussion:
  - Senator Fredock: I guess another comment because you had said during questioning that this would mostly affect our RSOs through sweepings, but I can kind of foresee like, from my own experience when I was going through some travel with an RSO so like, you know, we had applied to get money from mileage, and mileage is a hard thing to predict exactly how much money you're going to need right. So like what ended up happening is like, you know, the money we had requested for the hotel didn't fully fund like, we didn't need that full thing for the hotel it turned out, so we ended up applying some of that to mileage. So like under the language of that bill would we have to before we're able to get reimbursed for that get a Senate transfer bill signed and whatnot?
  - Chair White: From my understanding to switch money between categories you would have already, you would already have been supposed to go to SGA accounting and Senate to get that switched before the reimbursement. But this bill would most, it's the main point of this bill is to apply to, and but entities that get budgeted transfers from sweepings that have to change like thousands like two to three thousand dollars, and like the spring when they realized they need money for another categories. And to transfer you already do have to go to Senate, which is why we added this because it wasn't clear. Because RSOs used to not receive money from sweepings. They used to only be able to receive money from RTAC and PAC. So this bill applied to this now that they do receive money from sweepings. So this bill was to make the change that we enforced last Senate and the rules and procedures it says that it's a statute.
  - Senator Fredock: That's the case and can we amend to just include that for sweepings?
  - Chair White: I would not find that friendly just because they already do have to go to Senate if there's any transfer in the services fees technically that goes against the financial manual and SGA accounting rules because you're supposed to follow the categories. You're not supposed to switch funds in between categories. You've got to go through Senate to reallocate it for you or go to accounting because they're not supposed to reimburse you for anything else that's not exactly specified for you to be spending.
