- Resolution #46- Sponsored by Senator White (P), Senator Kerley (Co)
 - o Opening Statement (5 minutes):

 - Senator Staveski: I mean, the second set online is 23.7 and I think it rounded off to 24. so, I'm fine leaving it rounded off if everyone else is.
 - Senator Kerley: Yeah, that works.
 - Senator Staveski: Point of parliamentary privilege, do we have to vote on the amendment and then the resolution or can we just vote on it as a whole?
 - Chair Pedraja: With the rules and procedure that I'm familiar with, as long as the sponsor finds it firmly and there's no objections, we are fine to keep the amendment. We only vote if there's an objection, I'm pretty sure. Everyone got a look to look through the bill. You can also find this on campus under the Student Life tab. Do I have any other discussion points or questions or notions?
 - Vice Chair Arellano: motion to call to question on the resolution.
 - Chair Pedraja: There's been a motion to call the question on the resolution. Do I have a second?
 - Senator Staveski: so seconded.
