- Alexis Dorman, Deputy Director of OGA: Here with a few OGA updates. We're working on getting everything set for FSU Day at the Capitol and the reception. Bill 15                      Sponsored by Senator St. Hilaire (P) Folwell (Co)  
This bill was written to clarify procedures when we are faced with an

objection to a consent resolution. It reads "If objected to, the consent resolution shall be treated as any other piece of legislation, and shall require a majority vote for passage." **(Referred to Judiciary and Finance. Passed Judiciary 02.07. Tabled in Finance 02.07. 02.14)**

Bill 20 Sponsored by Senator Dale (P) Folwell, Salazar, Jones, Bettley, Chehaitli, Humberg (Co)  
A revision is made to the Student Body Statutes 802.9. To ban the purchase and use of plastic straws with A&S Monies. This will be in addition to the existing ban on the purchase of disposable plastic water Bottles. **(Referred to Judiciary and Finance.)**

Bill 21 Sponsored by Senators Diaz and Salazar (P)  
Moving back the deadline for HLSU E-board applications and removing the requirement that affiliates must vote on the incoming e-board.

Bills Second Reading:

- Bill 7                      Sponsored by Senator Folwell (P)  
This bill brings Chapter 605 in line with the changes made to the election code by the Seventy-fourth Student Senate in Bill 82. **(Referred to Judiciary. Tabled in Judiciary 01.24. Passed in Judiciary 01.31. Tabled on the floor 02.01. 02.08)**

- Opening Statement:
  - This has been on the floor for a while now, so I'm glad we're finally getting to it. In the 74th Senate, we passed a bill that allowed Union Board and Campus Recreation seats to be run by seat number and not block formation. We had some debate and decided to pass it. But I was reading through statutes and I noticed there was a reference to that process in another part of statutes that I didn't even think to check. So this is just bringing Chapter 605 in line with those changes we already made. This is just making sure everything is accurate. I think it's pretty self-explanatory, but if there's any questions, I'm happy to answer them.

- Bill 13                      Sponsored by Senator Widmann (P)

Changing statutory requirements for Senate Funding Boards in order to align with current practices. **(Referred to Judiciary and Finance. Passed in Judiciary 02.07. Passed in Finance 02.07. Tabled on the floor 02.08)**

- **No sponsor present, bill is tabled.**

Bill 14                      Sponsored by Senators Bettley and Chehaitli (P) Burton, Kariher, Maglin, LoBianco (Co)

This legislation serves to remove the Office of the Center for Participant Education as a budgeted bureau. **(Referred to Student Life and Internal Affairs. Passed Student Life 02.03. Passed Internal Affairs 02.06. Tabled on the floor 02.08)**

- Opening Statement:
  - This bill strikes the clause in statute that established the Office of the Center for Participant Education as a budgeted bureau. It hasn't been budgeted since 2020 and actually hasn't been active since 2020. We think this is the best way to expedite the budgeting process since this hasn't been budgeted since 2020. There are other organizations on campus that can better do the job of the CPE that deserve our support instead.
- General Questions:
  - Anderson: Have you been able to contact anybody from the OCE?
    - No, they haven't been active on Instagram since 2020 and on the SGA website, they don't have any contact information. We tried to, but there really was no one we could speak to.
  - Folwell: Is there any particular reason you wrote this bill now? Have you spoken to anybody from the executive branch?
    - Yeah, I figured this would clean up and streamline the budgeting process. But no, we have not spoken to anyone from the executive branch.
  - Patel Qadir: What are the other organizations that could do the job better?
    - There are other university organizations that do really try to promote progressive change on campus. For example, Florida PIIRG. We mention it in the resolution.
  - Widmann: I'm on the COE's website. It says they have an office on the fourth floor of the Thagard building and there is an email listed there, is that the one you used?
    - Yes, I did use that email and sent them like 5,6 emails and I did send them one at the end of the semester and didn't hear anything back. Back when the old Union was torn down, the fourth floor of Thagard was used as SGA offices, so it is my assumption that the website hasn't been updated since then.
- First round of Pro:
  - Dale: The Senators seem to have done their due diligence and anything that can streamline the complicated budget process sounds good to me.
  - Maglin: I'm in full support of this. If we already have organizations in SGA doing the job of the CPE, this bureau really only exists on paper.

- **Widmann moves to call the question on Bill 14. LoBianco seconds.**
  - **No objections.**
- Closing Statement:



- Thank you for all your questions and concerns. Since this is a budgeted entity, we really wanted to make sure all our avenues were closed before we struck them from statutes and we're excited to commemorate this bureau for all their work over the years.

Bill 17

Sponsored by Senators DuChêne and Folwell (P) Anandjiwala, Boisvert, Carter, Chehaitli, Dale, LoBianco, Maglin, McEntyre, McMahan, St. Hilaire (Co)

This bill makes the willful misrepresentation of one's self in an official capacity as a representative or potential representative of the Student Government Association a violation of the SGA Code of Ethics. **(Referred to Judiciary and Rules. Passed in Judiciary 02.14. Passed in Rules 02.15.)**

- **Opening Statement:**
  - This makes it so that anybody who lied about making themselves an SGA official and that lie is able to be proven, is a violation of the Code of Ethics. There have been some allegations that happened in SGA recently and I just want to address those upfront. This is not a response to those, but I did discover that the Code of Ethics doesn't really address anything about when people lie under oath.
- **General Questions:**
  - Brewer: If someone, during their confirmation hearing, says "I really hope to do this, I really hope to do that", but don't do it during their term, would that person be misrepresenting themselves?
    - At the end of the day, it is kind of open to the FSU Supreme Court. But, I don't think that this would be an issue because they said "I hope to do this," not "I will do this."
- **First round of Pro:**
  - Bettley: Hopefully this won't need to be used, but it will reiterate the significance of SGA positions and I appreciate the sponsor for writing this out.
  - Dale: I'm in favor of this change.
- **First Round of Con:**
- **Crocker moves to call the question. Chehaitli seconds.**
  - **No objections**
- **Closing Statement:**
  - This isn't controversial. We shouldn't be lying in general, but especially in our roles. It went under a fair amount of scrutiny in committee and while I hope we don't have to use this, I hope we will use it well.

Bill 18

Sponsored by Senators Barrett and Bettley (P) Dale (Co)  
To fund 2 ADA-accessible raised garden beds at the Seminole Organic Garden. **(Referred to Budget and Student Life. Passed in Budget 02.09. Passed in Student Life 02.10)**

- **Opening Statement:**

- Currently, in the Seminole Organic Garden, they do not have any ADA-accessible beds, so anyone with a disability cannot partake in any Garden events and it was recently brought to my attention that there are sustainable-focused scholarships, which means that any of those scholarships cannot be received by anyone with a disability. I do have a quote if you guys would like to see it, thank you.
- General Questions:
  - Widmann: Would these beds require routine maintenance and how would that work?
    - The maintenance workers in charge of the garden would just be in charge of an additional two beds, taking care of cleaning and things like that.
  - Folwell: Will these be accessible for other students?
    - Yes, this just makes two specific ones accessible for everyone and gives everyone the opportunity to partake.
  - Brewer: I was just wondering if you looked into making two already existing beds ADA-accessible and if that would be cheaper?
    - I think that this money is going to be used to make two already-existing beds accessible.
  - Adonis: How many beds do they have right now?
    - I think it's like 14.
  - Seeger: If this were to pass, what would the date be that they would start working on this project?
    - They have everything set up, they just need the money, so construction would start ASAP. They wanted this passed soon because the price of logs is all over the place and they expect it to go up soon.
- First round of Pro:
  - Folwell: I think this really checks both the accessibility and sustainability boxes. I think this is a great use of our money and the Seminole Garden deserves our support.
  - Alvarez: So I've seen the garden and it's really beautiful and I know it's encouraged for students to tend to the garden and use the produce for their own personal needs.
  - Dale: I think this is a really good project.

  - I really do urge all of you guys to go to the garden and this is really important to ensure that when events come up, all students can attend.

Bill 19

Sponsored by Senators Barrett and Bettley (P) Dale (Co)  
 To fund 7 U-Bike Locks as part of Sustainable Campus' bike rental program. These locks will be available to rent at no cost by students already owning bikes. **(Referred to Budget and Student Life. Passed in Budget 02.09. Passed in Student Life 02.10)**

- **Bettley moves to table Bill 19. Widmann seconds.**
  - **No objections.**

- **Bill 19 is tabled**

Bill 21

Sponsored by Senators Diaz and Salazar (P)

Moving back the deadline for HLSU E-board applications and removing the requirement that affiliates must vote on the incoming e-board.

- Opening Statement:
  - This is as a result of a bill I wrote over the summer, I believe it was Bill 57. That bill changed a lot of things about HLSU statutes, but it amended a lot of things that I, and the HLSU board, disagree with. There are 17 affiliate members versus 10 E-Board members. Additionally, there are only 4 E-Board members who were confirmed by the Senate. The Director and Assistant Director have confided in me their concerns.
- General Questions:
  - Bettley: Did HLSU also extend their deadlines last year?
    - Yes, that was a temporary bill but I expect this would be the permanent statute.
  - Gummerman: Has this method been used by HLSU in the past and could you elaborate on why they have people who haven't been confirmed by the Senate?
    - Not in recent memory. In the past, confirmations only needed to be passed by the HLSU E-Board.
  - Crocker: You said there were often issues meeting quorum. If there were any measures in place holding members accountable?
    - There are attendance requirements to continue membership,  
**(RECORDING INAUDIBLE 1:35:50)**
  - Patel Qadir: How long were the members given to vote on candidates?
    - This upcoming transition is the first time members have been able to vote.
  - Dale: How does this compare to other student agencies?
    - To the best of my knowledge, the only agency that allows its members to vote on the confirmations is the Jewish Student Union, they call it the "advisory council."
  - Widmann: Are these election hearings open to all affiliates?
    - Any member of the student body can show up.
- First round of Pro:
  - Folwell: I was in the Senate where the original amendment was passed and I commend the sponsor for righting this wrong. I will be voting in favor and will encourage everyone to do the same.
  - Bettley: I commend the sponsors for following up on this and I am in support.
  - Crocker: After hearing further clarification, I fully support this. I think it's great HLSU's voting members will be super informed on procedures.
  - Humberg: I just want to say the Brazilian Student Association supports this, and they are affiliates of HLSU.
- First round of Con:
- **Folwell moves to call the question. LoBianco seconds.**
  - **No objections.**
- Closing Statement:
  - This was something that happened during Summer Senate, and a lot of the Senators were inexperienced. This has been a long time in the making and we appreciate your support.
- Voting results for Bill 21:
