                                    To fund the National Council of Negro Women.

*Senate in ‘Finance as a Whole.’*

- Opening Statement:
  - Rider: The line item requesting funding for is ‘other’ which is mileage for a bus. Original request was \$7,079.95 so we did bring them down to \$2,500. This is a great rate. They are taking 56 members and using a charter bus rental we recommended from the FSU Financial Manual. They are leaving on March 25<sup>th</sup> and coming back on March 27<sup>th</sup>. Again, this is a great opportunity as all will be able to go. We also had the FSU Flying High Circus request a large number for 56 members to get a bus where we provided \$2,500 – this is how we came up with \$2,500. We did bring them down a lot. They were unable to go on this because of COVID-19. The National Council of Negro Women does so much on-campus such as building houses and extensive outreach. I ask Finance to fund them fully for this amount.

    - B. Suarez: I sat in on this meeting and fully supporting this Consent Resolution. Seeing as they opened to the entire body, I see no reason why we shouldn't fund this line item.
    - Tucker: This is a great organization; they do phenomenal things on this campus. The price is reasonable so I will be fully funding this organization.

Sponsored by Senator Roy (P)

To fund Dominican Student Association, Arab Student Union, and The Renegade Leadership Honor Society.

- Opening Statement:
  - Roy: Thank you and good evening. I am the Chair of PAC – a funding organization that helps organizations around campus. On Tuesday we met and heard six different organizations, tabled three organizations and are hearing them in the coming weeks with updated quotes ensuring fiscal responsibility. We funded the Dominican Student Association, and Arab Student Union – both for t-shirts We also funded the Renegade Leadership Honor Society which was tough as they were requesting funding for three different events, one of which costing \$5,000. We were not able to fund that but were able to work with them on their requests such as **RECORDING INAUDIBLE** (00:35:52) which will be March 5<sup>th</sup> on Langford Green with numerous activities. This goes to \$136 for food as an incentive. They will also be having an Induction/Reception on March 27<sup>th</sup>. Food will be \$384 and decorations \$213 – will be open to the student body and are inviting as many to attend as possible.

    - Yes, PAC has funded the Renegade Leadership Honor Society for this fiscal year for a different Induction/Reception they had last semester.

Amending the Election Code to expand its enforcement period.

- Bill 9                        Sponsored by Senator Russell (P)  
To aid the Executive Cabinet's Chief of Staff with the Candidate Search and Candidate Screening Process by allowing the Secretary of Appointments to also conduct interviews. **(Referred to Judiciary. Passed in Judiciary 2.8. Remanded to Judiciary 2.9. Tabled in Judiciary 2.15. Amended and Passed in Judiciary 2.22.)**

- Opening Statement:

- Russell: There was an initial problem as Secretary of Appointments is not enumerated. The language has been revised to be broader in aiding the candidate's screening process where the Chief of Staff will have one designated person to do this. The intention is for whoever is Secretary of Appointments to conduct this as they are closely related to the planning process. This would speed up the process of getting people in, in addition if there is a conflict of interest with the Chief of Staff there is currently no other option for anyone to interview them. It's straightforward – I just think it will help get people in this process.

  - Diaz: Being in Internal Affairs we know that the appointment process can take a long time and understand that the Chief of Staff may have a very busy schedule. This Bill simply streamlines that process and makes it easier for others to become involved and to resolve conflicts of interest.

Bill 11

Sponsored by Rivers (P) Bettley, Gonzalez (Co)

To require Homecoming and the Student Alumni Association to release the voting results for Homecoming Chief and Princess one (1) business day after the winners are announced at Homecoming Live. **(Referred to Student Life and Judiciary. Student Life did not meet. Amended and Passed in Student Life 2.17. Amended and Passed in Judiciary 2.22.)**

- Opening Statement:
  - Rivers: This Bill is very straightforward it just requires Homecoming to release the results of Homecoming Chief and Princess as the results are currently not public knowledge. This bill will make it that the following Monday the results will be posted on the SGA website. The following Wednesday, the Director of Homecoming will come to Senate to give the official results – the first results will be unofficial.
- Technical Non-Debatable Questions:
  - Little: Was the current Homecoming Council Administration contacted?
    - Yes and they are in full support.
- First Round of Pro:
  - Roy: Clearly they want to do this if they support it, but just in a general sense we should definitely be doing this. We should make this a more transparent process and encourage others to be involved.



- First Round of Con:
  - Pfeuffer-Ferguson: I have a reservation with this Bill - imagine being the one at the bottom of the poll. I can't stand by such a toll on an individual's mental health.
  - **Tucker moves to call the questions, Stewart seconds,**
    - **No objections.**
    - **The questions is called.**
- Closing Statement:
  - **Defers to Co..**
  - Gonzalez: All of the Homecoming budget comes from SGA which means that we go all over all of the process of Homecoming. All the SGA servers and processors are used to conduct the Homecoming elections which gives a full authority to implement **RECORDING INAUDIBLE** (00:55:47). I understand the reservations, but the point is to make this in-line of all SGA elections. I think this increases transparency which people would prefer to see. Our job is to ensure transparency and that's all we have control over.
  - Rivers: That's a bad thing that comes in elections in general. Numbers are tallied and somebody loses and wins. This is just a thing that needs to happen.

 Revising the statute regarding the amount of money that shall be funded to an organization in the category of lodging. **(Referred to Student Life, Finance, and Judiciary. Passed in Student Life 2.17. Finance did not meet 2.22.)**

Bill 13                      Sponsored by Senator Wang (P) Senators Gonzalez, Duchene, Bettley, Rivers, Little, Pfeuffer-Ferguson, Murray, Diaz (Co)  
 Explicitly stating that A&S monies may not be used to fund weapons and harmful materials outlined in the Student Conduct Code. **(Referred to Budget and Judiciary. Passed in Budget 2.22.)**

- **Point of Order: Wang: Bill 13 was also passed in Judiciary unamended meaning that it should be heard on the Floor this evening.**
- Opening Statement:
  - Wang: This is a revision of the Finance Code and something that I noticed was not in Statues. Do not mention anything about funding – or restricting funding – weapons in Statutes. I took the text directly from the Student Conduct Code so anything that you see there, is directly from the Student Conduct Code – A University policy. There was a stipulation about campus recreation as some clubs utilize who receive funding utilize these weapons for sport. This allows them to get funding

under PAC, RTAC, Budget (whatever that may be) while permitting them to use those materials for their sporting use.

If you haven't seen the calendar of events for the Inauguration, the President and Provost of Harvard University are going to be here, proving the magnitude of a figure that President McCullough is. - **Pfeuffer-Ferguson:**
  - Good evening President Hunter and Pro-Tempore Nemeth,  
 I want to formally dissent from the Senate's decision to pass Bill 11. During my time at Florida State, I have seen what elections can do to people, especially those who have lost their election. I completely understand the transparency of elections when it comes to Student Government, as we serve the student body and we are expected to be transparent in the work that we do. When it comes to Homecoming Court, this is a social activity and usually has a higher turnout for elections. I can only imagine how the student at the bottom of the election results would feel if they were to see that they received only a fraction of the votes when they expected to do better. Homecoming already releases the top three for each gender that is running for Homecoming Court, which I feel is already transparent enough. As someone who actively advocates for the mental health of my peers, I feel it is necessary for me to stand in opposition to this bill, especially considering I have been told that members of the Student Alumni Association were not informed about this bill.
