- Resolution 49 Sponsored by Senators Hine (P), Alvarez, Butrum, Chehaitli, Gomez, Gorelick (Co)
To promote available resources to the LGBTQIA+ community at Florida State University in the wake of anti-LGBTQIA+ Legislative attacks nationwide. **(Tabled on the floor 06.14)**
- Resolution 50 Sponsored by Senators Hellman, Pedraja (P), Arellano, Kerley, Patel, White (Co)
This resolution acknowledges the significance of the Fourth of July as a national holiday in the United States, commemorating the Declaration of Independence. It emphasizes the importance of unity, reflection on the sacrifices made by the country's forefathers, and the promotion of civic engagement and historical consciousness among the student body at Florida State University. The resolution encourages the celebration and recognition of Independence Day, participation in local events, educational activities, and discussions, and calls upon the university administration to support and promote these initiatives while urging the community to reflect on upholding principles of liberty, justice, and equality. **(Tabled on the floor 06.14)**

- Bill 56 Sponsored by Senators Cofer, Humberg (P) Butrum, Gomez, Gorelick, Randall, Richards, Waller (Co)
This bill would allow students enrolled in the Panama City campus the ability to vote for Student Body Treasurer, and also amends the Panama City statutes to modernize the language surrounding their voting procedures. **(Referred to Internal Affairs and Judiciary.
