### Bills Second Reading:

Bill 66

Sponsored by Senator Bevis (P)

The Finance Code currently says that PAC and RTAC cannot fund events that are for executive boards only. However, an exception to this rule can be made by a 3/4 vote of either funding board. This bill will end that exception, banning PAC and RTAC money from being used for executive board only events. (Referred to Finance 06.28. Referred to Budget 06.28. Tabled in Finance 07.04. Tabled in Budget 07.07. Passed in Finance 07.18. Passed in Budget 07.26)

#### • Opening Statement:

 Bevis: PAC & RTAC are supposed to serve a wide array of the student body and not just executive boards. This hasn't been an issue but it's important to prevent. I've spoken to the PAC & RTAC Chairs about this.

#### • General Questioning:

- Alvarez: What about an executive board needing money for a leadership conference?
  - The RTAC Chair approved of this however I'm open to an amendment to allow RTAC to allow this. There isn't an official definition of an 'executive-board' only event. It would be left up to interpretation
- Mendez: You said there aren't many executive-board only events, correct?
  - Correct, maybe in 2021.
- o Mendez: If that's true, why is this an issue?
  - I just didn't like the potential existing
- Pro-Tempore Chehaitli: What are 'executive-board' only events?
  - I left this up to interpretation, I see it as events exclusive to executive boards.

- Fredock: If an RSO has an event open, but only executive board members signed-up, how does that play?
  - I would see that as okay.
- Gorelick: Can you give an example of an 'executive-board only' event?
  - Retreats you don't typically need a lot of funding for.
- Pedraja moves to enter Pro/Con debate, Baez seconds.
  - No objections.
  - Senate enters Pro/Con debate.

## • First Round of Pro:

 Fredock: RTAC & PAC have limited amounts of money so they must be able to fund accessible events to as many students as possible.

#### • First Round of Con:

- Mendez: I feel that this isn't an issue and takes opportunity away.
- Alvarez: I think we should allow opportunities even if it's just executive boards as they still benefit the organization.
- o Pedraja: We've never run into an issue with this.
- o Waller: I don't feel this is urgent and a minor change.
- Pro Tempore Chehaitli: I think this is unnecessary as we're already not supposed to fund these type of events and a process is already laid out.
- Gorelick moves to call the question, Randall seconds.
  - No objections.
  - The question is called on Bill 66.

## • Closing Statement:

 Bevis: Thank you all for your honesty. I don't like the idea of small boards getting the benefits over larger events. Thank you all so much.

Bill 67

Sponsored by Senator Gorelick, Randall (P) Arellano, Baez, Bevis, Cofer, Fredock, Gessner, Gomez, Hellman, Hirji, Mendez, Olsson, Pedraja, Richards, Schwartz, Shaver, Sparling, Waldie, Waller (Co) This bill makes several changes to statutes concerning the Office of Governmental Affairs, making Board of Directors no longer a major office,

updating the Board of Directors Selection Process, and overhauling the Legislative Agenda process. (Referred to Internal Affairs 07.12. Referred to Rules & Calendar 07.12. Referred to Judiciary 07.12. Passed Internal Affairs 07.17. Passed in Rules & Calendar 07.18. Passed in Judiciary 07.19. Tabled on the Floor 07.19)

#### Opening Statement:

- Randall: This overhauls the OGA legislative process as we all found a change was needed. This is supported by OGA Exec. We overhauled a 'policy proposal' to determine what they lobby for throughout the year. This allows Senate to be involved while ensuring OGA has some control. This simplifies legislation OGA needs to lobby for to ensure effectiveness. The 'selection process' for board members is also changed. Removing OGA Board of Governors from being a major office as OGA involves some of those prominent individuals involved on-campus. This ensures representation on the board across campus.
- Gorelick: Three committees have heard this already. This
  ensures leaders have a voice in OGA. This also gives Senate
  some input, please vote in favor of this.

### • General Questioning:

- o Wallie: How does the policy proposal work with Senate?
  - It will go to Senate as a draft where Senators can make suggestions for revisions for OGA to review. Senate will then approve/disapprove.

#### • First Round of Pro:

- Alvarez: I was first against this but after a lot of communication they found a way to resolve my concerns and ensure an increase in communication. These are important issues they're dealing with.
- Bevis: This ensures quality individuals will be on the OGA board.
- Hine: I'm glad OGA has crafted this alongside Senate.
- Pro-Tempore Chehaitli: This is necessary to ensure what's lobbied for is what the students want and has our backing.
- Wallie: It's reassuring to have the OGA Director guiding us throghout this process.

(Referred to Finance 07.12. Referred to Budget 07.12. Passed in Finance 07.18. Passed in Budget 07.26)

 Fredock: This revamps the Organizational Fund. This Bill creates a process to better hear RSOs regarding this source of funding.
