- Brandon Gabay, Hillel FSU Treasurer: Good evening, Senate, I hope you all had a great summer. My name is Brandon and tonight I am here as the Treasurer of Hillel at FSU. Tonight, you will be hearing a consent resolution which will provide Hillel with funds to have Rosh Hashanah meals for 400 students here at FSU. There were a few questions that PAC had for us that I wanted to clarify here after speaking with our staff members. First, as with non-profits everywhere, our yearly operating budget relies on the donations and grants we get from people and organizations, such as Student Government. While we have fundraised, we are still in the process of fundraising, so our overall budget for this year is still only a projection; this is part of the reason we are requesting money from PAC. As I mentioned in PAC, we overspent last year because we had a lot more engagement than we anticipated, so we are trying to cover part of this spending deficit by covering as much of Rosh Hashanah as possible through PAC funding. We understand that this is a lot of money to ask for, and we would have gone through Sweepings if the money from Sweepings would be in our account in time for the holiday, but the holiday and event is at the end of September, and we cannot wait much longer if we want to get the purchase request in on time. This is also why we are only asking to partially fund the cost of the meal, since it costs more per head than we initially requested. Any support we get from PAC will allow us to stretch our budget - which we are still fundraising for - and allow us to provide more exciting and engaging programs for the Student Body. I want to emphasize that we get a quarter of our engagements every year from this event, and we anticipate that our engagement numbers will grow much more from this event and throughout the year than in past years. You may have seen our graphical projections in our PowerPoint presentation, which should be on your Canvas site. In addition to student interest increasing post-pandemic, Hillel participation has grown significantly with the growing Jewish student body. For example, our most recent Shabbat dinner and service served more than double the expected number of students. We need to provide quality food and service to make sure that students truly feel at home at Hillel. I encourage all of you to think about how you can best use A&S monies. Our numbers show that we will have at least 400 students at Rosh Hashanah this year, and this event truly invests their A&S monies back into our student population. Thank you, I look forward to your discussion on our request, and have a great first Senate.

Messages from Agency and Bureau Directors, SGA Organizations Officers and Employees:

- Assistant Director of JSU: Committee Chair and Outreach Chair applications are due tonight (8/31).
- Supervisor of Elections (SOE) Spencer Greenwood: Good evening. It's great to see and meet everyone. Tonight, there is a resolution about legislative apportionments – a routine procedure done every fall to reallocate Senate seats according to the population of their respective colleges. We need this to be approved tonight as candidacy declaration for the incoming fall 2022 elections opens September 7th at 4pm and closes on September 21st at 4pm. **RECORDING INAUDIBLE (00:36:40).** Here's a brief overview of the apportionments of those that have changed: the College of Arts & Sciences gained one seat going from twelve to thirteen seats, the College of Business gained one seat going from seven to eight, the College of Health & Human Sciences lost one seat going from three to two, the College of Law gained one seat going from one to two, the College of Music lost one seat going from two to one, the College of Social Sciences & Public Policy gained one seat going from six to seven, Graduate and Unspecified lost one seat going from two to one, and Undergraduate lost one seat going from **RECORDING INAUDIBLE (00:37:32).** According to Student Body Statute 705.5 (d): "No division shall have a difference in allocated seats greater than one from one semester to another." This means that colleges are only allowed to gain or lose one seat per semester. The loss of seat due to an apportionment (705.5(f)) dissolves upon inauguration. We now have an FSU SGA Elections account on Instagram so please follow for updates and any events the Elections Office has. Last semester I noticed the final expense statements formatting had difficult in their reading and verification, per Student Body Statutes 701.1(b) and 710.3(c), I have created forms to submit all final expense statements and campaign finance contribution forms and has been posted to the SGA Elections website. The fall elections calendar has also been added to the website. The election will be October 12th from 8am to 8pm, EST. If anybody has any questions email us and see us in person – I'd love to meet you.

Consent Calendar:

Sponsored by Senator Turkomer (P)

This is a PAC Consent Resolution that provides funding to two RSOs.

- Opening Statement:
 - Turkomer: The Chinese Students and Scholars Association (CSSA) is hosting their mid-autumn festival gala in the Moore Auditorium on September 17th and they need money for food distribution and napkins, plates, utensils, etc. Hillel FSU is looking for funding to host Rosh Hashanah catering event at the Hillel and remotely, needing \$5000. This is a big expense as how many will need food, costing \$25 per head and a \$500 delivery fee, and 300 kitchen staff. The closest kosher caterer that can cater to such a large event is far from Tallahassee. There is no admission fee, the event is free, and the event is open to the entire student body.
- Technical Non-Debatable Questions:
 - Tucker: Does 25 per head include delivery service?
 - No, just for food.
 - Hunter: What manner will the food be served?
 - Buffet-style but also packaged for the satellite location.
 - Suarez: Why are there two locations?
 - To increase accessibility.
 - Suarez: Can Hillel at FSU's location fit this number of people.
 - The remote location also serves to fit capacity.
 - Boisvert: Can Hillel accommodate up to 400 people?
 - They are prepared to go over 400 but this is the estimate they gave.
 - **Diaz moves for non-Senator Gabay to speak, Tucker seconds.**
 - **No objections.**
 - **Brandon Gabay, Hillel FSU Treasurer can now speak when called upon.**
 - Suarez to Gabay: What has past attendance been?
 - Last year the participation was 364 students.
 - Point of Information: Tucker to Gabay: How do you plan to advertise this event to the student body:
 - We have posted the event on Instagram and advertised for people to help setting up and break down and have provided newsletters.
 - Point of Information: Casiple to Gabay: You mentioned fundraising – how will you do this and how much have you received in fundraising?
 - I'd like to clarify that the non-profit Hillel is separate from the RSO Hillel. Most of the non-profit Hillel's fundraising goes towards operation costs. We just got a new Executive Director who discusses fundraising opportunities with potential funders throughout the region.
 - Point of Information: St Hilaire to Gabay: **RECORDING INAUDIBLE (01:02:12).**
 - The caterer asked to have a headcount by September 4th.

- Point of Information: Tucker to Hockett: Does your committee allow for roundtable?
 - Yes.
- Point of Information: Suarez to Gabay: If you requested money last year, what was that total?
 - We did not request funding last year. Hillel hasn't put a PAC request for the past five years.
- Point of Information: Suarez to Gabay: How much did the event cost last year?
 - I am not sure. **RECORDING INAUDIBLE (01:04:25).**
- Point of Information: Bettley to Gabay: What has the RSO on-campus done for fundraising?
 - We have competitions throughout the year, such as Giving Week where we compete against other Florida universities' Hillel. We learned we have an off-campus bank account which has \$1000.
- Point of Information: Schindler to Gabay: How much did you raise in fundraising?
 - \$2000.
- Point of Information: Carter to Gabay: Is there still no access to those numbers?
 - After talking to our staff members, they still don't know so I don't have the numbers.
- Point of Information: Carter to Gabay: How did fundraise last year without PAC funding?
 - Our former Executive Director had a lot of connections with alumni, temples, etc.
- Point of Information: Suarez for Gabay: What would the ramifications be if the line-item was cut down or zeroed out?
 - **RECORDING INAUDIBLE (01:08:20).** The total amount per person is \$35, but we are only requesting \$25 and covering the remainder.
- Point of Information: Folwell to Gabay: If you exceed you expected attendance, will \$5000 be enough?
 - No.
- **DuChêne moves to enter 'Roundtable Discussion,' Tucker seconds.**
 - **No objections.**
 - **Senate moves into 'Roundtable Discussion.'**
- DuChêne: I support this, Hillel is a wonder resource for Jewish students on campus and I admire how Hillel does not limit students who attend their events. It's great that they found PAC as a resource they can use.
- Schindler: Hillel is a great organization with a great opportunity to reconnect with Jewish students. It was hard to understand how much was fundraised, during the PAC meeting. I do think this will benefit the student body.
- Bettley: Both line-items are going to important things. We've heard in both on why and who the money is deserved, and it's obvious both are or for the student body. PAC has almost an abundance of money so we should fund this organization while we can.

- DuChêne moves to call the question on Consent Resolution 22, Rivers seconds.
 - The question is called on Consent Resolution 22.
- Voting Results on CSSA line-item:
 - 40 yes, 0 no, 1 abstention.
 - CSSA line-item passes.
- Voting Results on the Hillel FSU line-item:
 - 36 yes, 0 no, 3 abstentions.
 - Hillel FSU line-item passes.
- Rivers moves to call the question on Consent Resolution 22.
 - The question is called on Consent Resolution 22.
- Closing Statement:
 - Everyone seems in relative agreement, but I have two points: 1) PAC was rough to the organization's original request, the original request was \$12,050 and we cut it to \$5000 and 2) participation in Hillel FSU Rosh Hashanah dinners have been going up significantly, making funding necessary. In 2021 they served 364 meals – huge event.
- Voting Results:
 - 37 yes, 0 no, 0 abstentions.
 - Consent Resolution 22 passes.
- Rivers moves to exit 'Finance as a Whole,' Folwell seconds.
 - No objections.
 - Senate exits 'Finance as a Whole.'
- *Senate exists 'Finance as a Whole.'*
- Tucker moves to approve Consent Resolution 22, Edouard seconds.
 - No objections.
 - Consent Resolution 22 is approved.
- Opening Statement on Hillel FSU line item (above \$5000):
 - The FSU Chabad house recently burned down. With that house burning down, they've been operating in shipping containers resulting in Jewish students looking for another place to go – with that place probably being Hillel FSU. This is a big request, but necessary.
- Technical Non-Debatable Questions:
 - None.

- First Round of Pro:
 - Diaz: I was in the PAC meeting. PAC was initially concerned with a somewhat lack of transparency but remembered that PAC can get more funding from sweepings this fall. I will vote to support this Consent Resolution with that knowledge. I hope the future Chair of PAC can do that request for sweepings.
- First Round of Con:
 - None.
 - **DuChêne moves to call the question on the Hillel FSU line-item, Suarez seconds.**
 - **No objections.**
 - **The question is called on the Hillel FSU line-item.**
- Closing Statement:
 - After this Consent Resolution I will be resigning as PAC chair, so hopefully we can find a new PAC Chair tonight. I hope the next Chair can host a meeting next Monday (8/5) so organizations can be heard.
- Voting Results:

 - **Consent Resolution 22 Hillel FSU line-item passes.**

As stated in Election Code statutes, apportionments for Senate and Congress of Graduate Students need to be created every Fall Semester. This is a required provision in statutes.

- **Diaz moves to place Resolution 52 on 'Second Reading' and read in its entirety, Suarez seconds.**
 - **No objections.**
 - **Resolution 52 is placed on 'Second Reading.'**
- *President Hunter reads Resolution 52 in its entirety.*
- Opening Statement:
 - Supervisor of Elections (SOE) Greenwood stated everything already. I'm happy to answer your questions. It is now reapportionment time of the year. If this does not pass, this will be setting election staff back substantially.
- Technical Non-Debatable Questions:
 - Kariher: Where can we find the enrollment information this is based off?
 - The student database – because of FERPA – only students have access to the Student Directory. If it's beyond the Student Directory students do not have access to it. You can use the Student Directory to find how many students are in each College but the Student Database, for example, SOE Greenwood and I do not have access to, our advisors do. We cannot access the information of every, single student.
 - DuChêne: Is aggregated information without identifying information private?
 - I can defer to our advisor or SOE Greenwood, but I don't know.
 - Rivers: What is the data based on which decides whether we add or remove a seat?
 - The Office of Institutional Research – the University has an office that keeps track of college populations and students. (website shared).
RECORDING INAUDIBLE (01:46:27).
 - Tucker: Who drafts the apportionment plan?
 - Student Body Statues say that the Senate President for the Student Senate in line with the Office of Director Secretary of Appointments. However, we cannot do it alone, so it's a joint effort with our advisors, SOE Greenwood, and myself.
 - DuChêne: I went on the website and can't find data for this academic year, where is data for fall 2022?
 - Jacalyn: The plan is based off the previous fall (fall 2021).

- Folwell: The College of Graduate Studies (COGS) apportionment is on this document to be changed?
 - Yes, COGS **RECORDING INAUDIBLE (01:48:48).**
- Hockett: If no division shall be greater than one, can that lead to the deletion of representation?
 - No, it's also listed in that statute that no College can have no representation.
- Kariher: Was any college supposed to lose more than one seat?
 - Jacalyn: Yes.
- Rivers: Can I get number of seats being changed in the Colleges of Nursing, Music, Law, and Hospitality?
 - The College of Nursing has no change, the College of Music lost a seat, the College of Law gained a seat, and the College of Hospitality has no change.
- **Bettley moves for non-Senator SOE Greenwood to speak, Rivers seconds.**
 - **No objections.**
 - **SOE Greenwood can now speak when called upon.**
- Rivers to SOE Greenwood: Can you list colleges' seat changes?
 - The College of Arts & Sciences gained one seat, the College of Business gained one seat, the College of Health & Human Services lost one, the College of Law gained one seat, the College of Music lost one seat, the College of Social Sciences & Public Policy gained one seat, Graduate and Unspecified lost one seat, and Undergraduate Studies lost one seat.
- Kariher to SOE Greenwood: Which colleges should have lost more than one seat?
 - We can only add or drop one seat for every reapportionment period, but Colleges such as Arts and Sciences should have fourteen seats, but we can only increase by one.
- Rivers to SOE Greenwood: The College of Law has an enrollment 1,148 students listed while the College of Music has 1,140 students listed and I'm wondering why the College of Music is losing a seat while the College of Law is gaining a seat.
 - You're wondering why the College of Law gained a seat with 1,148 students and the College of Music lost a seat with 813 students?
- Diaz: Does Senate have the statutory authority to amend apportionments?
 - You cannot amend apportionments, but you can amend the rule.
- Rivers to SOE Greenwood: Those numbers **RECORDING INAUDIBLE (01:55:20)?**
 - The College of Law had a population of 1,148 and the College of Music had a population of 813 students.
- DuChêne to SOE Greenwood: Is your data for the College of Music in 2021 from the website previously provided?
 - Yes.

- Jacalyn: Junior, Senior, and graduates count towards a College's population while freshman do not.
- First Round of Pro:
 - Point of Information: DuChêne to SOE Greenwood: If the data were using is from the Institutional Research website, where are your different numbers? I have College of Music fall 2021 at 1,040 students.
 - That number includes freshman and sophomores.
 - Point of Information: Rivers to SOE Greenwood: What number are you going off for Undergraduate Studies in fall 2021?
 - 10,672 students.
 - Point of Information: Rivers to SOE Greenwood: What is the new number for seats of Undergraduate Studies.
 - Twenty-three
 - Point of Information: Duchene to SOE Greenwood: Where can we access data without freshman and sophomores not being counted in their college?
 - **RECORDING INAUDIBLE (01:59:09).**
 - **Diaz moves to amend the Resolution to add words "and COGS seat," Tucker seconds.**
 - **No objections.**
 - **Sponsor finds it friendly.**
 - **Amendment adopted.**
 - Folwell: I understand why some are concerned with the numbers, but the Resolution does not entail those figures. I am in support.
- First Round of Con:
 - None.
 - **Schindler moves to call the question on Resolution 52, Bell seconds.**
 - **No objections.**
 - **The question is called on Resolution 52.**
- Closing Statement:
 - This shows how apportionments were done, we cannot change it because it's based off a formula. This needs to be approved tonight (8/31) in order for us to have elections. Great debate and I'm happy we're all engaging with our colleges, ensuring we represent them fairly in the Student Senate.
