- CR 30 Sponsored by Senator Seeger (P) To fund the American Hellenic Educational Progressive Association and the Real Estate Society at FSU.
 - Humberg moves to approve CR 30. Baez seconds.
 - No objections.
 - CR 30 is approved.
- CR 31 Sponsored by Senator Humberg (P) To fund the Flute Association at FSU, Nolettes, SUMS, Diverse World Fashion Magazine, Sigma Tau Delta, Future Women of Dentistry, No Bears Allowed Improv, and Studio H
 - <u>Opening Statement:</u> DWF originally asked for \$3,000 but we amended them down to \$1,836.
 - <u>Widmann moves to allow a non-Senator, the representative from DWF, to</u> <u>speak. Velasquez seconds.</u>
 - No objections.
 - General Questions:
 - Widmann: How much money is in your account and have you done any fundraising?
 - We just had our first fundraiser but after some recent payments, we have less than \$100.

• <u>Hine moves to amend. Restoring the DWF line item to the original "\$3,000".</u> <u>Someone seconds.</u>

- <u>Opening Statement on the Amendment:</u> The amount that we are trying to give them right now only covers enough for 100 members, and they have over 100 members and the rest of the student body.
- Questions on the Amendment:
 - Seeger to Representative: Will the models also be receiving a magazine?
 - Yes.
- Roundtable on the Amendment:
 - Widmann: If we're trying to guarantee 180 members a magazine, this means that these funds will only go to members and not to the general student body, which I think breaks statutes.
 - Widmann: How do you plan on purchasing more magazines? How do you plan on distributing them?
 - Fundraisers and membership dues. They will be distributed at our release party where we celebrate our work together.
 - Gorelick: I think we should give them the funding. Magazines are not cheap to print and we're giving them this money to print more magazines, not less magazines.
 - Velasquez: I don't really know if I'm for this or against this. I liked the middle ground, so I will be against this amendment but for funding this organization.
 - Gorelick to the Representative: This is open to everyone, correct?
 Yes.
 - Randall: This is the same idea as funding t-shirts. Members of an organization get t-shirts first and they are passed out after.
- <u>Gorelick moves to call the question on this line item. Velasquez</u> seconds.
- <u>Closing Statement</u>: I just think we should fund them the full amount for their members and the public.
- Voting results on the Amendment to the DWF Line Item:
 - 21 yesses, 16 nos, 1 abstention.
 - The amendment fails.
- <u>Staveski moves to amend, changing the DWF line item to "\$2,204". Salazar</u> <u>seconds.</u>
 - <u>Opening Statement:</u> We were initially concerned about there being an excess amount of magazines, but after recent numbers, I don't think that will be a problem.
 - General Questions on the Amendment:
 - Widmann: What happens if they run out of magazines?
 - Not everyone comes to every meeting.
 - First round of Pro:
 - Velasquez: This is the happy medium.
 - First round of Con:

 - <u>Closing Statement on the Amendment:</u> This is a happy medium

To change PAC and RTAC membership statues to expand participation on the funding boards. (Referred to Judiciary and Finance).
 Bill 92 Sponsored by Senator Brewer (P) Arellano, Birdsong, Brown, Dennig, Gummerman, McEntyre, Mendez, Newsome, Sparling, Syska, Walerio (Co)

 This Bill would convert the Catholic Student Union ("CSU") from a Registered Student Organization to an Agency. This would make CSU the eighth esteemed identity-based Agency at FSU.(Referred to Student Life, Judiciary, Internal Affairs, and Finance).

 Bill 93 Sponsored by Senator Widmann (P) Baez, Gorelick, Hellman, Humberg, Patel (Co)

 An allocation of \$955,661 from Sweepings to various departments and organizations. (Referred to Sweepings.)

Resolutions First Reading:

Resolution 77 Sponsored by Senator Gorelick (P) This resolution recommends the allocation decided upon by the Leadership Councils Funding Committee to the Student Leadership Councils of the College of Business, College of Fine Arts, College of Arts and Sciences, College of Communication, College of Social Sciences and Public Policy, College of Criminology, and College of Entrepreneurship. (Referred to Budget and placed on Budget's Calendar.)

- Opening Statement:
 - This resolution shows everyone what we funded to some student leadership councils around campus. We had \$15,000 to allocate. We heard from six SLC's and this was the amount we decided to fund each. They each came to us with a presentation and I can answer any questions you guys have.

 - Thank you guys so much. I yield.
