Under these modifications, that would put such independent candidates against one or two specific individuals – you mentioned this will make ticket splitting possible – could you address this hypothetical?
    - I don't think internally focused campaigns are restricted by this. When we see independent candidates run for Senate they address themselves, not their opponents. In the current system, independent candidates have a small chance of election. Two parties currently dominate the ballot and makes it less likely for the independent candidate to be elected.
  - DuChêne moves to enter 'Pro/Con debate,' Maglin seconds.

- Suarez: Prior to speaking about this Bill, I want to bring attention to the Bill I passed. I worked with Bowden and Jacalyn to allocate the remaining PAC funding to this park. I was required to withdrawal the Bill on the Floor but am excited to here it tonight.
- Anand: This Council is known as the 'Devine Nine,' which has brought changemakers to our community. The NPHC Council is one of smallest on campus with some of the largest impact – 93 involvements with \$20,000 dollars raised among numerous awards, for example.
- Suarez: The park has been custom built for our history and will be the first of its kind in the nation, and will become a living museum for future generations. It will represent leaders and members of this organization. This park will promote Black history as it correlates to FSU.
- Anand: This year marks 60 years of integration. The Committee deserves representation and we have the opportunity to showcase our appreciation or the community for additional funding to the park. Tonight (10/26) we have the opportunity to leave a lasting legacy.
- Suarez: We also have the NPHC President here tonight (10/26).
- o General Questioning:
  - Schindler to the Sponsors: What is the total amount that Senate Projects has?
     President Hunter: It's in the calendar. (\$24,480).
  - DuChêne to the Sponsors: it was explained in Student Life, but could you talk about why the amount was raised from \$2,500 to \$5,000?
    - Anand: I was on a time crunch in writing this legislation, and after speaking to leaders and my co-sponsors, I was confirmed with \$2,500.
       However, after my co-sponsors got back to me, we realized \$5,000 would be more impactful.
  - Tucker to the Sponsors: Where will this park be located?
    - Suarez: It will be right outside the Chambers, currently where the 'D9' strolls on Market Wednesdays.

  - UF is a good example and was a point of reference. It's necessary to create the physical space for us to promote opportunities – not having a space on-campus took the enjoyment of these organizations for me. It makes me feel a little bit left out.
- Folwell to the NPHC President: Can you give a timeline on the park?
  - This is not University-funded, and we can't start breaking ground until the full amount has been raised. It would be done in the same or next semester when starting construction.
- Schindler to the NPHC President: Are you fundraising elsewhere than this Spark page?
  - We have numerous fundraising opportunities.
- Diaz to President Hunter: If this is not budgeted from SGA, will these funds be swept at the end of the year?
  - No, it will be transferred to their account beyond our control.
- DuChêne moves to enter 'Pro/Con debate,' Rivers seconds.
  - Casiple objects.
  - <u>DuChêne withdraws.</u>
- Schindler to the NPHC President: If the goal of \$450,000 is not reached, what happens?
  - I don't know but I know this is not University-funded, so we're trying to fund at least 75% of it and seeing if the University will match.
- Schindler to the NPHC President: What amount of fundraising do you expect to come from alumni?
  - o **40-50%**.
- Casiple to the NPHC President: How was the \$450,000 number reached and what does that account for?
  - It was the eesult of materials needed to build project most schools have some form of dedication. Student Affairs wanted something physical that couldn't be as easily vandalized and we don't believe this number will inflate. Each chapter plot will occur for each organization with details on the floor to commemorate.
- Schindler to the Sponsors: If the money is not raised how will it be given back?
  - Suarez: As of today only 50% needs to be raises to break ground, and through fundraising, Chapter and Student Foundation support, they will also be supporting with these events, etc. No circumstance would arise to give the money back – they would just continue fundraising until the threshold is met. We have a statute that says it must label – 'Paid for by SGA' and there will be a brick detailing that.
- Bell to the NPHC President: Have conversations occurred with other universities who have this?
  - We have had discussions with other universities but I'm not prevue to those.
- St. Hilaire moves to enter 'Pro/Con debate,' DuChêne seconds.

We felt that mentioning the incidence was important and that although it was reported anonymously does not mean it had no weight. I didn't tell people I was Jewish until I was thirteen-years-old because there was no diversity where I grew up people have various reasonings for wanting to report things anonymously. It was important the event be mentioned but we understand that it doesn't reflect all thoughts of the chapter. There is more they can do to help.
